

# Mapping Social Security Regulations 2018 to former acts and regulations

As part of the rewriting of social security legislation from 26 November 2018:

- some provisions from the Social Security Act 1964 were moved into regulations
- 24 separate sets of regulations were repealed and rewritten into one consolidated set of regulations, the Social Security Regulations 2018.
