    - 3c. *If the request was extended, the duration of the extension.*
  4. *The outcome of the request (e.g. all information released, transferred to another agency).*

The Ministry endeavours to respond to all requests for information within twenty working days, which do not include holidays as set out in section 2 of the Act. Where it is recognised that this timeframe cannot be met and a decision has not been made on what information is available to be provided in response, the requestor is informed of an extension to the timeframe required to make a decision. Where a decision has been made but additional time to prepare a response is required, requestors are informed of this decision and a revised due date.

Please note, extensions to the timeframe to respond to a request are based on estimates of the time required. When additional unforeseen work is required to provide the requested information, the requestor is kept updated on the progress of their response.

Please find attached a table that shows all requests for information made to the Ministry that were logged as Official Information requests for the period from 1 July 2017 to 30 December 2017, including the date received, date response was sent and the date the response was extended to if applicable. Please note, as these statistics are for those requests logged as Official Information requests, they will differ from the statistics publically available on the State Services Commission's Website, which show the number of completed requests, including those responded to by the Media team.
