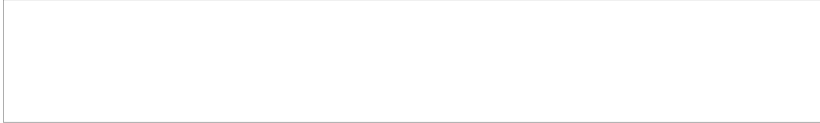

On 17 January 2017 you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

- *information on funding contracts for service delivery specific to servicing Asian, African, and Middle Eastern (Ethnic) women, children, and families in Domestic/Family Violence. The region being looked at is Greater Wellington including the Hutt Valley, Wairarapapa, extending up to Palmerston North. If MSD has contracted agencies for this purpose in the region, we would like to know who they are, the service numbers contracted for, and the type of service contracted for including emergency/refuge accommodation.*

Please find enclosed a table that details providers of family and domestic violence services contracted by the Ministry to provide services for the greater Wellington region. The table outlines the service contracted for and the contracted service volumes.

The Ministry does not specifically fund domestic/family violence services that target Asian, African, and Middle Eastern women, children and their families. People from all ethnic groups are able to access the services outlined in the table enclosed.

The Ministry also provides funding to providers of national services. Where these services are delivered is at the discretion of the provider. As such, national contracts are not included in the enclosed table.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public shortly. The Ministry will do this by publishing this letter and attachments on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.
