  - ii) Please provide a breakdown of this data by benefit, ethnicity of caregiver and age of child.
- 3. How many working age caregivers added a child aged under one year to a main benefit in the year ending 31 December 2019.
  - iii) Please provide a breakdown of this data by benefit, ethnicity, age and gender of caregiver.

On 27 January 2020, you contacted the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982, the following information:

- 1. At 31 December 2019 how many Jobseeker Support recipients were working part-time or full-time?
  - Please provide an ethnic breakdown of those Jobseekers who had a health condition and disability at 31 December 2019

The Ministry offers several main benefits to people who need financial support and fit the eligibility criteria. The type of main benefit a person may receive is dependent on their circumstances. - Ethnicity data is self-identified and multiple ethnicities may be chosen. When this occurs, the selected ethnicities are prioritised into a hierarchy where the Maori ethnicity has the highest priority in the hierarchy, followed by Pacific peoples. NZ European has the lowest priority. This is to ensure that smaller ethnic groups do not get overwhelmed by larger ethnic groups and can lead to an over-representation of Maori in some data sets.
