On 21 May 2020, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982, the following information:

 A breakdown of the number and value of Special Needs Grants issued for the Wairarapa sub-region (Masterton, Carterton, and South Wairarapa District Councils), per month for the period 1 January 2019 - May 2020, broken down per SNG category.

Please be advised that the Ministry is unable to provide a monthly breakdown of the number and value of Special Needs Grants (SNGs) granted in the Wairapara Community Link broken down by SNG need for the period you have specified as this is outside the Ministry's standard reporting. The Ministry is however able to provide you with quarterly figures.

Please find enclosed **Table One** and **Table Two** which show the number and amount of SNGs granted in the Wairarapa Community Link for each quarter during the period 1 January 2019 to 31 March 2020, broken down by SNG need.

In order to protect client privacy, some values are suppressed and are represented by 'S'. Secondary suppression rules have also been applied when required. The Ministry is unable to provide you with the exact number as releasing this information is likely to risk identifying the individuals concerned. As such, this information is withheld under section 9(2)(a) of the Act. The need to protect the privacy of these individuals outweighs and public interest in the information.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- · to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public. The Ministry will do this by publishing this letter and attachments on the Ministry of Social Development's website. Your personal details will be deleted, and the Ministry will not publish any information that would identify you as the person who requested the information.

- In certain circumstances low numbers may potentially lead to individuals being
 identified. Due to these privacy concerns, numbers for some categories of clients have
 been suppressed or aggregated. Secondary suppression rules have also been applied
 when required. Suppressed numbers have been replaced by an 'S'.
