On 21 April 2021, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- *A more refined list of the accommodation suppliers who have received a payment from the Ministry between the dates of February 2020 to now.*

On 20 April 2021, the Ministry sent you a response in regard to your previous request, dated 1 March 2021.

In this response, the Ministry provided a list of registered Emergency Housing suppliers that have received at least one payment from the Ministry between 1 January 2017 to 31 December 2020, for grants granted to recipients whose address is recorded in the Ministry's system as residing in the Wellington City Territorial Local Authority (TLA).

The Ministry has interpreted your most recent requested dated 21 April 2021, as requesting a more recent list of accommodation suppliers that have received at least one Emergency Housing Special Needs Grant (EH SNGs) payment for the period February 2020 to now, for the Wellington City TLA.

Please note, the Ministry is unable to provide you with the information you have requested as monthly data reporting is not standard reporting practice for the Ministry. However, the Ministry can provide you with the data you have requested by quarter's ending, for the period 1 January 2020 to 31 March 2021.

Please see enclosed, **Table One** which contains a list of suppliers that have received at least one Emergency Housing Special Needs Grant payment for the period 1 January 2020 to 31 March 2021, in the Wellington City TLA.

As per the response to your previous official information request, you will notice that the list of registered Emergency Housing suppliers provided include suppliers from outside of the Wellington region. This is likely to be for payments made in arrears for a previous period of accommodation, or payments for a future period. It is also possible that a number of clients may have recently moved, but their address details have not yet been updated.

Please note, the TLA is estimated based on the clients' address at the time of the grant, and this TLA may not be the same as the address of the Emergency Housing supplier.

Please also note that the registered supplier name is the name of the parent company of the accommodation supplier, and not necessarily the name of the accommodation itself. One registered supplier may provide accommodation across multiple premises in different locations or trading names, receiving payment through the single supplier record.

Where the client address is not recorded, the location of the Ministry's service centre case managing the client has been used to approximate which TLA a client resides in. However, as the Ministry has switched to working from national queues, EH SNGs and other hardship grants could be granted by a case manager working anywhere in New Zealand. Therefore, in such cases, the TLA may not reflect the actual client address or location. Due to the transient nature of people receiving EH SNGs, the recorded address for a client may also be that of a trusted family member or friend who receives mail on their behalf.

**Notes for Table One:**

- Territorial Authority is based on the main applicant's residential address at the time of application, not the location of the supplier.
- A supplier's location may be outside the Wellington City territorial authority area.
- One registered supplier may provide accommodation across multiple premises with different trading names while receiving payment through the single supplier record.
