Tēnā koe

On 28 June 2022, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- *All information held by the Ministry relating to consultation in relation to the policy issues relating to [the Oversight of Oranga Tamariki System and Children and Young People's Commission Bill].*
- *This request is limited to consultation with children and young people, organisations working on behalf of or with children and young people and with Māori.*
- *The request, includes records of all consultation relied upon for the Beatie report and in relation to the Kahui Group, including (but not limited to) records of who specifically was consulted and what was specifically said by whom and any analysis of that feedback (for example, how many people of what category said a particular point) and any advice given that relies upon or references that consultation.*
- *I recognise that strictly the request covers personal information to be revealed. I am happy for this not to be revealed - for example, a named young person could be identified as Young Person 1.*
- *I am happy to discuss methods of limiting the scope of and work involved in meeting this request (I would also welcome being pointed to any publicly available material (I have not identified any) - at the heart of my request is the desire to understand fully the quality of the consultation that has taken place in regard to the Bill, since it is being relied on so significantly in the defence of the Bill.*

Appendices 1 and 2 of the Ministry's Departmental Report, *Oversight Oranga Tamariki System and Children and Young People's Commission Bill* (April 2022) contains details on who the Ministry consulted as part of our hui with Māori in 2019, and the key themes from what the Ministry heard in those conversations. The post-consultation Report, *Strengthening independent oversight of the Oranga Tamariki system and of children's issues in New Zealand* (2018) acknowledges that the consultation included Māori, NGOs, Judges, academics, Pacific Peoples, health professionals, past Children's Commissioners, statutory bodies such as the Children's Commissioner, Chief Ombudsman, the Privacy Commissioner and chief executives of the relevant public sector agencies. This report includes a summary of themes arising out of 35 face to face meetings or teleconferences with groups and individuals, a hui with Māori providers, and 33 written submissions. Furthermore, it also drew from insights gained from other consultations with care experienced young people that had been conducted around the time, including:

- Oranga Tamariki: Care experienced children's workshops – May/June 2018
- Specialist Foster Care for Remand Youth Engagement – 2017
- Assess Plan Implement and Review (APIR) Rangatahi Forum – 2015
- Voices of Children Interviews Expert Advisory Panel – 2015, and
- CYF Modernisation Youth Voices Workshop – 2014.

The Ministry will do this by publishing this letter on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.
