Official Information Act Request

Thank you for your email of 17 February 2024, in which you requested information about the Sole Parent Support benefit (SPS). I have considered your request under the Official Information Act 1982 (the Act).

Please find eight tables set out below, providing the data you have requested.

Table One: Working age SPS grants where the child or children included in the benefit were all in care for 25 percent or less of the time, from 1 January to 31 December 2020.

Notes:

• SPS grants included in this list are not necessarily still current.

- In some instances, the number of days in care of a dependent child on a client's record has not been updated to reflect circumstances at time of SPS grant.
- Any discrepancies identified have been referred for follow up, to ensure that the clients in receipt are receiving their correct payments.
- The tables include working-age clients only (18 to 64 years).
- This is a count of grants, not clients, and the same clients may have been granted more than once.
- The percentage of time in care is based on the number of days in care calculated for each child included in the benefit as at the benefit commencement date.
- Some cases may be excluded due to the timing of the child's inclusion in the parent benefit.

Confidentiality:

- To protect confidentiality, the Ministry of Social Development uses processes to make it difficult to identify an individual person or entity from published data.
- These data tables have had random rounding to base three applied to all cell counts in the table.
- The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals.
- The published counts will never differ by more than two counts.
