Main benefit assistance

Main benefits

At the end of December 2023, **378,711 people** were receiving a main benefit. This was up 24,807 or 7.0 percent when compared to December 2022.

The proportion of the working-age population receiving a main benefit increased to **11.9 percent**, up 0.6 percentage points from December 2022.

Figure 1a: Number and proportion of people receiving a main benefit at the end of the last six December quarters.

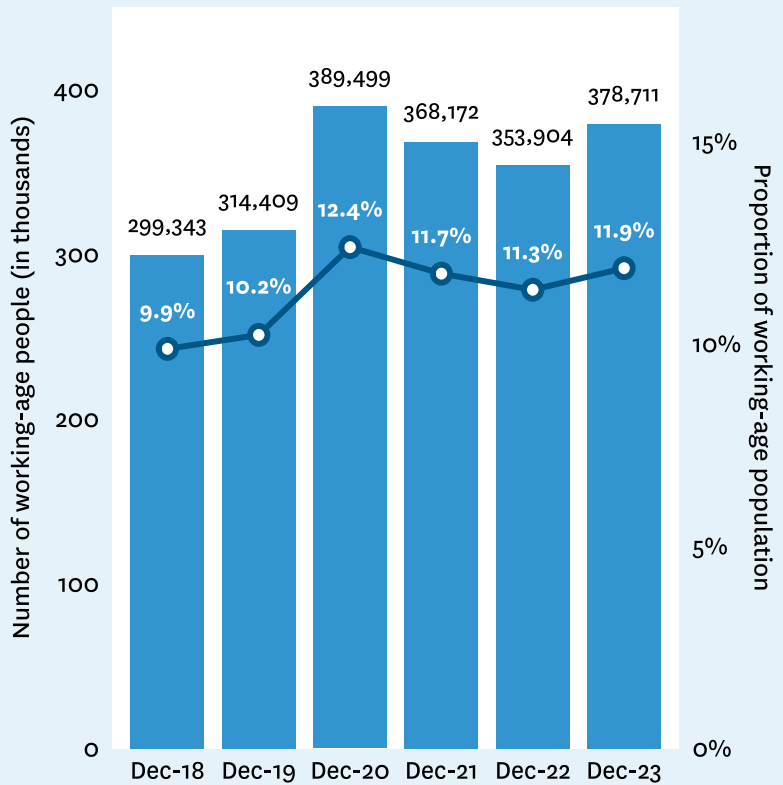
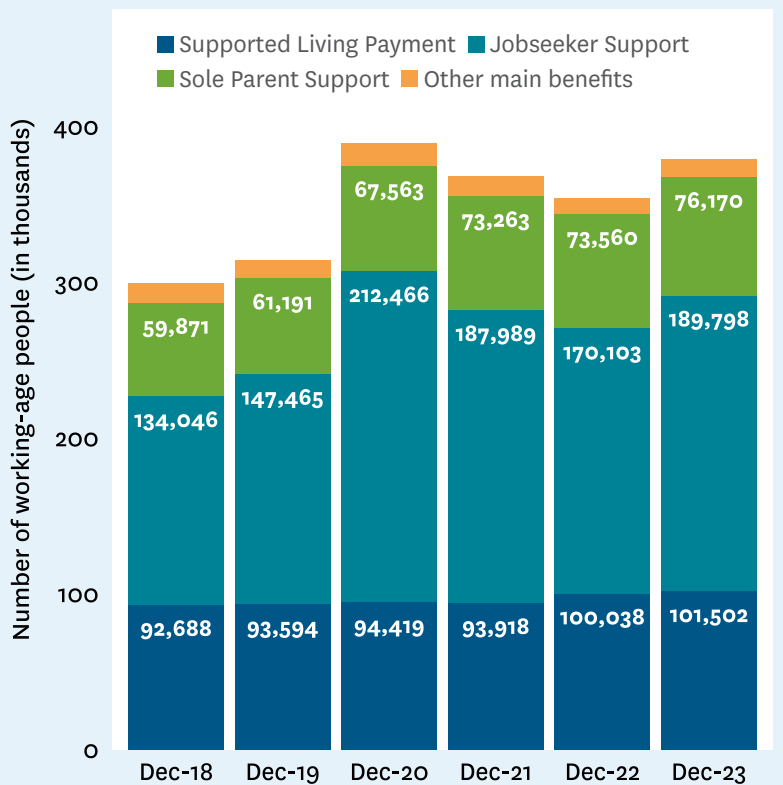


Figure 1b: Number of people receiving a main benefit by benefit type at the end of the last six December quarters.

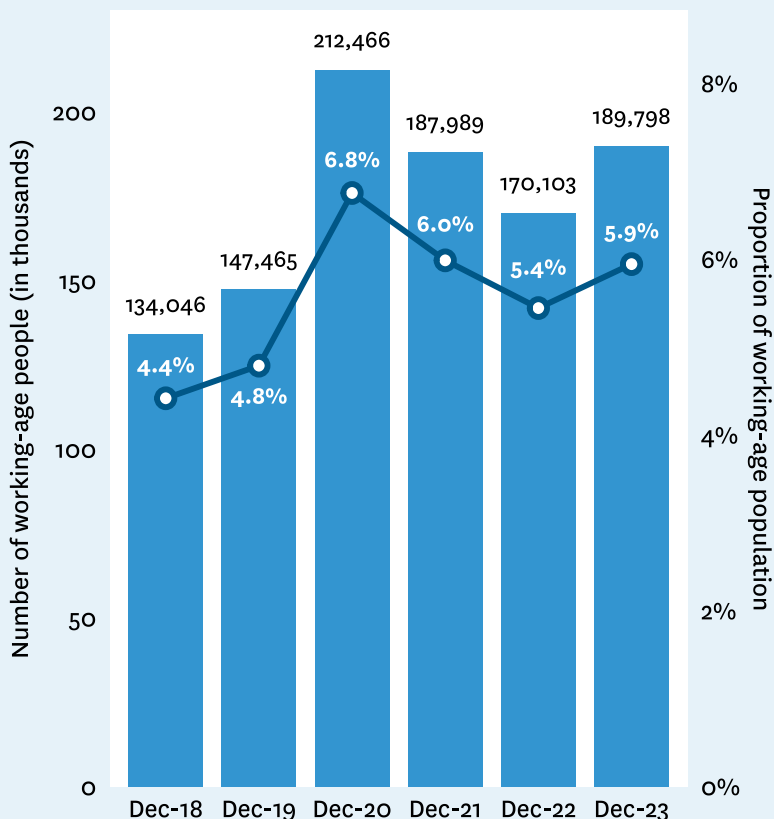
- Youth Payment and Young Parent Payment

Jobseeker Support

At the end of December 2023, **189,798 people** were receiving Jobseeker Support. This was up 19,695 or 11.6 percent when compared to December 2022.

The proportion of the working-age population receiving this benefit increased to **5.9 percent**, up 0.5 percentage points from December 2022.

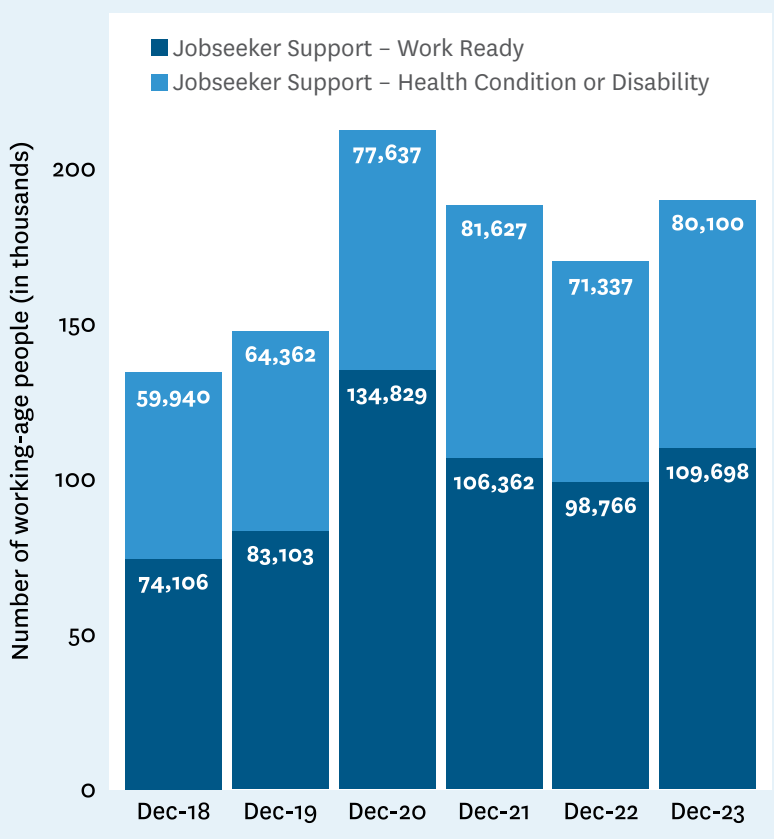
Figure 2a: Number and proportion of people receiving Jobseeker Support at the end of the last six December quarters.



At the end of December 2023, **109,698 people** were receiving Jobseeker Support – Work Ready. This was up 10,932 or 11.1 percent when compared to December 2022.

At the end of December 2023, **80,100 people** were receiving Jobseeker Support – Health Condition or Disability. This was up 8,763 or 12.3 percent when compared to December 2022.

Jobseeker Support is for people who are actively looking for or preparing for work. It includes people with part-time work obligations and those who cannot look for work at the moment (e.g. those with a health condition, injury, or disability).

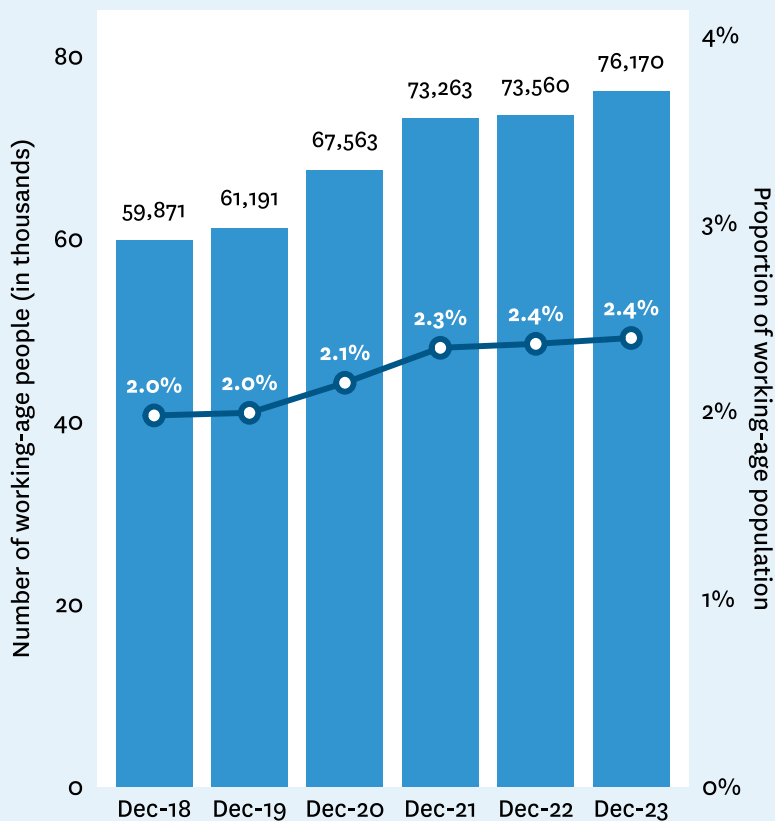
Sole Parent Support

At the end of December 2023, **76,170 people** were receiving Sole Parent Support. This was up 2,610 or 3.5 percent when compared to December 2022.

The proportion of the working-age population receiving this benefit is **2.4 percent**, the same as this time last year, December 2022.

Sole Parent Support is for single parents with at least one dependent child under 14 years.

Figure 3: Number and proportion of people receiving Sole Parent Support at the end of the last six December quarters.



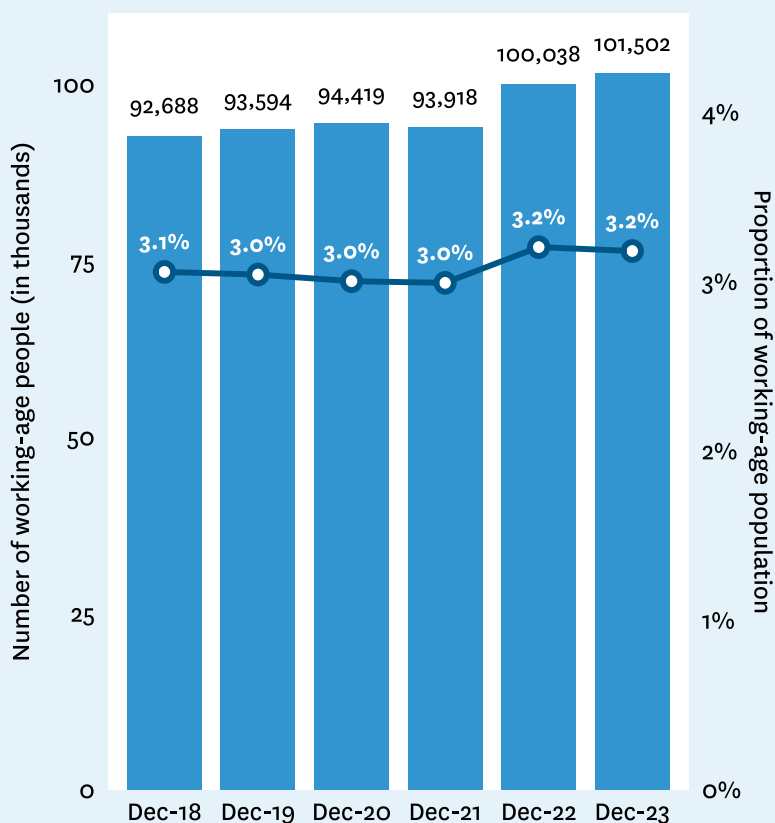
Supported Living Payment

At the end of December 2023, **101,502 people** were receiving Supported Living Payment. This was up 1,464 or 1.5 percent when compared to December 2022.

The proportion of the working-age population receiving this benefit is **3.2 percent**, the same as this time last year, December 2022.

Supported Living Payment is for people who have, or care for someone with, a health condition, injury or disability that limits their ability to work.

Figure 4: Number and proportion of people receiving Supported Living Payment at the end of the last six December quarters.



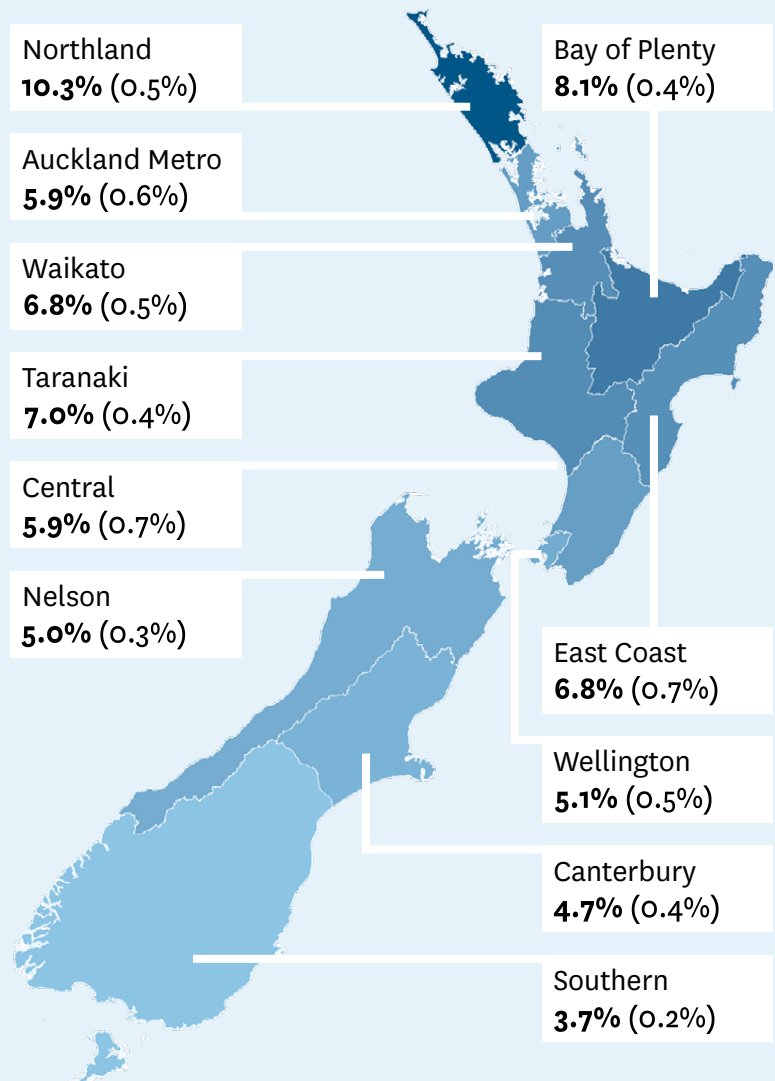
Regional distribution of Jobseeker Support

Between December 2022 and December 2023, **the proportion of the working-age population receiving Jobseeker Support increased in all regions.**

The largest percentage point increase was seen in Central and East Coast (both 0.7 percent).

At the end of December 2023, Northland had the highest proportion receiving Jobseeker Support, at 10.3 percent.

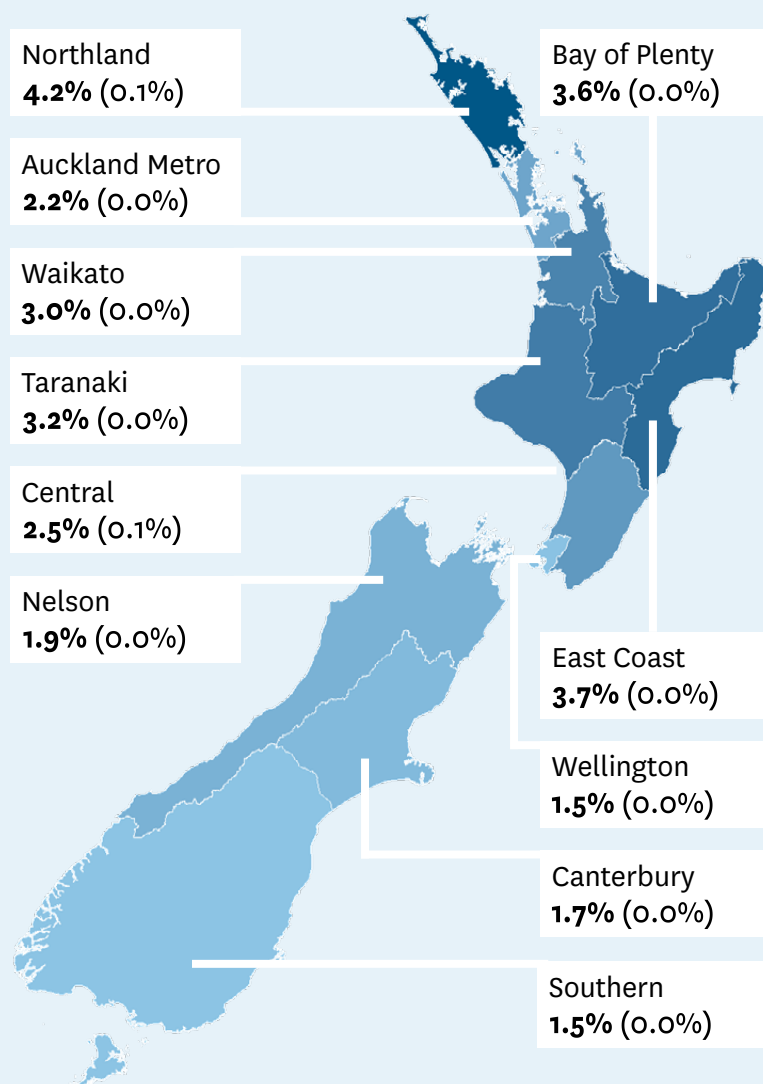
Regional distribution of Sole Parent Support

Between December 2022 and December 2023, **the proportion of the working-age population receiving Sole Parent Support remained the same or increased slightly in all regions.**

The largest percentage point increases were seen in Northland and Central (both 0.1 percent).

At the end of December 2023, Northland had the highest proportion receiving Sole Parent Support, at 4.2 percent.

Main benefit grants and cancellations

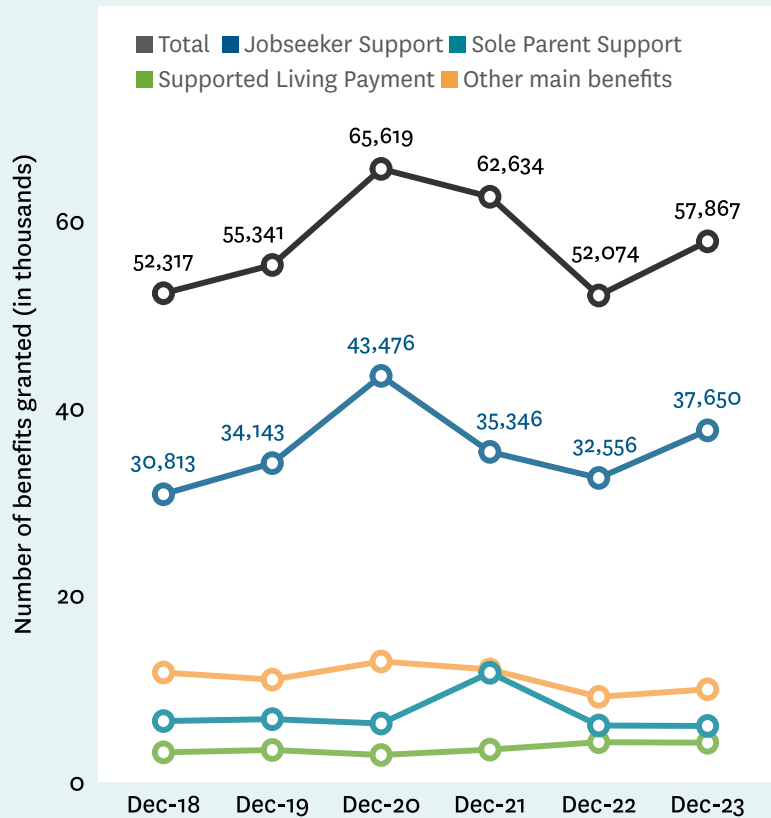
Main benefit grants

There were **57,867 main benefits granted** in the December 2023 quarter, an increase of 5,793 or 11.1 percent from the December 2022 quarter.

There were **37,650 Jobseeker Support grants** in the December 2023 quarter, an increase of 5,094 or 15.6 percent from the December 2022 quarter.

A main benefit grant is the formal acceptance of entitlement to a main benefit.

Main benefit cancellations

There were **37,593 main benefit cancellations** in the December 2023 quarter, a decrease of 3,837 or 9.3 percent from the December 2022 quarter. There were **16,311 exits into work** in the December 2023 quarter, a decrease of 4,833 or 22.9 percent from the December 2022 quarter.

Figure 8a: Number of main benefit cancellations by benefit type during the last six December quarters.

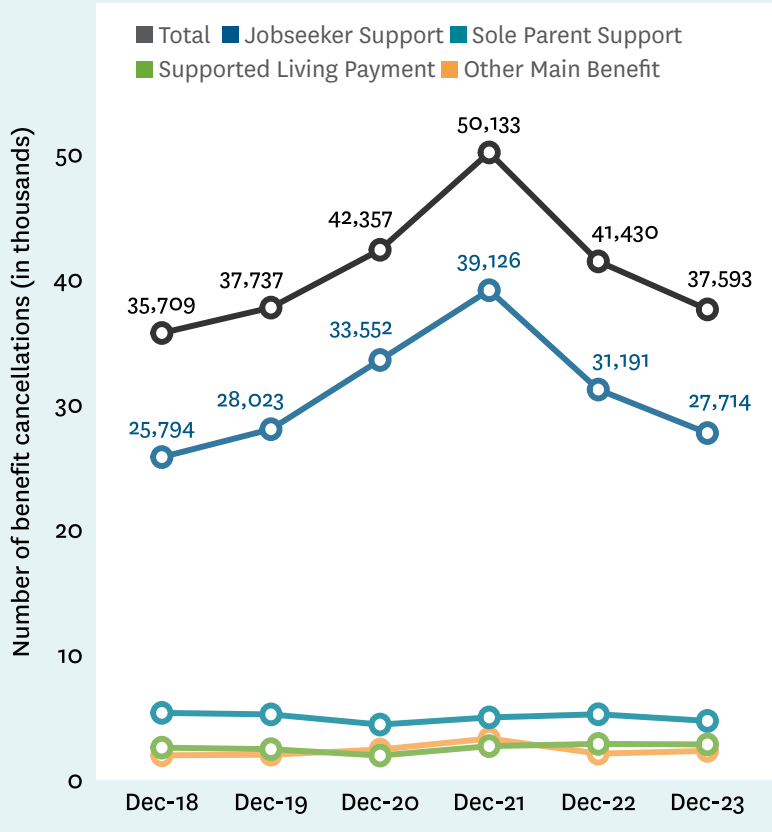
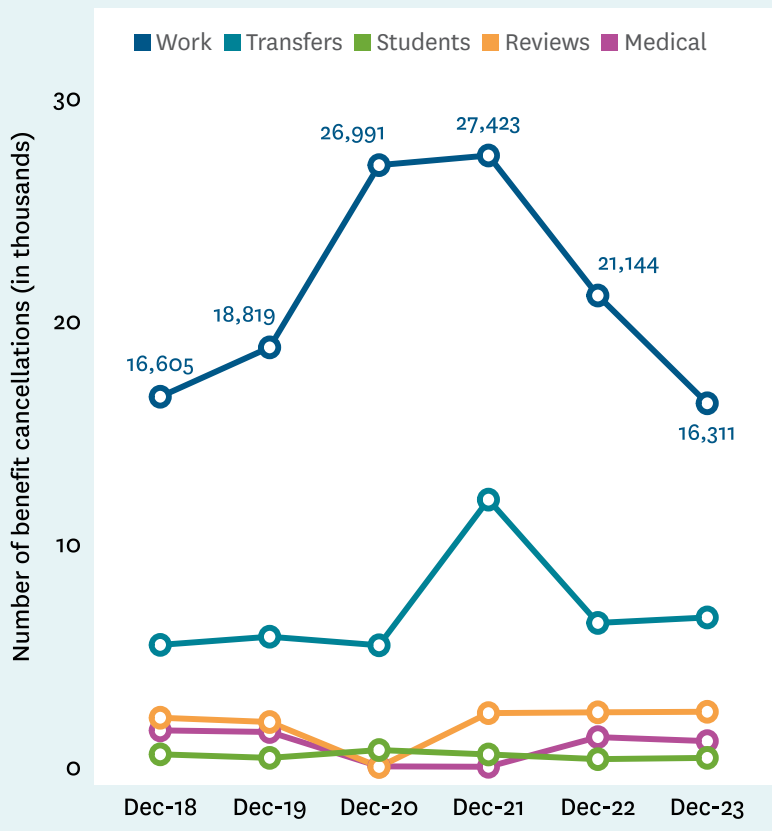


Figure 8b: Number of main benefit cancellations by selected reasons during the last six December quarters.



A main benefit cancellation is the formal process that ends the entitlement to a main benefit.

Benefit sanctions

The number of sanctions issued during the December 2023 quarter was **6,147**, an increase of 759 or 14.1 percent from the December 2022 quarter.

A sanction is a reduction in a person's benefit that may occur if they do not fulfil their work obligations. Not everyone who does not fulfil their obligations gets sanctioned; if benefit recipients re-comply or provide additional information, the sanction can be overturned.

During the December 2023 quarter, the main reasons for unfulfilled work obligation sanctions were **clients not attending appointments** including seminar appointments (3,483 sanctions) and **failing to prepare for work** (2,157 sanctions).

Figure 9a: Number of sanctions for unfulfilled work obligations during the last six December quarters.

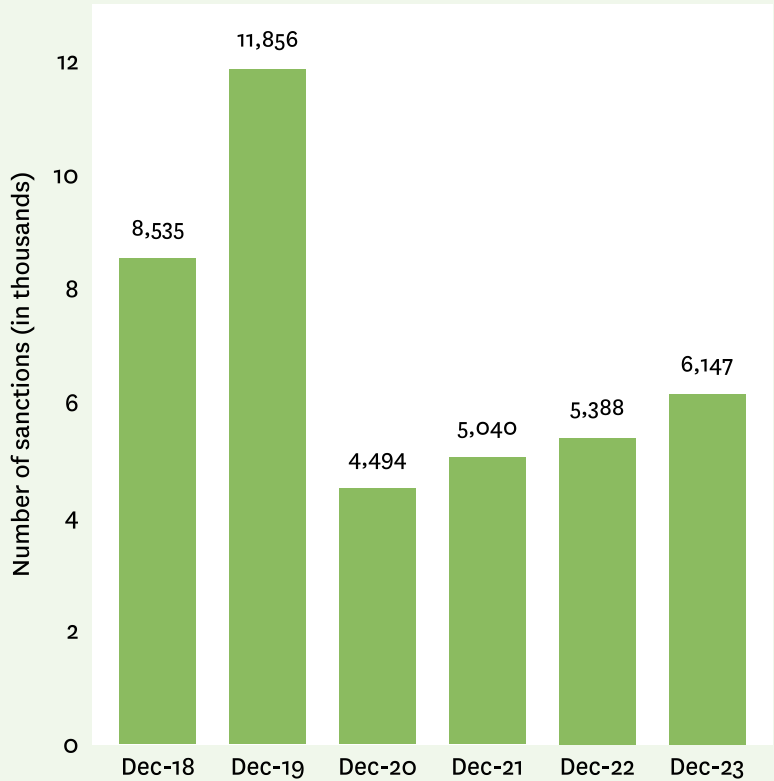
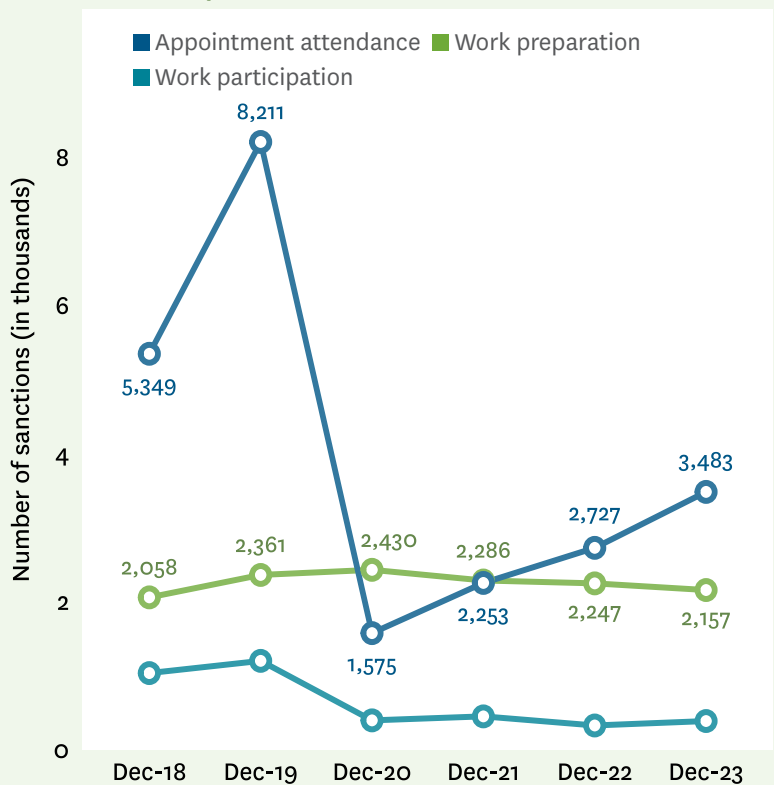
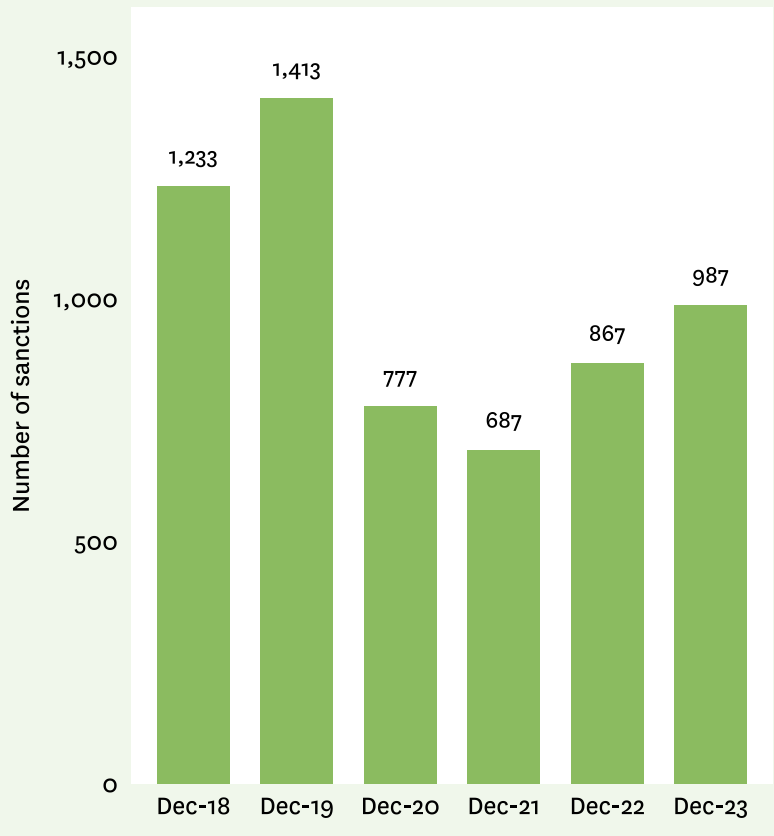


Figure 9b: Number of sanctions for unfulfilled work obligations by reason during the last six December quarters.



At the end of December 2023, there were **987** graduated sanctions in place, an increase of 120 or 13.8 percent from the December 2022 quarter.

Sanctions can affect benefit recipients in a number of ways, depending on their circumstances and the number of times they have had a sanction over the last 12 months. There are three types of sanctions: graduated (i.e. percentage reduction in benefit amount), suspended, or cancelled.

Supplementary assistance

Between the end of December 2022 and the end of December 2023:

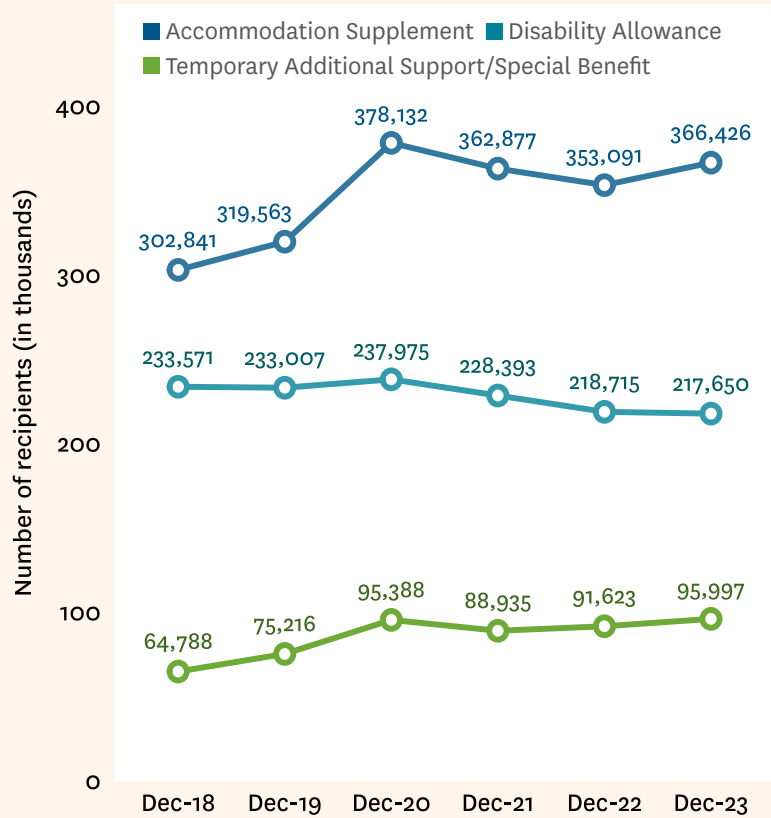
- the number of people receiving Accommodation Supplement increased by **13,335** or 3.8 percent
- the number of people receiving Disability Allowance decreased by **1,065** or 0.5 percent
- the number of people receiving Temporary Additional Support/Special Benefit increased by **4,374** or 4.8 percent.

The Accommodation Supplement assists people on low incomes with their rent, board, or the cost of owning a home.

The Disability Allowance assists people who have on-going costs because of a disability.

Temporary Additional Support helps people to cover essential living costs that cannot be met from their income or other resources.

Hardship assistance

Total hardship assistance

During the December 2023 quarter, there were **601,752** hardship assistance payments, worth **\$240.7 million**.

Compared with the December 2022 quarter, the number of hardship assistance payments was 1.6 percent higher, and the value of hardship payments was 4.4 percent higher.

Figure 11a: Number of hardship payments provided during the quarter for the last six December quarters, by type of assistance.

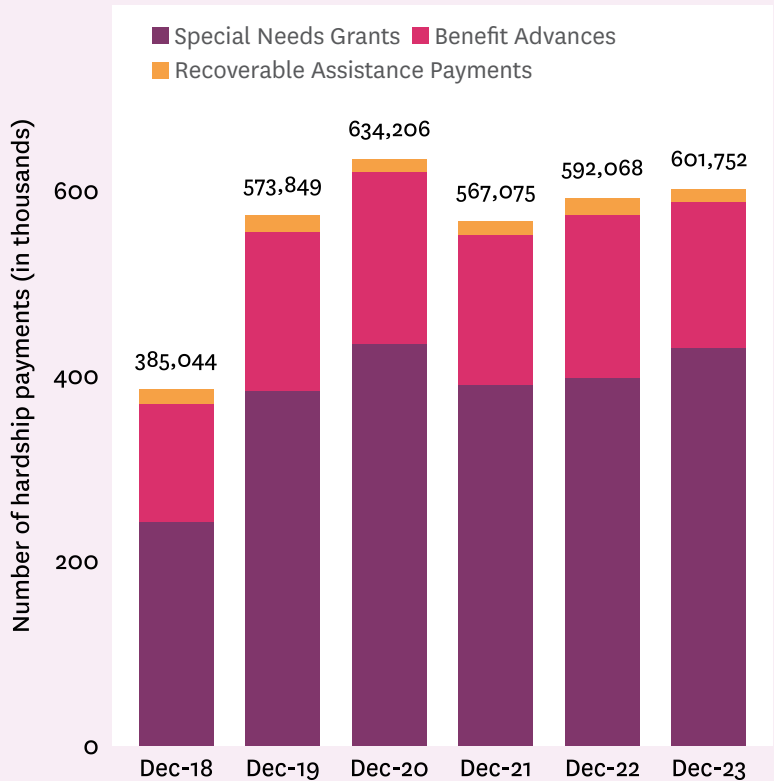
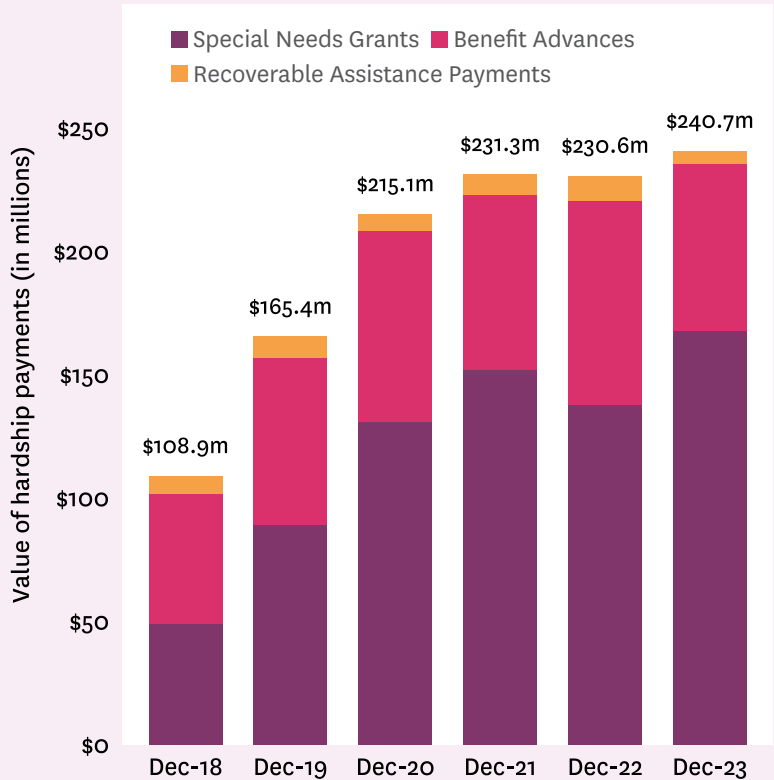


Figure 11b: Value of hardship payments provided during the quarter for the last six December quarters, by type of assistance.



Hardship assistance includes, but is not limited to: Special Needs Grants, Benefit Advances, and Recoverable Assistance Payments. These forms of assistance are designed to help people who have immediate needs.

Reasons for hardship assistance

Two key types of hardship assistance are Special Needs Grants for food and Emergency Housing Special Needs Grants.

There were **336,270** Special Needs Grants for food during the December 2023 quarter, up 4,656 or 1.4 percent from the December 2022 quarter. The value of these grants was **\$35.8 million**, up 1.5 percent from the December 2022 quarter.

There were **24,114** Emergency Housing Special Needs Grants during the December 2023 quarter, down 2,256 or 8.6 percent from the December 2022 quarter. The value of these grants was **\$86.2 million**, down 0.3 percent from the December 2022 quarter.

Figure 12a: Number of hardship payments provided during the last six December quarters by selected reason.

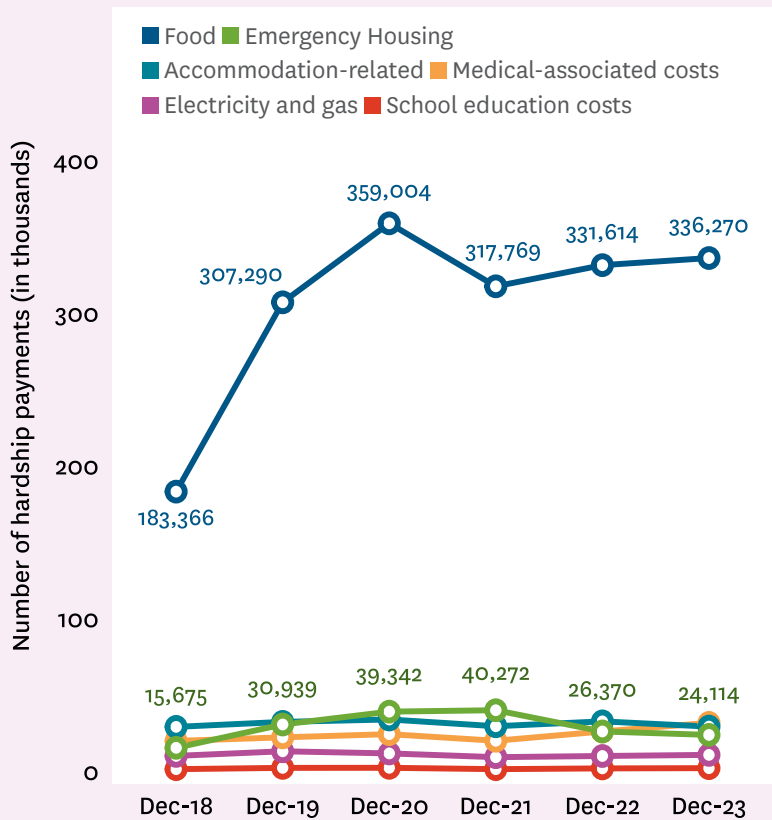
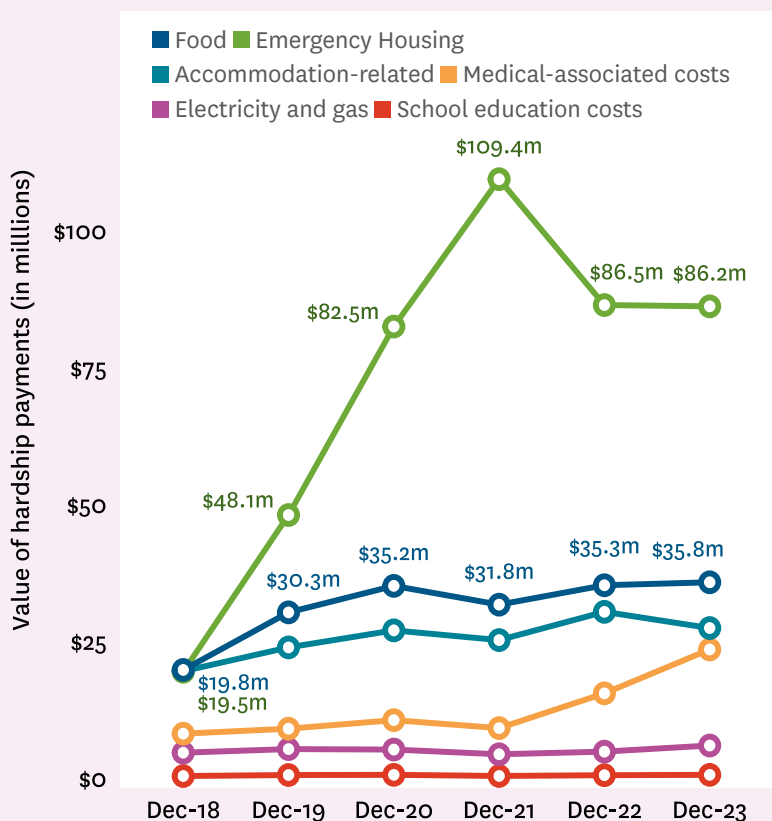


Figure 12b: Value of hardship payments provided during the last six December quarters by selected reason.

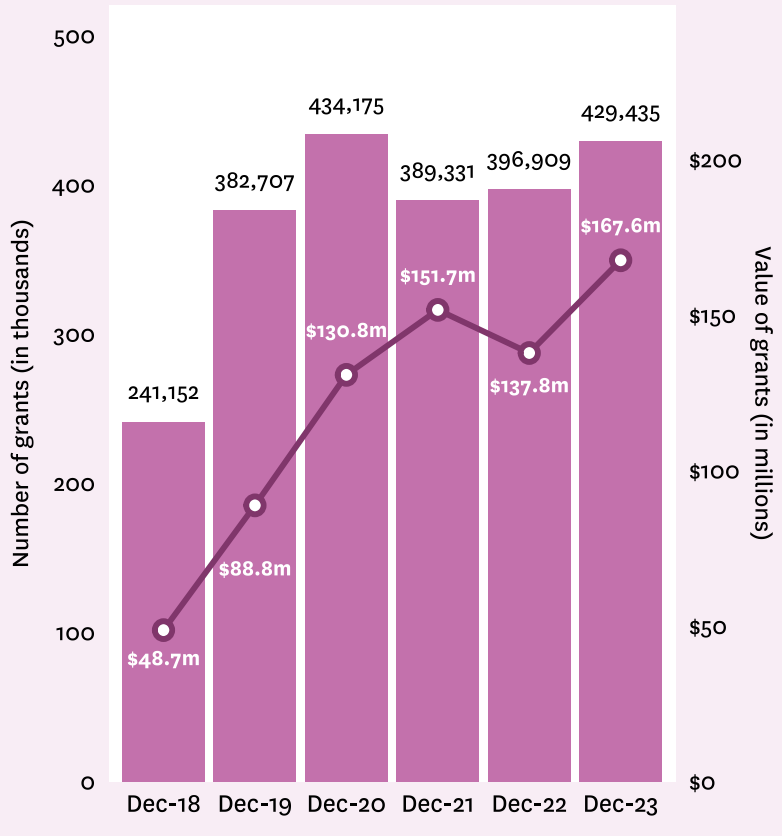


Special Needs Grants

There were **429,435** Special Needs Grants in the December 2023 quarter, up 8.2 percent from the December 2022 quarter. The value of these grants was **\$167.6 million**, up 21.6 percent from the December 2022 quarter.

A Special Needs Grant provides a non-taxable, one-off recoverable or non-recoverable payment to help people meet immediate needs. A person does not need to be receiving a main benefit to be eligible for a Special Needs Grant.

Benefit Advances

There were **158,529** Benefit Advances provided during the December 2023 quarter, down 10.1 percent from the December 2022 quarter. The value of these grants was **\$67.6 million**, down 18.0 percent from the December 2022 quarter.

A Benefit Advance can be up to six weeks of a benefit recipient's net entitlement, and is recovered from subsequent payments of benefit. People not receiving a main benefit may instead receive Recoverable Assistance Payments.
