Emergency Housing SNGs | Jan 2022 |

Emergency housing is short-term accommodation (usually in motels) for individuals who have an urgent need because they are unable to remain in their usual place of residence. It is funded through Special Needs Grants that clients apply for when they cannot access accommodation and we've explored all the other options available to them. Grants can cover between 1 and 21 nights accommodation at a time.







Commentary

There was a substantial decrease in the expenditure on Emergency Housing Special Needs Grants between December and January (down from \$41.4m to \$28.7m). This was due to the holiday period, with many grants made in December covering stays in Emergency Housing during the first half of January.

The number of clients in Emergency Housing at the end of January is also down to 4,743, from a peak of almost 5,000 households across both November and December. This is consistent with seasonal trends from previous years.

The number of new households entering Emergency Housing continues to fall each month. However, the average duration for those in Emergency Housing continues to increase, up to 20.2 weeks from 19.3 weeks, as households already in Emergency Housing are staying for longer.





Households by duration in Emergency Housing 4 - as at end of the month









Age distribution of primary applicants in Emergency Housing – as at end of the month

The Public Housing Register is a non-time bound list of all applicants eligible to be placed in Public Housing. Applicants complete a public housing assessment which determines eligibility and priority for public housing against an agreed set of criteria, which is then used to assist the public housing provider in matching to the most appropriate property.







Public housing - Register numbers
















Percentage of main applicants, by ethnicity 12 - as at end of the month

Commentary

There were 31,128 applications live on the Public Housing Register at the end of January, an increase of 378 from December 2021.

The number of new applications on to the Register decreased in January, as fewer assessments were completed over the holiday period, with reduced business days in January. There was also a decrease in the number of applications exiting the Register in January, which follows usual seasonal patterns for the beginning of each calendar year.

MSD reports total response ethnicity.
