# Remaining decisions relating to Budget 2024 Purpose



It is recommended that you:



# Background

Following your Social Development Budget 2024 bilateral meeting with the Minister of Finance on Wednesday 20 March 2024, MSD and the Treasury provided joint advice to you and the Minister of Finance, seeking decisions to inform the fourth Budget Ministers' Meeting (BM 4) on 8 April 2024 and the Budget Cabinet paper on 29 April (REP/24/3/291 refers).



- Food Secure Communities (time-limited)
- GUiNZ Study (time-limited).
- This report provides advice regarding these initiatives, some of which require funding to be transferred forward, whilst others do not.





# Growing Up in New Zealand Study



19 MSD is seeking delegated authority through the Budget Cabinet paper for Joint Ministers to approve the final transfer of funding for the GUINZ Study before the end of the financial year.



21 MSD will continue to work with the University of Auckland to negotiate a contract and provide regular updates.

### **Food Secure Communities**

22 There is \$4m of unspent funding for Food Secure Communities in the current financial year (2023/24), in anticipation that this funding would be returned through Budget 2024.

- 24 It is therefore recommended that you agree to also seek delegated authority for Joint Ministers to approve the final transfer of funding for initiatives as appropriate before the end of the financial year, which will include the Food Secure Communities programme.
- 25 This delegated authority could also provide a mechanism to resolve funding transfers for other initiatives as appropriate – and MSD will provide further advice on this in due course.

- 26 Subject to your decisions in this report, MSD will work with the Treasury to reflect the following in the financial recommendations for the Budget Cabinet paper, which are due on Tuesday 16 April 2024:
  - the final Vote Social Development package, and
  - recommendations to seek delegated authority for Joint Ministers to agree to transfer funding forward before the end of the financial year.
