- **If Treasury does have advice**, email the Treasury secondee (copy Katy.Greco-Ainslie@parliament.govt.nz in) using this template - [Template for feedback on papers for Ministerial consultation \(Treasury:4079208v2\)](#). Treasury advice needs to be received by the office in advance of the Minister needing to provide feedback. In general:
 - If the Minister's feedback is due within the week, Treasury advice is due with the office by 4pm the day before
 - If the Minister's feedback is due the following week, Treasury advice is due with the office by midday Friday.

Consultation feedback tables are not requested for APH or LEG papers unless your team identifies a need to flag an issue with the Office.
