These documents set out the advice provided to the Minister for Child Poverty Reduction in relation to setting the third intermediate child poverty reduction targets and changing the ten-year targets. Under the Child Poverty Reduction Act, the Minister was required to set third intermediate child poverty targets by 30 June 2024. :~:text=Third%20set%20of%20three%20year,costs%20measure%20to%2014%20perc ent. The Minister also considered advice on changing the ten-year child poverty targets which were originally set in 2018. The Minister ultimately decided not to change the ten-year targets. These remain unchanged.

Some parts of the documents included in this information release would not be appropriate to release and, if requested, would be withheld under the Official Information Act 1982 (the Act). Where this is the case, the relevant sections of the Act that would apply have been identified. Where information has been withheld, no public interest has been identified that would outweigh the reasons for withholding it. This is the key to the redaction codes used for this release:

- Section 9(2)(h) this information is legally privileged
- Section 9(2)(a) to protect the privacy of natural persons.
