On 8 September 2016 you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

- *All advice, briefs, reports and memos sent to the Minister of Social Development, Hon Anne Tolley, to determine the name of the Ministry for Vulnerable Children, Oranga Tamariki.*

The name of the Ministry for Vulnerable Children, Oranga Tamariki fully incorporates the Māori name Oranga Tamariki, which means the health or wellbeing of children. This is the first Government entity to give equal weight to both the Māori and English names of the department.

A lot of the work that went into the decision on the name of the new Ministry occurred in conversations between Officials, community groups, the Youth Advisory Panel and the Minister. As such there are not a lot of documents to release. Enclosed are the six documents identified as being in scope of your request:

- Memo from the Associate Program Director of Investing in Children, *Expert Panel Report: Investing in New Zealand's children and Families: Early draft of the Cabinet paper*, dated 4 February 2016. This memo is primarily in relation to the draft of the Cabinet paper regarding the recommendations in the *Expert Panel Final Report: Investing in New Zealand's Children and Families*. You will note the majority of the memo is redacted as it is out of scope of your request.
- Email from an advisor at the Office of the Children's Commissioner, *YAP feedback*, dated 8 June 2016. This email contains a screenshot of a Facebook group conversation from the Youth Advisory Panel outlining their views on the name of the new agency.
- Email, *Re: New Children's Entity name*, dated 10 June 2016.
- Email, *FW: ideas for names*, dated 13 June 2016.
- Email, *NCE name*, dated 9 August 2016. This is an email from the State Services Commission providing advice on the formal naming of the new Ministry to the Minister's Private Secretary.
- Email from the Māori Language Commission, *Te Taura Whiri i Te Reo Māori, FW: Name for the new entity/ministry*, dated 10 August 2016.

You will note that the names of some individuals are withheld under section 9(2)(a) of the Act in order to protect the privacy of natural persons. The need to

protect the privacy of these individuals outweighs any public interest in this information.

Additionally some information is withheld under section 9(2)(g)(i) of the Act to protect the effective conduct of public affairs through the free and frank expression of opinions. I believe the greater public interest is in the ability of individuals to express opinions in the course of their duty.

You will also note that some information has been withheld as it is outside of the scope of your request.

The principles and purposes of the Official Information Act 1982 under which you made your request regarding the naming of the Ministry for Vulnerable Children, Oranga Tamariki are:


- to create greater openness and transparency about the plans, work and activities of the Government,

Kia ora Jack,

As per our conversation earlier today here are some initial thoughts (all subject of course to Māori Language QA process etc), based loosely around the proverb/idea, "Ka whāngāia, kā tupu, ka puawai" – "that which is nurtured grows, then blossoms."

An interesting fun fact: The word whāngai in Māori language means both foster child and to nurture. The two are synonymous which gives you an indication of the cultural expectation around foster children within a healthy whānau, hapū, iwi system.

Te Wai Korari - Wai korari is the nectar of flax flowers, which children used to be tasked with extracting back in the day (probably because they had little hands and lips). The flax bush is a traditional metaphor for family, where the 'rito' (flower) is seen as the child, the middle leaves are seen as the parents, and outer leaves the grandparents. So the name draws on children as those who hold the 'wai korari' and those who extract it. Without children, there is no 'wai' (water / life sustenance), which means no nectar and no flax bush.

Hi S 9(2)(a)

As discussed:

- Option 1: TPK is the "Ministry of Maori Development" in the State Sector Act schedule and then the Ministry of Maori Development Act has a section specifying that the department's name in Maori is Te Puni Kokiri
- Option 2: The Order in Council and Schedule would have the Ministry for Vulnerable Children name. The Gazette notice would repeat the OIC wording but could also have an explanatory note that the department will also be known in Maori as Oranga Kowiriaki
- Option 3 – Legal name as both English and Māori. This is a bit clunky as it involves using both together in all situations where the legal name is required – however both Archives NZ and National Library had dual names listed in the schedule in the past. The OIC, Schedule, Gazette and all other comms would name the department as Ministry of Vulnerable Children Oranga Kowiriaki (or the other way round – the second name could run straight on or be in brackets)
- Option 4 – Maori legal name. This hasn't been done this way before in Schedule 1 but is doable. The OIC, Schedule and Gazette would list the name as Oranga Kowiriaki, with an explanatory note in the Gazette that the department would also be known as the Ministry for Vulnerable Children

Finally, and you may have already done this but I understand there's a process for establishing what the correct Maori name would be as the legal name.

Whatever is decided we would also replicate in the warrant for the CE.

Let me know how your minister would like to proceed or if you need any further information.

When considering a name for a public entity, and one that will come under some scrutiny, it is important to consider the following;

- simplicity, in pronunciation, concept, and applicability
- aspirational in message and interpretation
- acceptability to Maori and the wider New Zealand public

The suggested term 'Oranga Kawariki' has merit and it's origin, interpretation and applicability are clear. I would like to suggest two things however;

- shortening the name to one word to keep it simple
- using 'Mana' instead of 'Kawa' i.e. Manariki

I propose Manariki for the simple reasons that;

- the word 'Mana' has become part of the NZ vernacular
- it promotes a process of nurturing the mana of a child as much as the outcome of a child whose mana is intact and/or enhanced, and this promotes the notion of a secure future for a child.
- it roll easily off the tongue and will hopefully not be strangled in pronunciation

The word kawariki is used by some but not all tribes and the word 'kawa' itself can have some negative connotations.

Section 9(2)(g)(i) Free and frank expression

I could go one further and simply propose 'Tamariki' (children) as the term - now that is simple!
