On 14 July 2016 you emailed the Ministry requesting, under the Official Information Act 1982, correspondence between the Office of the Children's Commissioner and the Ministry relating to Youth Justice Residence monitoring reports. The Ministry would like to take this opportunity to apologise for the delay in responding to your request.

Children and young people who are ordered by the Youth Court to spend time in a Child, Youth and Family Youth Justice Residence often come from a difficult background and have already exhausted all other available options designed to address their offending behaviour.

A child or young person might be ordered to a Youth Justice Residence for the following reasons:

- They have been arrested by Police and their offending matters warrant them being placed in the custody of Child, Youth and Family pending their next Court appearance.
- They have been remanded by the Youth Court and are directed to a Youth Justice Residence until the Court deals with the case.
- They have been sentenced by the Youth Court for a period between three to six months; once they leave the Youth Justice Residence, they will be subject to six to twelve month's supervision in the community.
- If a young person is sentenced to a prison term in the adult Court, they may be admitted to a Youth Justice Residence to serve some or their entire sentence.

Children and young people in Youth Justice Residences have their own bedrooms, and access to communal areas including the living room and dining room. There is also a school building, a gym and areas for sports and outdoor activities. Trained staff work with the children and young people to run programs, provide support, mentoring and extra care for any child or young person presenting with significant risk factors. Education and health services are also provided to children and young people while they are in a Residence.

You will note that the names of some individuals are withheld under section 9(2)(a) of the Act in order to protect the privacy of natural persons. The need to protect the privacy of these individuals outweighs any public interest in this information.

The monitoring reports and meeting minutes referenced in the enclosed correspondence are withheld in full under section 9(2)(g)(i) of the Official Information Act in order to protect the effective conduct of public affairs through the free and frank expression of opinions. I believe the greater public interest is in the ability of individuals to express opinions in the course of their duty. You have previously been provided with summarized versions of the monitoring reports which are publically available on the Ministry's website.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and attached documents available to the wider public after ten working days. The Ministry will do this by publishing this letter and attachments on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.

Residence monitoring visit to Te Maioha o Parekarang youth justice: March 2014

As you will be aware, in February 2015, staff from your office conducted a pre-arranged visit to Te Maioha o Parekarangi youth justice residence in Rotorua. The resulting report contained a number of recommendations for the residence's consideration.

On 3 November 2015 the Te Maioha or Parekarangi residence manager and CYF national office staff met with members of your office via videoconference to review the residence's action plan in response the recommendations. Please find enclosed, for your records and information, the minutes of the meeting.

Agreement was reached at the end of the meeting that appropriate actions have been taken to address the recommendation and OCC will likely pay an informal visit, outside of the monitoring programme, to Te Maiona o Parekarangi when the opportunity arises.

Prearranged residence monitoring visit to Korowai Warraaki; July 2014

In July 2014 staff from your office's monitoring and investigations team undertook a prearranged monitoring visit to the Korowai Manaaki youth ustice residence in Auckland. The visit resulted in a number of recommendations.

On 17 June 2015, the Korowai Manaaki residence manager met with members of your office via videoconference to review the residence's response to these recommendations.

Agreement was reached at the end of the meeting that there would be a further review of progress in November 2015.

On 4 November 2015, the Kor war Manaaki residence manager and CYF national office staff met with members of your manitoring earn to discuss the residence's progress in responding to the recommendations. The national from that meeting are attached.

Agreement was reached at the end of the meeting that good progress has been made to address the recommendations. While additional meetings are not required, a follow-up discussion will take place in behavior or March 2016 between the residence and OCC to consider progress.


