On 6 March 2017, you emailed the Ministry requesting, under the Official Information Act 1982, follow up information for the amount of government funding for each provider listed in the response you received on 21 February 2017.

As you are already aware, a total of \$24,718,505 family violence funding has been provided to organisations, excluding Shine and the National Collective of Independent Women's Refuges (NCIWR) affiliated women's refuges, which combat family violence.

Please find enclosed a spreadsheet that lists the organisations that receive family violence funding and the allocated funding amount for each organisation.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public shortly. The Ministry will do this by publishing this letter and attachments on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.
