On 19 April 2018 you emailed the Department of Internal Affairs requesting, under the Official Information Act 1982, the following information:

• The total and yearly sum that the government has spent on the Working For Families program since its creation

This request was subsequently transferred to the Ministry of Social Development and the Inland Revenue Department. The Ministry can answer your request in relation to the provision of Accommodation Supplement and Childcare Assistance as they are administered by the Ministry of Social Development. Please find attached two tables. Table one provides the number of non-beneficiary clients with children receiving Accommodation Supplement as at the end of June from 2005 to 2017. Table two provides the number of non-beneficiary clients receiving Childcare Assistance (OSCAR/CCS) as at the end of June from 2005 to 2017.

Please note these tables only include clients not in reciept of a benefit as Working For Families assistance is targeted at working families with children i.e people not in receipt of a main benefit (Jobseeker Support, Sole Parent Support and Supported Living Payment). It is important to note that families receiving main benefits may be eligible to receive Family Tax Credit, Accommodation Supplement and OSCAR/CCS.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.
