On 21 September 2020, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- 1. All correspondence/emails, briefings, and other documents provided to the Minister and between Ministry officials in the decision-making process for the COVID-19 Income Relief Payment (CIRP).
- 2. All correspondence/emails, reports, briefings, and other documents provided to the Minister and between Ministry officials as to the suitability of current benefit levels for people becoming unemployed due to COVID-19 from 1 November 2019 to now.

On 30 September 2020, you refined question one of your request to the following:

1. All briefings and other documents provided to Minister Sepuloni by Ministry officials, and all correspondence/emails between Ministry officials and the Office of the Minister for Social Development in the decision-making process for the COVID-19 Income Relief Payment (CIRP).

I would like to extend my apologies for the delay in responding to your request for information.

For reasons of clarity, I will respond to your questions in turn.

 All briefings and other documents provided to Minister Sepuloni by Ministry officials, and all correspondence/emails between Ministry officials and the Office of the Minister for Social Development in the decision-making process for the COVID-19 Income Relief Payment (CIRP)

All the papers provided to the Minister for Social Development and leading up to the implementation of CIRP have been proactively released. Your request for this information is, therefore, refused under section 18(d) of the Act as the information is publicly available. The documents in scope of question one are available at the following weblink: www.covid19.govt.nz/updates-and-resources/legislation-and-key-documents/proactive-release/income-support-measures/.

Regarding correspondence, please find correspondence in scope of your request attached to this letter.

The following four documents referenced in the correspondence are also attached to this response:

To expedite the response, information contained within the correspondence that is not within scope of your request has not been included.

You will note that the names of some individuals are withheld under section 9(2)(a) of the Act in order to protect the privacy of natural persons. The need to protect the privacy of these individuals outweighs any public interest in this information.

Some information within the Memo Further information on implementation timeframes for temporary income relief options, dated 15 April 2020, is withheld under section 9(2)(f)(iv) of the Act as it is under active consideration. The release of this information is likely to prejudice the ability of government to consider advice and the wider public interest of effective government would not be served.

Some information is withheld under section 9(2)(g)(i) of the Act to protect the effective conduct of public affairs through the free and frank expression of opinions. I believe the greater public interest is in the ability of individuals to express opinions in the course of their duty.

You will note that the contact details of some individuals have been withheld under section 9(2)(k) of the Act in order to reduce the possibility of staff being exposed to phishing and other scams. This is because information released under the Act may end up in the public domain.

You will note that some information within the Report *COVID-19 Income Relief Payment – legislative process,* dated 12 May 2020 is withheld under section 6(c) of the Act where making that information available would be likely to prejudice the maintenance of the law, including the prevention, investigation and detection of offences.

The Ministry searched for further reports and briefings in scope of the second question of your request that have not been published to date. I can confirm that the Ministry did not locate any further documents within scope of your request.

The Ministry refuses the second question for 'other documents' that have not been provided in this response under section 18(f) of the Act. Your request for 'other documents' is very broad and substantial manual collation would be required to locate and prepare any further possibly existing documents within scope. The greater public interest is in the effective and efficient administration of the public service.

Regarding correspondence and emails, the Ministry advised you on 29 September 2020 that this aspect of your request is very broad and manual collation of correspondence and emails relating to this subject is likely required. The Ministry advised you that this aspect of your question may, therefore, be refused under section 18(f) of the Act. The Ministry invited you to refine your request. On 30 September 2020, you advised the Ministry that you did not want to refine this part of your request.

I made inquiries with the relevant business units and can confirm that substantial manual collation would be required to locate and prepare all documents within scope of your request. In order to provide you with the information requested, the Ministry would need to divert personnel from their core duties and allocate extra time to complete this task. The diversion of these resources would impair the Ministry's ability to continue standard operations and would be an inefficient use of the Ministry's resources. As such, I refuse this part of your request under section 18(f) of the Act. The greater public interest is in the effective and efficient administration of the public service.

I have considered whether the Ministry would be able to respond to the second question of your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Ministry's ability to undertake its work would still be prejudiced.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government
- to increase the ability of the public to participate in the making and administration of our laws and policies

to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public. The Ministry will do this by publishing this letter and attachments on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.



Kia ora Section 9(2)

Attached is the cover report, the draft Cabinet paper and the draft Bill and Amendment Regulations to ensure the COVID-19 Income Relief Payment can be treated as income for benefit and public and community housing purposes.

The cover report seeks agreement to circulate the draft Cabinet paper and legislation for Ministerial and cross-Party consultation, with feedback due by close of business Tuesday 19 May. We appreciate these are tight timeframes but it is what is required to have the paper considered at Cabinet on Monday 25 May and subsequently, the Bill introduced and passed by 8 June. The drafts are being circulated for agency consultation at the same time.

In regards to the timeframe for passing the Bill, an indicative timeframe is attached as an Appendix to the cover report. We have spoken with the Office of the Clerk – who have advised that the 2 day rule (for the Bill to sit on the order paper) doesn't apply if legislation proceeds under urgency. The did seem weary about the use of urgency and suggested that legislation can be introduced on any day, and then urgency can be used later ie it can sit for a day or two until the first reading etc proceeds under urgency, which provides somewhat more opportunity for scrutiny.

We think it would be best for the office to confirm the approach for passing the Bill with the Office of the Leader of the House to explore what would work best.

Why is the Government looking at this now?

The Government is looking at how best to support displaced workers (particularly financially) and unemployment insurance is a key tool many countries use for that purpose. We want to understand the role it can play in New Zealand.

What is unemployment insurance?

- Unemployment insurance provides replacement cover for lost income. Redundancy is the usual reason for getting unemployment insurance.
- The replacement income is usually a percentage rate of a person's lost income. Different countries offer different levels of replacement income.
- The replacement income usually lasts for a number of months, or until a person finds new
- People receiving income insurance payments usually also get help to find work, or retrain and upskill.

What other countries have unemployment insurance?

Unemployment insurance is common in OECD countries. OECD governments usually play important roles in administering insurance schemes, often working closely with business and unions.

Who pays?

Unemployment insurance schemes are funded through a mix of contributions from workers, firms and government.

Does insurance replace welfare?

There is a clear interaction and we need to look at how any such scheme would work alongside our benefit system. Countries with insurance schemes usually also have welfare systems.

How serious is the government about unemployment insurance?

The government has an open mind and is looking forward to receiving advice from officials. Unemployment insurance plays an important role in other countries in reducing the financial shock of job loss, and helping people back to work.

Any moves towards an insurance scheme would be gradual (over several years) and would be taken in close consultation with unions and business.

The eligibility criteria coûld be amended so that the payment is resumed only for people who have lost their subsequent work for reasons outside of their control. Therefore it would not be available to those who voluntarily terminate their subsequent employment (e.g. resign) or who were dismissed (e.g. for misconduct). People who took up a short fixed-term contract would remain eligible to receive the remaining period of entitlement following the end of the contract.

This would ensure that the payment could be implemented by 8 June 2020. If Ministers wanted COVID-19 related job loss, this could only be implemented by 22 June 2020 (if decision is made today).

Please see our comments in red below. We have updated the paper to reflect some of the comments made, however please see below comments on whether further changes to the paper may be required.

- Working for Families entitlement the paper says this payment will have "no impact" on WFF assistance. Will people receiving this payment be eligible for the FTC at a rate that reflects their lower income through this payment compared to their income while in employment? And will the IWTC be available for this period of time also? (rec 6). People receiving this payment will receive the FTC at a rate which reflects a reduced income due to the loss of work. Note that this income calculation for FTC (and wider
 - WFF) does not include this payment as this payment won't be considered income for WFF. E.g. someone without any other income will receive the full rate of FTC, i.e. as if they had zero income. The IWTC won't be available if the person and their partner do not meet the in-employment test – that is, families must be deriving income from employment in that week. We have made this more clear in the paper.
- There is a concern about lack of eligibility for people whose fixed term contracts end during the period from 1 March – 31 December, where these people work in significantly impacted industries. Would this be possible to consider?
 - We could consider more detailed rules around fixed-term contracts ending during eligibility period as part of further advice on decisions on self-employed people and people on unpaid leave who meet the hours test. Please confirm if you would like us to include this reference to further work on this group in the Cabinet paper.
- There has been a request that this be extended to all workers laid off, including migrants on temporary visas- I assume this would not be possible due to the parameters of social security act but can I get some further advice on this please?
 - People on temporary visas could be made eligible for this payment similar to what was done for the Christchurch Mosque attack payment (using the Welfare Programme). However we do not think that this is appropriate given that Ministers are still considering how to best to assist temporary migrants. A draft Cabinet paper is currently with Ministers (Immigration and Social Development) for Ministerial and cross-party consultation. The paper proposes to establish a time-limited hardship grant to provide

financial assistance to temporary migrant workers who lose their employment due to COVID-19. The proposed hardship grant for migrants is less generous than the temporary income relief payment. Extending the temporary income relief payment to temporary migrants would also mean that they would receive more support than existing beneficiaries. Including this group will also increase operational workload and may impact on processing times. Please confirm if you would like us to address this in the Cabinet paper, and if so, what the Minister for SD and MoF would like to recommend.

 Is there any update from MSD on where the student support work is at? There is concern about lack of support for those working under 15 hours, for example students.

We've had a few questions come through the consultation process. Are you able to provide me with responses as soon as possible please? I'm not sure if these are all in MSDs area so let me know if I should seek some of the advice through another office.

- Working for Families entitlement the paper says this payment will have "no impact" on WFF assistance. Will people receiving this payment be eligible for the FTC at a rate that reflects their lower income through this payment compared to their income while in employment? And will the IWTC be available for this period of time also? (rec 6).
- There is a concern about lack of eligibility for people whose fixed term contracts end during the period from 1 March – 31 December, where these people work in significantly impacted industries. Would this be possible to consider?
- There has been a request that this be extended to all workers laid off, including migrants on temporary visas- I assume this would not be possible due to the parameters of social security act but can I get some further advice on this please?
- Is there any update from MSD on where the student support work is at?

There is concern about lack of support for those working under 15 hours, for example students

Is it possible for MSD to draft up the following changes to the paper please? (and if they could keep them visibly separate from the other changes being made so we can distinguish them when Ministers next review the paper please)

- Entitlement to receive this payment if redundancy occurs during parental leave – noting rec 14.8, it should be clarified that this exclusion is only for people remaining on unpaid leave and able to return to work at the end of the leave. If someone is made redundant while on parental leave they should absolutely be eligible for this payment.
- Eligibility for hardship grants if needed while receiving this payment should be clarified that this payment is not intended to preclude availability of other assistance, though will be taken into account in assessing eligibility (rec 5).
- Relationship with main benefit eligibility rec 14.5 should clarify that if someone opts to receive this benefit instead there will be continuity of payment, i.e. no gap between transitioning from Student Allowance to this payment, and no stand down periods after the end of this payment if moving on to a main benefit or back onto Student Allowance.



Attached is the cover report, the draft Cabinet paper and the draft Bill and Amendment Regulations to ensure the COVID-19 Income Relief Payment can be treated as income for benefit and public and community housing purposes.

The cover report seeks agreement to circulate the draft Cabinet paper and legislation for Ministerial and cross-Party consultation, with feedback due by close of business Tuesday 19 May. We appreciate these are tight timeframes but it is what is required to have the paper considered at Cabinet on Monday 25 May and subsequently, the Bill introduced and passed by 8 June. The drafts are being circulated for agency consultation at the same time.

In regards to the timeframe for passing the Bill, an indicative timeframe is attached as an Appendix to the cover report. We have spoken with the Office of the Clerk – who have advised that the 2 day rule (for the Bill to sit on the order paper) doesn't apply if legislation proceeds under urgency. The did seem weary about the use of urgency and suggested that legislation can be introduced on any day, and then urgency can be used later ie it can sit for a day or two until the first reading etc proceeds under urgency, which provides somewhat more opportunity for scrutiny.

We think it would be best for the office to confirm the approach for passing the Bill with the Office of the Leader of the House to explore what would work best.



Options:

- Option 1 is preferred as it best meets the policy intent, uses MSD's usual verification processes so has higher integrity and provides the best service for clients to access all the support they are entitled to.
- Option 1 ensures:
 - clients receive all of their payments from MSD at the same time and on the same pay day. Option 2 will mean clients receive the temporary payment earlier than supplementary assistance and once all assistance is granted, they will receive multiple payments each week.
 - · it is easier for people to transition on to the new payment from a main benefit (if they lost their job after 1 March), easier to transition onto a main benefit if they are still unemployed at the end of the 12-week entitlement period, and manage changes in circumstances more seamlessly.
- Option2:
 - carries risk that some clients receive incorrect payments as the two payment systems cannot easily interact. This could mean some main benefits are overpaid, creating debts for our beneficiaries who have already entered the welfare system due to job loss and elect to transfer to the temporary payment.
 - Even if a link to a calculator and supplementary assistance is provided under option 2, it is still likely to result in fewer applications for additional support.
- Across all of the options, s 9(2)(g)(i)
 - Whether the payment is delivered through SWIFTT or the portal (similar to the wage subsidy) the payment will still have Work and Income branding.
 - Under option 1, people applying for the new payment will face the same integrity checks as beneficiaries and will likely face more similar processing times as people accessing other MSD supports. Under option 2, these people may have preferential treatment because it may mean quicker processing for applications made for the temporary income relief payment and contains less integrity checks.

Taxable treatment:

- The temporary income relief payment will made through a Ministerial Welfare Programme which means by default it would not be taxable.
- The Income Tax Act could be amended to make the temporary income relief payment taxable, however for MSD to operationalise such a payment it would increase the implementation timeframes significantly, and the payment would not be in place by the time that the wage subsidy application close on 9 June 2020.
- To make this payment taxable through our usual IT systems would add at least three months onto the implementation timeframes, and a manual work-around (which would require significant on-going resource and has its own set of risks) would add one month.
- To mitigate this, the proposed payment rate of \$490pw is closely aligned with the
 after tax full-time rate of the wage subsidy. The wage subsidy is paid to employers
 and passed on to employees through regular earnings so is subject to PAYE,
 ACC levies and student loan deductions (if any). A person in full-time work on tax
 code M, paying ACC levies and receiving the full wage subsidy without additional
 earnings, would receive \$494pw.

Further information on implementation timeframes for temporary income relief options

Purpose

This memo provides further advice on implementation timeframes for temporary income relief options to better support low-to-middle income people who experience a significant reduction in their income because of COVID-19.

Further information in implementation timeframes

- On 7 April 2020, Ministers received further advice on options to better support low-to-middle income people who experience a significant reduction in their income because of COVID-19. The advice noted three main options:
 - Option 1: A time-limited weekly payment after job loss (instead of a main benefit), paid on an individual basis – similar to Job Loss Cover (3-month implementation timeframe).
 - Option 2: A time-limited weekly top-up payment after job loss (paid on top-off an existing payment, such as a main benefit or Accommodation Supplement) similar to ReStart (2-month implementation timeframe).
 - Option 3: A lump-sum payment for all new recipients of Accommodation Supplement or a main benefit (2-week implementation timeframe).
- The advice noted that MSD would continue to consider the feasibility of delivering option 1 in a shorter timeframe by using a high trust model and similar payment mechanism to the wage subsidy scheme (paid outside the usual MSD payment systems). Further consideration would need to be given to the trade-offs/risks with using a different payment mechanism.
- 4 MSD will work with other agencies to provide further advice to Joint Ministers by the end of this week on the trade-offs and risks with options that reduce implementation timeframes. At a high-level:
 - The implementation timeframes for option 1 could be reduced to around 2-4 weeks (depending on the option agreed by Ministers) if the payment was implemented outside of MSD's usual payment system with minimal interactions with existing supports. This payment would need to be delivered via a self-declaration of job loss and a high trust model with minimal application and verification requirements. Implementing a high trust model has increased risk as this would rely on clients self-declaring eligibility, and only basic verification checks using IR information for identification purposes. There are also some key policy decisions required by Ministers on the treatment of income and eligibility for supplementary and other assistance.

- The timeframes for option 2 could also be reduced to around 4 weeks if the requirement
 for people to be 'newly redundant' was instead replaced with people simply being new
 main benefit recipients (or new Accommodation Supplement recipients) as well as the
 payment rules being simplified. Such a change is easier to administer because of the
 simpler eligibility and payment rules.
- Further information on the options and key decisions required will be provided in the proposed advice to Joint Ministers later this week. There are some key choices, trade-offs and limitations with each option that need to be worked through and considered further by Ministers.
- 6 Further advice will also be provided on:
 - · Options for support for rental arrears
 - Section 9(2)(f)(iv)
- Due to MSD operational pressures and our limited ability to deliver multiple new initiatives at the same time (e.g. a job loss payment, an amended wage subsidy, payments to other groups such as OB/UCB) phasing of implementation will likely be required. Implementing an amended wage subsidy at the same time as a temporary income relief option may not be feasible further advice on this can be provided.

Integrity scenarios and application processes

Potential for individuals to exploit the payment:

- Apply for a subsidy they don't meet the hours test for
- · Apply for a subsidy when they hadn't been working
- Apply for a subsidy when they are still working
- Apply for a subsidy using someone else's identity

With all of these scenarios, an applicant would be making false declarations to MSD. This risk exists for other support, including main benefits. MSD has processes for this payment (and other support) to reduce these risks.

Procedures: Up-front

- This payment will be managed through MSD's existing payment infrastructure, SWIFTT. Current design is for applicants to be subject to the same identity checks as those which applicants for main benefits currently experience at Alert Levels 3 and 4 (including identity documents, IR number and bank account details). As we continue to work through what our application processes will be for all income support products through different Alert Levels, processes for this payment may change in line with those.
- If any applicant for this payment also applies for other assistance (e.g.)
 Accommodation Supplement), they will also be subject to the same integrity processes as other clients. This will include scruting of their costs and income.
- MSD is continuing to explore whether application, verification or approval processes
 could be adjusted to improve processing times. We will provide you with further
 advice if options are identified, but this will necessarily include thorough
 consideration of any additional integrity risk that would be introduced.
- MSD will also be ensuring that people do not receive this payment at the same time
 as main benefits or Student Allowance, ensuring that people do not receive more
 income support than they are entitled to.

Retrospective

- As with all payments where there is evidence someone has deliberately committed fraud against MSD (to the detriment of the Crown and New Zealand taxpayers), MSD can prosecute that person.
 - MSD will be collecting information from applicants regarding their circumstances and eligibility. Although it is not currently intended that there will be verification of these details up from they provide MSD with information it could check retrospectively.
- The appropriate retrospective audit approaches for this payment are still being developed. This includes exploring whether to use existing or new data-sharing mechanisms with IRD to check that individuals were working prior to their application and not working while they were receiving this payment), or at what level they were earning.

Potential for employers to exploit the payment:

· Applicant is let go for the period of the payment, then re-hired

Under this scenario, an employer could seek to exploit the payment by making an employee redundant with the intention of re-hiring them at a later date. This would effectively allow the employer to use the payment as a wage subsidy for unpaid leave, but create unnecessary changes in circumstances for employees, as well as potentially introduce inefficiencies in labour-market matching if there are unnecessary changes in employer/employee relationships at the end of the 12-week period.

If workers on unpaid leave were eligible for this payment, employers would have no incentive to make them redundant unnecessarily. This would reduce matching inefficiencies if there are fewer job changes.

However, employers would have stronger incentives to put employees on unpaid leave. This has a lower cost for employers than dismissing an employee (due to reduced labour search costs), and therefore may occur in more cases, with employers postponing necessary decisions on their workforce. There is therefore a risk that individuals on unpaid leave lose their jobs at the end of that 12-week period regardless, but while on unpaid leave race reduced incentives or ability to look for other work, and that they do not use the 12 weeks to transition their costs.

Joint Ministers recently agreed the parameters of the COVID-19 Income Relief Payment...

- On 4 May 2020, Cabinet authorised a group of Ministers comprising the Prime Minister, Deputy Prime Minister, Minister of Finance and the Minister for Social Development (joint Ministers), to have Power to Act to take decisions on the proposal for a temporary income relief payment, including:
 - 3.1 any matters required to give effect to the decisions
 - 3.2 funding and appropriations
 - 3.3 drafting instructions for any legislative changes that may be required and
 - 3.4 any other related matters to give effect to the proposals [CAB-20-MIN-0203 refers].
- Subsequently, joint Ministers agreed to establish the COVID 19 Income Relief Payment ('the relief payment'), payable for up to 12 weeks to an eligible individual who experiences or has experienced a loss of work between 1 March 2020 and 30 October 2020.
- The payment will be non-taxable and paid at a rate of \$490 per week for someone previously in full-time work (30 hours of more a week), and \$250 per week for someone previously in part-time work (between 15 hours and 29 hours a week) [REP/20/5/481, T2020/1335 refers). Because it is non-taxable, it will not be treated as income for the purposes of Child Support or other types of assistance administered by Inland Revenue.

... including that the payment would be considered income for benefit purposes

The relief payment will be an alternative to the main benefit, so recipients cannot receive it at the same time as a main benefit. However, recipients will be able to access other income support provided by the Ministry of Social Development (MSD), such as supplementary and hardship assistance. Joint Ministers with Power to Act have agreed that the relief payment will be treated as income for these supports [REP/20X9/481, T2020X1335 refers].

Generally, main benefits are not treated as income for supplementary or hardship assistance. This reflects that those in receipt of a main benefit have low or no income, so receipt of a main benefit should not prevent individuals from accessing supplementary assistance related to their specific costs or circumstances. Likewise, receiving supplementary assistance should not affect access to a main benefit.

While the relief payment is an alternative to the main benefit, it has a different purpose from, and will be treated differently to, a main benefit. The relief payment serves as more of an 'earnings replacement' for individuals who have lost work, rather than the main benefit which serves as more of a 'safety net' for individuals or families with low or no income from work. It is therefore paid at a comparatively higher rate.

If the relief payment was not considered income for supplementary and hardship assistance, then those receiving it would have a greater entitlement to those supports than those who receive other income, such as from paid employment. This would create an inequity between these two groups, so treating this payment as income ensures equity of entitlement.

¹ A main benefit is considered income for the calculation of some supplementary and hardship assistance, for example Temporary Additional Support and the calculation of Income Related Rent Payments.

10 Treating this payment as income also aligns with MSD's IT systems, which enables officials to deliver the relief payment within four weeks of decisions. To implement the relief payment by 8 June, the relief payment would either need to be considered income for all supplementary assistance and hardship payments or none. Different rules would have required a significantly longer lead-in time for implementation to allow for changes to MSD's system.

Ensuring the relief payment is considered income requires changes to primary, secondary and tertiary legislation

- The relief payment will be established in a Ministerial Welfare Programme under Section 101 of the Social Security Act 2018 (the Act). Under current legislation, Ministerial Welfare Programmes are only considered income for Temporary Additional Support, Childcare Assistance and Special Benefit as they are excluded as income for other purposes under clause 8(a) of schedule 3 of the Act. This means primary, secondary, and tertiary legislation must be amended to ensure the relief payment is considered as income for all supplementary and hardship assistance.
- The primary definition of income for the social security system sits in Schedule 3 of the Act. Other income tests and rules for supplementary and hardship payments sit across legislation including the Act, the Social Security Regulations 2018, the Public and Community Housing Management (Prescribed Elements of Calculation Mechanism) Regulations 2018 and various welfare programmes.
- A change to primary legislation is required in order to charge the relief payment as income for Disability Allowance. In order to reduce the number of amendments required to secondary legislation officials recommend you progress a Bill which amends Schedule 3 of the Act to include the relief payment as income for the purposes of eligibility for supplementary and hardship assistance. This amendment will be narrow in scope and will impact only on the treatment of payments made through this specific Ministerial Welfare Programme.
- Officials are working with the Parliamentary Counsel Office and intend to provide you with a draft Cabinet paper later this week.

Changes to legislation are required before 8 June, therefore they need to happen under urgency

- 15 Officials are working at pace to implement the relief payment on 8 June 2020.2
- 16 s 9(2)(f)(iv)

Given the urgency, there are questions about the ability to have a Select Committee process

- Passing the Bill under urgency means a truncated legislative process and raises questions about whether or not there is time for the Bill to be considered at a Select Committee.
- Officials seek your direction on whether to have a significantly truncated Select Committee process or no Select Committee process. Indicative timelines³ for both options are attached as an Appendix to this report.

Implementing the relief payment from 8 June coincides with the end of the Wage Subsidy on 9 June.

Note this timeline does not include the creation of the Welfare Programme for the relief payment or amendments to Welfare Programmes as this process can happen without Cabinet approval.

Option one: No Select Committee process (MSD's preferred option)

- While a Select Committee process is ideal, officials do not consider that there is time to do so meaningfully. Any substantial changes suggested through the process will not be able to be incorporated, as the legislation would be considered less than a week before the go live date and it would be too late to make any changes to MSD's systems.
- 20 Given already constrained timeframes, any changes as a result of the Select Committee (even on technical drafting changes) would be at such a late stage that it could either:
 - 20.1 jeopardise the implementation date, potentially delaying access to the relief payment, or

We acknowledge the shortfalls of this approach, particularly an regard to a lack of public scrutiny. However, the changes to legislation required are relatively miner in comparison to the creation of the relief payment. Any engagement with Select Committee could only focus on the technical drafting changes in the proposed Bill, rather than the more substantial policy decisions within the Ministerial Welfare Programme (which does not involve a Select Committee process).

Option two: A truncated Select Committee process

- To ensure transparency and to allow time for public scruting a Select Committee process is ideal. Given timeframes to ensure the Bill is able to be passed before 8 June, any Select Committee process would be significantly truncated. It is likely this process could only last for a day and a helf.
- 23 The proposed indicative timeline indicates:
 - the Billeonid be introduced on Wednesday 3 June for first reading and Select Committee

the Select Committee would report back on Thursday 4 June

leaving Friday 5 June for the second reading, committee of the whole house, third reading and Royal assent.

- The Select Committee process would likely result in the House needing to extend their sitting hours to ensure the Bill could be passed before 8 June 2020, as Friday 5 June is not a scheduled sitting day.
- As noted above, there is also the risk that any changes suggested during the Select Committee process would either not be able to be incorporated, or risk implementation delays.
- Whilst a truncated Select Committee process is possible, it adds significant risk to the timeline for implementation of the relief payment.

Next steps

- 27 Officials will provide your office with a draft Cabinet Legislation Committee paper later this week for Ministerial consultation.
- 28 The Welfare Programme which will establish the relief payment will be sent to you for approval on Friday 22 May.

Losing a job due to COVID-19 while on paid parental leave, compared to other types of leave

- Joint Ministers agreed that those on unpaid leave, such as planned time off work or parental leave, would not be eligible for the relief payment. This excluded those that lose their job while on parental leave.
- 2 Further work has been done to determine how to treat people who lose their job due to COVID-19 while on leave. The table below outlines the proposed approach.

	Lose job due to COVID-19 while on parental leave	Lose job due to COVID-19 while on non-parental leave (eg due to caring responsibilities, bolidays)
Unpaid	Eligible for relief payment	Eligible for relief payment
Paid	Ineligible for relief payment while the government is continuing to bay paid parental leave, but can be eligible once government stops paying (ie cannot receive both relief payment and paid parental leave at the same time). If someone transfers paid parental leave to their partner, they are eligible for the relief payment while their partner receives paid parental leave (this is similar to ACC compensation payments).	Eligible for relief payment

This approach kaises some equity issues:

Ti someone oses their job due to COVID-19 at the start of a long period of unband leave, they have likely already planned for a drop in their income so will not be experiencing an income shock similar to those that lose their jobs while not on unpaid leave.

Termination payments do not affect someone's eligibility to the relief payment. Therefore, it could be perceived as unfair that someone is unable to receive paid parental leave at the same time as the relief payment, but could receive a large termination payment and immediately be eligible for the relief payment.

However, this approach has benefits:

- Complex requirements around the length of unpaid leave required to be eligible
 or ineligible would be difficult to administer and potentially confusing for
 potential applicants.
- Paying the relief payment concurrently with paid parental leave would create
 inequities with ACC recipients, and would mean that some people would be
 receiving two forms of relatively generous government assistance that are
 intended for the same purpose.
- The Ministry of Business, Innovation and Employment and Inland Revenue support this approach.
