On 23 October 2020, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- Data on the social housing register broken down by ethnicity at the Territorial Authority (TA) level
- Trends around the number of families needing emergency housing at the TA level

On 3 November 2020, the Ministry contacted you to clarify your request, to which you responded with the following:

- I would like the social housing data from Manawatū District compared to national data for 2015 to 2020?
- I would like quarterly data on the number of families needing emergency housing from 2015 to 2020, also with comparing data from Manawatū District

On 4 November 2020, the Ministry contacted you again, to reclarify your request, and you confirmed that you would be happy to receive the following information:

- Manawatū Territorial Local Authority (TLA) vs. National number of people on the social housing register, broken down by ethnicity for 2015 – current, quarterly.
- Manawatū TLA vs. National number of Emergency Housing Special Needs Grant (EH SNG) for 2017 - current, quarterly.
- Manawatū TLA vs. National number of families four or more that were granted EH SNG for April – current.

When a person makes an application for public housing, their eligibility is assessed on their ability to access suitable, adequate, affordable and sustainable housing. Further details about the criteria for public housing assessments, is available on the Ministry's website at: www.workandincome.govt.nz/map/social-housing/assessment-of-eligibility/introduction.html.

The Ministry understands that demand for housing across New Zealand is growing, and more people are experiencing a severe and immediate need. This demand is generated by a shortage of affordable housing, driving house price and rent growth. People on low incomes are most affected by rising housing costs, and many seek financial help from the Ministry.

Across the government, there is a wider programme of work underway aimed at increasing the supply of public housing and improving housing affordability and supply. The Ministry of Housing and Urban Development (HUD) leads the programme of work on New Zealand's housing and urban development.

This includes planning, and with Kāinga Ora, delivering more public housing, transitional housing, and services to tackle homelessness. HUD is also working to improve housing affordability and supply for aspiring homeowners. The Government Housing Programme Dashboard tracks progress on key parts of the Government's housing programme.

The Ministry's role is to assess eligibility for public housing, provide financial support to eligible people to access and sustain suitable housing, and to provide immediate assistance to meet emergency housing needs.

The EH SNG is available to people who cannot remain in their usual place or residence, if any, and do not have access to other accommodation which is adequate for them or their family's needs. Assistance is generally granted for up to seven nights but can be extended, dependent on individual circumstances.

The Ministry recognises that motels are not a long-term solution. They provide a shorter-term solution while more sustainable options are progressed.

Some people may struggle to access suitable housing due to a lack of available supply or they simply may not be able to meet the high cost of housing which may result in them receiving EH SNG support for an extended period of time.

The year 2020 has seen a significant increase in demand for emergency housing, as the Ministry supported people through the COVID-19 pandemic period with accommodation where they could safely self-isolate. Due to the COVID-19 lockdown restrictions, people also could not easily move out of emergency housing into long-term accommodation which contributed to longer durations of stay and higher costs.

Please note, the Ministry only started capturing information about household composition of EH SNG applicants from 01 April 2020, therefore the Ministry does not have records of household composition in EH SNGs grants prior to this date.

In order to protect client privacy, some values are suppressed and are represented by 'S'. The Ministry is unable to provide you with the exact number as releasing this information is likely to risk identifying the individuals concerned. As such, this information is withheld under section 9(2)(a) of the Act. The need to protect the privacy of these individuals outweighs any public interest in the information.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government
- to increase the ability of the public to participate in the making and administration of our laws and policies
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter available to the wider public. The Ministry will do this by publishing this letter on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.
