On 2 December 2020, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

 Please indicate the number of recipients of the Covid-19 Income Relief Payment who also received Temporary Additional Support (TAS)

The COVID-19 Income Relief Payment (CIRP) was available for 12 weeks from 8 June 2020, for anyone who lost their job due to the impact of COVID-19, since 1 March 2020. It paid \$490 a week to those who lost full-time work and \$250 for part-time. The payment was not taxed. More information on the COVID-19 Income Relief Payment can be found on the Ministry's website here: www.workandincome.govt.nz/covid-19/income-relief-payment/index.html

Temporary Additional Support (TAS) is a non-taxable supplementary payment that can be paid for a maximum of 13 weeks, at which point a re-application is required. It is paid to assist clients with their regular essential living costs that cannot be met from their income and other resources. A client does not need to be receiving a main benefit to qualify for TAS but must meet a cash asset test.

Please see **Table One** in **Appendix A** which shows the number of CIRP recipients as at the end of each month from June to November 2020, broken down by whether or not they were also receiving TAS.

- to increase the ability of the public to participate in the making and administration of our laws and policies
