On 19 October 2019, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982, the following information:

• The number of applications made in 2018 for a business start-up grant and how many were approved.

The Ministry offers three types of self-employment assistance:

- Self-Employment Start-Up a lump sum payment for essential business startup costs
- Flexi-wage Self-Employment an ongoing subsidy to assist the client with financial obstacles while the business is getting established, and
- Business Training and Advice Grant a grant offered to assist clients who are investigating or entering self-employment to cover specific costs.

Please find enclosed a copy of a response to an Official Information Act dated 12 December 2019 regarding the number of approved Flexi-Wage (Self Employment) applications for the period starting 1 January 2018 to the quarter ending 30 September 2019.

This response will focus solely on Business Training and Advice Grant which helps clients to investigate or enter self-employment by meeting the costs of receiving business advice, developing a vetting report and business plan, and undertaking business skills training.

You have requested the number of applications made in 2018 for a business start-up grant. I am unable to provide you with this information as it is held in notes on individual case files. In order to provide you with this information Ministry staff would have to manually review thousands of files. As such I refuse your request under section 18(f) of the Official Information Act. The greater public interest is in the effective and efficient administration of the public service. I have considered whether the Ministry would be able to respond to your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Ministry's ability to undertake its work would still be prejudiced.

In response to your request regarding how many applications were approved in 2018 for a business start-up grant, please find below Table One showing the number of

Business Training and Advice Grant applications/contracts approved from 1 January 2018 to 31 December 2018.

On 4 November 2019, you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

- For 2018 and 2019 how many applications have been lodged for the "Flexi Wage for self-employment" benefit and
- For 2018 and 2019 how many applications have been approved for the "Flexi Wage for self-employment" benefit.

The Flexi-Wage Self-Employment grant is a wage subsidy to help clients overcome financial barriers associated with moving into self-employment. It is expected that in time, the client will be able to fully support themselves from their business. The weekly rate of subsidy is determined by the client's weekly living expenses and the expected cash flow from the business. This subsidy can be given on its own or in conjunction with a Self-Employment Start-up grant which provides a lump sum payment or payments for essential business start-up costs (where a client does not have access to other commercial finance). Both the Flexi-Wage Self-Employment grant and Self-Employment Start-up grant are captured together in central data reporting on Flexi-Wage Self-Employment.

To apply for a Flexi-Wage Self-Employment grant, clients are required to prepare a business plan, and have it independently assessed. Clients often develop an application over time with the support of a Ministry Case Manager and as such, details of their application are held in individual client files. Therefore, your request for the number of applications that have been lodged for the Flexi-Wage Self-Employment grant for 2018 and 2019 is refused under section 18(f) of the Official Information Act as substantial manual collation would be required to locate and prepare all documents within scope of your request and some information is held in notes on individual case files. In order to provide you with this information Ministry staff would have to manually review thousands of files. The greater public interest is in the effective and efficient administration of the public service.

I have considered whether the Ministry would be able to respond to your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Ministry's ability to undertake its work would still be prejudiced.

The Ministry plans to review existing employment products and services to look at whether they are fit for purpose, and easily accessible for clients who use them.

You have requested the number of applications which have been approved for the Flexi-Wage for Self-Employment in 2018 and 2019. The table shows the number of approved Flexi-Wage (Self Employment) applications. The period shown is for the period starting 1 January 2018 to the quarter ending 30 September 2019. Further, please note that the table shows a count of Flexi-Wage Self-Employment grant approvals, not individual clients.
