## Dear

On 17 June 2020, the Office of Hon Carmel Sepuloni transferred your request to the Ministry of Social Development (the Ministry), under the Official Information Act 1982, for a response.

You have requested the following information:

• The extent of financial support offered through Accommodation Supplements since they first began. I would like to know the yearly cost since this initiative began. If you could provide this or refer me onto a resource that displays this information, it would be greatly appreciated.

An Accommodation Supplement is a non-taxable benefit that provides assistance towards a client's accommodation costs. A person does not have to be getting a benefit to qualify for Accommodation Supplement. The Accommodation Supplement was first introduced in 1993.

**Table One** below shows the amounts paid annually by the Ministry for Accommodation Supplements. The data has been broken down by Financial Years.
