## Dear

On 25 August 2020, you wrote to the Minister for Social Development, Hon Carmel Sepuloni, requesting, under the Official Information Act 1982, the following information:

- The number of people receiving NZ Superannuation as at 30 June 2020, in the following age brackets: 65-69, 70-74, 75-79, 80-84, 85-89, and 90 and over
- The number of people receiving NZ Superannuation in the following age brackets: 65-69, 70-74, 75-79, 80-84, 85-89, and 90 and over, as at 30 June for the years 2013, 2014, 2015, 2016 and 2017

On 7 September 2020, your request was transferred from the Minister's Office to the Ministry of Social Development (the Ministry), as this information is of an operational nature.

New Zealand Superannuation (NZS) is one of the few international pension schemes that is given to everyone who meets the residency requirements. The Veteran's Pension (VP) has the same residency and age requirements as NZS but is only available to New Zealand veterans who have recognised service.
