On 16 February 2021, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information about emergency housing in the Wellington region:

- Could I please have a list of every emergency housing accommodation providers who currently have a contract to deliver this service, as at the most recent date possible?
- Can I please have this broken down by area, such as Lower Hutt, Upper Hutt, Porirua, Kapiti, Wellington city and Wellington central city?
- Could I please have the same list, but for the years 2017, 2018, 2019, 2020?
- Could I please have a list of the amount of people in Wellington city currently in emergency housing (as at the most recent date possible)? *not the amount of grants.
- Could I please have a list of the amount of people in Wellington city who received emergency housing grants in 2017, 2018, 2019 and 2020? *not the amount of grants.
- Could I also please have a separate list of emergency housing accommodation providers in the Wellington CBD area?

On 17 February 2021, 25 February 2021 and 4 March 2021, the Ministry contacted you via phone in order to clarify your response.

During this correspondence, the Ministry advised you that the Ministry does not hold contracts with any emergency housing suppliers, or record the locations of accommodation for emergency housing in a reportable way, and that if this information was held, it would be in individual client notes, therefore this part of your request was likely to be refused as it would involve manual collation to gather. Your request for information, was subsequently refined to the following:

- Could I please have a list of registered emergency housing suppliers, that have received a payment from the Ministry for clients whose address is recorded in the Ministry's system as residing in Wellington, as at the most recent date possible?
- Can I please have this broken down by area, such as Lower Hutt, Upper Hutt, Porirua, Kapiti, Wellington city and Wellington central city?
- Could I please have the list, for the years 2017-2020?

- Could I please have the number of people in Wellington city currently in emergency housing (as at the most recent date possible)? *not the amount of grants.
- Could I please have the number of people in Wellington city who received emergency housing grants in 2017, 2018, 2019 and 2020? *not the amount of grants.

As advised to you at the time, due to the clarification of the original request, the 20 working-day time period was reset under section 15(1AB) of the Act.

On 25 March 2021, the Ministry advised you of the need to extend the time available to make a decision on your request to 13 April 2021.

Demand for housing across New Zealand is growing, and more people are experiencing a severe and immediate need. This demand is generated by a shortage of affordable housing driving up house prices and rents. People on low incomes are most affected by rising housing costs and many seek financial help through the Ministry.

The Emergency Housing Special Needs Grant (EH SNG) is available to people who cannot remain in their usual place of residence, if any, and do not have access to other accommodation which is adequate for them or their family's needs. The Ministry pays EH SNGs directly to the accommodation supplier, and assistance is generally granted for up to seven nights but can be extended depending on the individual's circumstances.

After these seven nights, Work and Income arrange another appointment with the client to discuss their housing situation, and whether another grant is required. The Ministry works hard to support people in emergency housing to secure a long-term housing solution, either through public housing or private rental accommodation. Other options, including transitional housing, can also be explored as an option, depending on availability and the individual's circumstances.

The Ministry recognises that motels are not a long-term solution, or the solution that we want to deliver for people who are potentially in a vulnerable situation. More information about EH SNGs is available at the following link:

Some people may struggle to access suitable housing due to a lack of available supply, or they simply may not be able to meet the high cost of housing which may result in them receiving EH SNG support for an extended period of time. As previously mentioned, the Ministry does not hold contracts with emergency housing suppliers.

There has been a growing demand nationally for emergency housing, as the shortage of affordable housing and rising rents continues to impact low-income whānau, particularly those who are beneficiaries. The year 2020 saw a significant increase in demand for emergency housing, as the Ministry supported people through the COVID-19 pandemic period with accommodation where they could safely self-isolate. Due to the COVID-19 lockdown restrictions, people also could not easily move out of

emergency housing into long-term accommodation, which contributed to longer durations of stay and higher costs.

Across government, there is a major programme of work underway aimed at increasing the supply of public housing and improving housing affordability and supply.

Te Tūāpapa Kura Kāinga (The Ministry of Housing and Urban Development/HUD) and Kāinga Ora are responsible for increasing the supply of affordable and public housing. This includes planning, and with Kāinga Ora, delivering more public housing, transitional housing, and services to tackle homelessness. HUD is also working to improve housing affordability and supply for aspiring homeowners.

In regard to your request, the Ministry is supplying the full list of emergency housing suppliers from our records for EH SNGs granted to recipients whose address is recorded in the Ministry's system as residing in specific Territorial Local Authorities (TLAs). To expedite the information release, the Ministry has not investigated any recording anomalies within the data release. Please find the following tables attached to this letter within **Appendix One:**

- **Table One:** A list of registered emergency housing suppliers, that have received at least one payment from the Ministry between 1 January 2017 to 31 December 2020, for grants granted to recipients whose address is recorded in the Ministry's system as residing in the Wellington City TLA.
- **Table Two:** A list of registered emergency housing suppliers, that have received at least one payment from the Ministry between 1 January 2017 to 31 December 2020, for grants granted to recipients whose address is recorded in the Ministry's system as residing in the Lower Hutt City TLA.
- **Table Three:** A list of registered emergency housing suppliers, that have received at least one payment from the Ministry between 1 January 2017 to 31 December 2020, for grants granted to recipients whose address is recorded in the Ministry's system as residing in the Upper Hutt City TLA.
- **Table Four:** A list of registered emergency housing suppliers, that have received at least one payment from the Ministry between 1 January 2017 to 31 December 2020, for grants granted to recipients whose address is recorded in the Ministry's system as residing in the Porirua City TLA.
- Table Five: A list of registered emergency housing suppliers, that have received at least one payment from the Ministry between 1 January 2017 to 31 December 2020, for grants granted to recipients whose address is recorded in the Ministry's system as residing in the Kapiti Coast District TLA.
- **Table Six:** Number of distinct clients who received an EH SNG in Wellington City TLA between 1 October 2020 and 31 December 2020.
- **Table Seven:** Number of distinct clients who received an EH SNG in Wellington City TLA between 1 January 2017 and 31 December 2020, broken down by calendar year.

The lowest geographical boundary the Ministry reports on for clients receiving EH SNGs is TLA. The Ministry records the addresses of recipients at a local level, however, this information is kept on individual client records and is not part of the Ministry's standard reporting. Therefore, I am refusing your request for information regarding Wellington Central City under section 18(f) of the Act. In order to provide you with this information, Ministry staff would have to manually review thousands of files. The greater public interest is in the effective and efficient administration of the public service.

I have considered whether the Ministry would be able to respond to this part of your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Ministry's ability to undertake its work would still be prejudiced.

Regarding the tables provided, please note that the TLA is estimated based on the clients' address at the time of the grant. This TLA may not be the same as the address of the emergency housing supplier. Where the client address is not recorded, the location of the Ministry's service centre case managing the client has been used to approximate which TLA a client resides in. However, as the Ministry has switched to working from national queues, EH SNGs and other hardship grants could be granted by a case manager working anywhere in New Zealand. Therefore, in such cases, the TLA may not reflect the actual client address or location. Due to the transient nature of people receiving EH SNGs, the recorded address for a client may also be that of a trusted family member or friend who receives mail on their behalf.

You will notice that the lists of registered emergency housing suppliers provided include suppliers from outside of the Wellington region. This is likely to be for payments made in arrears for a previous period of accommodation, or payments for a future period. A number of clients may have recently moved, but their address details have not yet been updated.

Please note that the registered supplier name is the name of the parent company of the accommodation supplier, and not necessarily the name of the accommodation itself, for example, New World. One registered supplier may provide accommodation across multiple premises in different locations or trading names, receiving payment through the single supplier record.

Further, reference to I-Sites as suppliers may be reflective of payments in respect of council accommodation. Other suppliers may be listed due to a coding error when a client receives multiple assistance payments at one point in time, for example for petrol or groceries. For example, Caltex Porirua.

Some of the emergency housing suppliers may have received an incorrect payment which has been refunded. For example, in some of the tables, the Ministry of Social Development is listed as receiving payment as a supplier. This is due to an incorrect payment being made to a supplier, and that payment being returned to the Ministry in order to correct this error.

Please note that some of the listed suppliers have only received a small number of payments, or no more than one payment.

Regarding Tables Six and Seven, "distinct clients" refers to clients who have received the emergency housing special needs grant. Most of the time only one person from a

household applies for an EH SNG on behalf of their household. The grant may cover one person or a number of people, including children. Where there are multigenerational households, each client applies for their own EH SNG, even if they are staying in the same accommodation as another extended family member.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public. The Ministry will do this by publishing this letter and attachments on the Ministry of Social Development's website. Your personal details will be deleted, and the Ministry will not publish any information that would identify you as the person who requested the information.

Notes for Tables One to Five:

- TLA is based on the main applicant's residential address as at the time of application, not the location of the supplier.
- One registered supplier may provide accommodation across multiple premises in different locations or trading names, receiving payment through the single supplier record.
- The registered name is the name of the parent company of the accommodation supplier, and not necessarily the name of the accommodation itself.
- The Ministry has supplied the full list of emergency housing suppliers from our centralised records. To expedite the information release, the Ministry has not investigated any recording anomalies within the data release.

- For context, some of these suppliers may have only received a small number of payments, other
 may have received a payment incorrectly and have subsequently been refunded or recoded.
- Although you have asked for clients who have an address based in Wellington, it is possible that a
 non-Wellington based supplier has received a grant in respect of the client. There are a number
 of reasons for this, including a transient client base, timing of the action to change a client's
 address in our systems, or administrative errors not to change the address.
- You may notice that in some of the tables, the Ministry of Social Development is listed as
 receiving payment as a supplier. This is due to an incorrect payment being made to a supplier,
 and that payment being returned to the Ministry in order to correct this error.

Notes for Tables Six and Seven:

- The Ministry uses a count of distinct clients who have had an EH SNG granted, not a number of
 grants. It is a proxy for households, as most of the time, only one person from a household is
 applying for an EH SNG on behalf of their household. Where there are multi-generational
 households, each client must apply for their own EH SNG, even if they are staying in the same
 motel unit as another extended family member.
- The same client may have more than one grant in a given period.
- To protect confidentiality, the Ministry uses processes to make it difficult to identify an individual person or entity from published data. These data tables have had random rounding (to a multiple of three) applied to all cell counts in the table. For example, a value of one or two may be rounded to zero or three. The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals. The published counts will never differ by more than two.
