## Tēnā koe

On 14 May 2021, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- 1. Any internal communications at a senior leadership level (your discretion to define this) that discuss the decision to suspend the processing of data matched files with the IRD when MSD had to divert resources to administer the wage subsidy in 2020 (time frame; 60 days before the date the decision was finalised and 30 days after this date).
- 2. Any representations/official briefings MSD provided to any Government Minister about the decision to suspend the processing of data matched files with the IRD.
- 3. Any documents (in their final form) that identify risks of suspending the processing of data match files with the IRD (time frame; 60 days before the date the decision was finalised and 30 days after this date.

On 14 June 2021, the Ministry emailed you to extend the timeframe for response under section 15(1) and 15A of the Act. You were advised that you would receive a response by no later than 8 July 2021.

The Ministry will answer your questions in turn.

 Any internal communications at a senior leadership level (your discretion to define this) that discuss the decision to suspend the processing of data matched files with the IRD when MSD had to divert resources to administer the wage subsidy in 2020 (time frame; 60 days before the date the decision was finalised and 30 days after this date).

For this part of your request, the Ministry has defined 'Senior Leadership' to be General Manager level and above. As such, please find four emails enclosed in this response.

Employee names below the level of General Manager have been redacted as 'Out of Scope'. Furthermore, emails between staff below General Manager level have also been deemed to be out of scope of your request.

2. Any representations/official briefings MSD provided to any Government Minister about the decision to suspend the processing of data matched files with the IRD.

3. Any documents (in their final form) that identify risks of suspending the processing of data match files with the IRD (time frame; 60 days before the date the decision was finalised and 30 days after this date.
