On 15 January 2021, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- 1. Please list all Government Department Strategy (GDS) Indexes that were archived in 2019/2020, being those that were in operation as at 31 December 2018 (see list attached) but are no longer in operation as at 31 December 2020? Please state the date (e.g., month and year) and the reason the strategy was archived.
- 2. Please list GDSs that were moved to another department in 2019/20, being those that were in operation as at 31 December 2018 but is now being implemented by another government department as at 31 December 2020?
- 3. Please list all new GDSs (published in 2019/2020) (being those that are not on the list as at 31 December 2018)?
- 4. Please list all new GDS (published in 2019/2020) that have also been archived in 2019/20? I expect there will not be many of these.

The Ministry does not have its own definition of what comes under a GDS. Therefore, in line with the response provided to you in December 2018, this response reflects the definition that you provided in your request: 'Key documents that drive public policy and reflect a significant investment and commitment by public officials and Members of Parliament'.

Please note that strategies published by other government agencies which would fall under your definition of a GDS are of relevance to the Ministry and at times would have been co-created or created with input e.g. with engagement from the Ministry. However, as these strategies are governed by other departments, they are not included in this response.

I will now respond to your questions in turn.

1. Please list all Government Department Strategy (GDS) Indexes that were archived in 2019/2020, being those that were in operation as at 31 December 2018 (see list attached) but are no longer in operation as at 31 December 2020? Please state the date (e.g., month and year) and the reason the strategy was archived.

The Ministry does not go through a formal process of 'archiving' documents that would potentially fall under the McGuinness Institute's definition of a 'GDS'. Table One below,

however, lists documents which are considered to meet your definition of being a GDS and are no longer in use, i.e. they have been 'concluded'.

The Ministry does not believe it has any documents that fall under the McGuinness Institute's definition of a 'GDS' and meet the criteria requested.

It may, however, be relevant to note that a number of documents which meet the McGuinness Institutes definition of a GDS operate through departments administered by the Ministry, e.g. the Office for Seniors, or span across the departments of other government agencies and organisations, e.g. the Ministry of Health.
