On 1 February 2021, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- 1. I request the number of requests received by Work and Income for financial assistance for school uniforms and stationery each month since 2014.
 - a) The number of requests approved, and the number of requests denied each month.
 - b) The average value of the loans approved.
- 2. I request all reports, briefings, aide-memoire, etc, provided to the Minister for Social Development relating to financial assistance for school uniforms and stationery since 26th October 2017.

On 2 March 2021, the timeframe of your request was extended to 25 March 2021 in accordance with section 15(1) and 15(A) of the Act. This extension was to allow the time for consultations necessary to make a decision on the request to be undertaken.

A client requiring assistance for school uniforms and stationery may be eligible to receive a Recoverable Assistance Payment (RAP) or an Advance Payment of their benefit (an Advance).

RAPs are non-taxable, interest free, recoverable financial assistance to meet essential and immediate needs to non-beneficiaries for specific items or services. If a client meets all qualifications, including meeting an income and asset test and having an immediate and essential need, a RAP can be made to assist with the cost of essential school stationery, generally up to \$200 per child. A RAP can also be made to purchase school uniforms, generally up to \$300 per child.

All clients receiving a main benefit have access to an Advance of up to six weeks of their net benefit entitlement. If a client meets all qualifications, including meeting an income and asset test and having an immediate an essential need, an Advance can be made to assist with generally up to \$200 of school stationery costs and \$300 of school uniform costs.

Please note that all of these grants are recoverable. The arrangement for the repayment of these grants depends on the individual's circumstances. The Ministry works with clients to determine repayment amounts with a view to not place individuals and families in further hardship.

In terms of the second part of your request, the Ministry has undertaken a search for all reports, briefings and aide-memoire provided to the Minister for Social Development and Employment relating to financial assistance for school uniforms and stationery since 26 October 2017. No documents were located which specifically relate to financial assistance for school uniforms and stationery. Therefore, this part of your request is refused under section 18(e) of the Act, that the documents alleged to contain the information requested does not exist, or despite reasonable efforts to locate it, cannot be found.

Please note that in addition to financial support in relation to school uniforms and stationary costs, the Ministry provides a recoverable grant for School Costs. This grant relates to funding for costs such as school donations, computing equipment, attendance dues, and school camps and trips. Notes for Table One:

- Number of grants is the sum of Advances on Benefit (ADV) and Recoverable Assistance Payments (RAP).
- ADV is a recoverable payment available to people receiving a main benefit (e.g., Jobseeker Support, Sole Parent Support, Supported Living Payment) who require assistance to meet a particular immediate need for an essential item, such as a tenancy bond. Clients accessing this type of assistance can receive an advance of up to six weeks of their net benefit entitlement
- RAP provides non-taxable, interest-free, recoverable financial assistance to non-beneficiaries to meet an essential immediate need for specific items or services, such as a tenancy bond. It is only available to people who meet an income and asset test and is paid up to a maximum amount of six weeks of the rate of the Supported Living Payment

- Amounts are provided to the nearest whole dollar
- This is a count of grants, and not a count of clients
- A client may have received more than one grant in any time period
- This is the amount granted, and not the amount spent
- In certain circumstances low numbers may potentially lead to individuals being identified. To protect confidentiality the Ministry of Social Development uses processes to make it difficult to identify an individual person or entity from published data. Therefore, this data table has had random rounding to base three applied to all cell counts in the table.
- A value of one or two may be rounded to zero or three.
- The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals.
- The published counts will never differ by more than two counts.
