On 10 March 2021, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- Information pertaining to the amount of funds paid by your Agency / Organisation / Department / Ministry directly to victims of the March 15, 2019 terror attacks on the two Christchurch Mosques.
- This request relates to payments made from 15 March 2019 to 31 December 2020.

The Ministry offers a range of support to qualifying clients, in the form of main benefits (e.g. Jobseeker Support, Sole Parent Support), New Zealand Superannuation, and supplementary assistance (e.g. Accommodation Supplement, Disability Allowance). However, to support victims of the Christchurch mosques attack of 15 March 2019 who did or do not qualify for a main benefit, the Ministry introduced Christchurch Mosque Attack Assistance.

Paid under the Christchurch Mosques Attack Welfare Programme, and available until 4 June 2021, Christchurch Mosque Attack Assistance enables clients who have been affected by the 15 March 2019 attacks to apply for the following types of payment:

- Emergency Benefit special assistance,
- Temporary Additional Support special assistance,
- Family Tax Credit special assistance,
- Best Start Tax Credit special assistance, and
- Winter Energy Payment special assistance.

To qualify for one or more of the above assistance types, a client must meet the pre-existing qualifications relating to each (e.g., meet the criteria for Emergency Benefit if applying for Emergency Benefit special assistance), except that the usual residency criteria (for all) and cash asset test (in the case of Emergency Benefit) does not apply. Clients must then meet the following additional criteria:

- be an affected person (present during the attack, relation of someone injured, or killed),
- not qualify for a benefit under the Social Security Act 2018, and
- be unable to earn income to support themselves and any dependent family.

Notes:

- Figures are approximate, as they do not take into account any retrospective reviews of payments that may have occurred.
- The dollar amounts have been rounded and therefore the cells may not sum up to the total value.

As already indicated, some victims of the 15 March 2019 mosques attack received support from the Ministry under the Social Security Act 2018 (rather than the Christchurch Mosques Attack Assistance Welfare Programme). However, we cannot provide you with the full amount that has been paid to victims under every programme and payment type offered by the Ministry. To do so would involve reviewing thousands of files to determine which clients were affected by the attack. This aspect of your request therefore is refused under section 18(f) of the Act on the ground that it requires substantial manual collation.

I have considered whether the Ministry would be able to respond to your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Ministry's ability to undertake its work would still be prejudiced.

That said, some victims in receipt of Christchurch Mosques Attack Assistance received additional assistance in the form of Special Needs Grants and Recoverable Assistance Payments, and information relating to these payments is centrally recorded by the Ministry. A Special Needs Grant provides non-taxable, one-off recoverable or non-recoverable financial assistance to clients to meet an immediate need. A Recoverable Assistance Payment, on the other hand, provides non-taxable, interest-free, recoverable financial assistance to non-beneficiaries to meet an essential, immediate need for specific items or services.

Please find **Table Two** enclosed in **Appendix A** attached, which shows the amount of Special Needs Grants and Recoverable Assistance Payments granted to Christchurch Mosque Attack Welfare Programme recipients between 1 June 2019 to 31 December 2020.

It is also worth noting that the Ministry assisted victims of the attack in other ways too, such as by paying for driver licenses and funding for immigration advisors. As these payments did not go directly to clients, however, the Ministry has not included information pertaining to that support in this response. The Ministry has interpreted your request to be only for assistance that has been paid *directly* by the Ministry to the victims of the attacks.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- · to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter available to the wider public. The Ministry will do this by publishing this letter on the Ministry of Social Development's website. Your personal details will be deleted, and the Ministry will not publish any information that would identify you as the person who requested the information.
