- Encouragement to get towards option development to get costings for this as soon as possible, fiscally neutral options will need a bit of iteration, seems on the right track, concrete options priority
  - High-level options will be considered at the next Governance Group meeting
- Note that the project plan spreadsheet proposes to do WFF and AS separately and then bring them together.

- Phasing of the reports leads you to believe the third (combined) report brings the answer – need to signal that there will not be many options that span both WFF and AS in earlier advice to avoid this perception.
- Comments on timeframes and Child Support Pass-on from *Item 3* can fit nicely in the outline.

#### Item 6: Discuss and provide feedback on the draft Accommodation Supplement report and appendices

- Alana (Employment and Housing Policy) provided modelling from TAWA demonstrating the overlap between AS and WFF population:
  - 115,000 families receiving both 62% are sole parent families, 38% are couple with children family
  - AS largely single beneficiaries or couples without children so potentially intersect less with WFF than you think.
- Can you look at targeting within the instrument better?
- s 9(2)(f)(iv)

- s 9(2)(g)(i)
- AS is an income support lever and a housing support lever.
- s 9(2)(g)(i)
- Paper comes across as looking at AS individually rather than in combination with

  WFF
  - Need to position AS work to link to WFF work
- Re-frame AS report to capture the above points, bring back to next Governance Group meeting

#### **Consultation and Engagement**

- Minister Sepuloni lead Minister for the WFF + AS Review so MSD to be first point of contact.
- Need engagement plan that is more proactive suggestion towards targeted engagement.

- Next WFF advice will confirm a consultation and engagement approach with Ministers.

#### Item 3: Feedback on AS report and appendices

- Alana (Housing Policy) gave an overview of some of the changes since the last meeting.
- General comments were that the report is looking good
- Note that Ministers are getting questions on what the review will look like with no advice on it yet so this will be a good start and needs to go to Ministers soon.
- One of the key objectives of this paper is to get Ministers to confirm that they want to look at AS in a fiscally neutral review of Working for Families.
- Recommendations generally good but expecting a lot of feedback from Ministers.
  - Suggest changing recommendations 4 and 5 to guide Ministers by saying "officials recommend..."
  - o May want to re-order the recommendations.
- Concerns about paragraph 74 wording.
  - Para 71 contains the critical context for Ministers, so para 74 can be removed.
  - Take paragraph 74 out.
- Shift recommendations on objectives before recommendations on the fiscally neutral envelope.
- Make Child Poverty reduction targets more prominent in the paper.
- AS advice sign out joint advice?
  - DPMC happy either way.
  - AP TSY to get back to MSD before decision finalised.
- The above comments will be incorporated in the final AS report to Ministers.

#### Item 4: Feedback on options to model for further advice on WFF

- All the options are essentially changing 5-6 key parameters.
- Try not to get too focused on the individual options yet, s = 9(2)(f)(iv)
- Careful to provide options that could or could not be fiscally neutral, by modelling options that cost and save both separately and together.
- Careful to clearly signal that the options in this paper will not show the overall impacts of these changes if they were funded from savings elsewhere – this will come in subsequent advice.
- Is there space to put more options into the paper? Note TSY has some new ideas.
  - Yes, space for more options (if done quickly), encouraged to align clearly with objectives.
- s 9(2)(f)(iv)
- Note impacts of advice on the interim child poverty reduction targets to be considered by Cabinet in June.
  - This advice will need to consider options that could contribute to the achievement of these targets, which would need to be implemented (for full impact) in July 2022.
  - Constraints on what can be implemented by July 2022.
- Note there is now pressure on engagement following recent announcements:
  - Treasury keen to engage with stakeholders.
  - AP MSD will have an initial discussion with Minister Sepuloni next week.

# Item 1: Oral update on the plan for the Income Support Ministers' meeting on 29 June

- The focus of the meeting is for Ministers to have broader discussion on what they
  want for the Accommodation Supplement (AS) as part of the Working for Families
  (WFF) review.
- Busy agenda for 30mins when the purpose is to get some good direction on AS.
- Hoping to get another meeting scheduled for by the middle of August after the next WFF paper (due end of July). We would be supportive of regular meetings potentially until the calendar year end so that we can put some of the items off.
  - AP DPMC and MSD to discuss this with Ministers' offices

# Item 2: Discuss and provide feedback on the draft report on public engagement for the WFF/AS review

- The Minister for Social Development is more inclined towards targeted engagement with key stakeholders and experts rather than public engagement. She also wants to have a group of experts we specifically engage with. This could be through face-to-face meetings or potentially some workshops.
  - MSD considers that targeted consultation is the most appropriate approach given timeframes.
  - DPMC supports targeted consultation with key stakeholders given that we could not respond well in the timeframes to broader consultation. DPMC also wants to make sure the target is not too small.


- IR's views were generally discussed via email prior to this meeting. IR
  considers public consultation best practice, and is also important as there
  could be current issues with WFF that targeted consultation alone fails to
  identify.
- TSY notes that proper public consultation is a huge process but is worried about only talking to select people through targeted consultation (some similar concerns to IR).
  - Suggests a hybrid consultation model targeted well facilitated workshops and written submissions, being clear what will be done with this information.
  - Treasury noted that we could consider the Minister of Finance's Challenge Model – have the people who 'don't like it' come in and consult.
- We will need to make sure the group of experts has a wide range/definition of expert to capture broader views.
- It is important to remember other engagement going on at the same time such as Purpose and Principles work and Social Unemployment Insurance.
- Generally concerned about engagement advice and resourcing.
  - Pull out the pros and cons of consultation options for Ministers and indicate to Ministers if we don't think we can achieve it within the timeframes.

Feedback will be incorporated into the engagement paper due this week.

# Item 3: Discuss and provide feedback on the content of the detailed outline of the next WFF paper

- DRMC (Jason) Looking really good!
  - Where is the cost modelling up to?
    - TAWA starting modelling but very busy but should start getting results in the next couple weeks.
- TSY worried it will be a very long paper suggests slide pack
  - Could be tricky for Ministers to navigate what decisions do you need from Ministers to keep the work going?
  - DPMC notes that the last paper was good and very well received by Ministers even though it was long because it stepped the Ministers through the choices.
- The status-quo appendix will give Ministers a good picture of how the current system works, eg moving from benefit to work.
  - MSD happy to work with TSY on the status-quo appendix.
- DPMC The paper lists options that might be good to think about but may be slightly out of scope / better to think about longer term
  - IR keen for Ministers to consider operational issues. These may be future options to think about that we can note.
- DPMC likes the focus on the two-tiered abatement.

#### Feedback will be incorporated into the WFF options paper due in July.

# Item 1: A summary of the Income Support Ministers' meeting on 29 June and next steps.

No final minute from the meeting

#### - AP - Jason to go back and request

- Ministers want to know what could be done within existing parameters and will then consider whether other non-fiscally neutral options should be considered.
- Ministers don't want engagement to delay the Working for Families (WFF) review, so they are happy with targeted consultation and limited public consultation.
- Accommodation Supplement (AS)
  - Ministers want "two tracks" of advice on AS a shorter-term track of advice on AS as an income support tool and a longer-term track of advice on how AS works as a housing intervention. The longer-term track will need to be led by HUD and also involve Treasury.
    - AP MSD Housing Policy and HUD to meet to discuss the advice on AS as a housing intervention.

#### Next steps:

- We are going back to Ministers with more detail on the approach to public and targeted engagement. Timeframes for engagement are tight, especially as we want to ensure consultation material is accessible. We are also looking for a Project Manager for this process.
  - AP If other agencies have someone for this role please let MSD know.
- Further advice was commissioned by Ministers on Child Support as income in the benefit system.
  - Treasury is concerned that agencies will invest time/resources and it will not be funded.
  - The Minister of Revenue requested this advice.
- The Minister of Education and Minister for Social Development and Employment met to discuss Childcare Assistance on 28 June 2021.
- Further advice was commissioned by Ministers clarifying the scope and timeframes of the AS review.
- s 9(2)(f)(iv)
- AP Jason to confirm when the next Ministers meeting will be.
  - The group agreed that an hour meeting would be better.

# Item 2: Discuss and provide feedback on initial WFF modelling results – options with increases to the Family Tax Credit and changes to abatement

- The next WFF advice to Ministers will clearly describe the trade-offs between fiscal cost and child poverty reductions.
- The modelling shows Ministers we can't make a significant improvement to child poverty without some families being significantly financially disadvantaged within a fiscally neutral envelope.
  - Ministers will be focused on the households that face losses.
  - Distributional analysis of those who would be worse off would be useful.
  - Suggest having a cheat-sheet table showing the levers (eg abatement threshold, abatement rate, payment rate) and the types of impacts they have.
- The next WFF paper needs to also explain that for Budget 2022 agencies can only feasibly make changes to rates and abatement settings, but any changes made will have a big impact on further work in the reform.

- Suggested potential next steps for modelling:
  - s 9(2)(f)(iv)
- Treasury noted that meeting the interim child poverty targets is likely to be a

significant part of the review. Feedback will be incorporated into the next WFF paper and the next stage of modelling.

#### Item 1: Confirm the minutes from the 6 July meeting

- No comments on the minutes.
- The next Income Support Ministers meeting is scheduled for Wednesday 11
   August 2021. The items for discussion have not been confirmed but are likely to be:
  - the next Working for Families (WFF) report
  - the report back on the Accommodation Supplement (AS) scope and timing
  - s 9(2)(f)(iv)
  - advice on the treatment of Child Support pass-on as income, and the appetite for this to progress.

# Item 2: Discuss and provide feedback on the draft joint Working for Families paper for Ministers

- The structure of the paper works well.
- The group discussed the operational section being tightened/cut back and that the group had previously agreed that some of this work could be pushed into the next paper.
- Although *Table 8* was found to be confusing it was noted that the table is being updated to make it easier to follow.
- There was general discussion about what the recommendations will look like and some members struggled to see how the paper would all come together.

- Treasury noted that presenting objectives is helpful, but heavily theory based. Looking at different hypothetical options packages could be useful for Minsters to see, especially if we want them to consider the challenges of a fiscally neutral envelope.
- The paper needs to get a clear steer from Ministers on further options and the fiscal envelope.
- There was discussion on whether 'child poverty reduction' was an explicit objective of the WFF review.
  - The Ministry of Social Development (MSD) and the Treasury noted that 'income adequacy' and 'support for low-income families' are significant aspects of child poverty reduction. The WFF review is also the primary lever for the Government to achieve child poverty targets.
  - This WFF paper is seen as a way to drive discussion on the choices
     Ministers have. It was broadly agreed that the paper pulled out the child
     poverty trade-offs clearly and there was no need for a separate
     recommendation to confirm child poverty targets as an objective.
  - A graphic showing the trade-offs for Ministers was suggested as an appendix.
- MSD suggested that Objective 3 could be presented as a natural follow-up of options/advice focused on working people.
- The paper needs to make sure the options are clearly understood as illustrative only.
- There was also a brief discussion on the child poverty targets \$ 9(2)(g)(i)

  The balance of risks of meeting these targets should be noted in the discussion of options, and the role of the broader economy and labour market in helping to achieve targets.
- The group agreed to try push the due date to 5 August, as Ministers won't discuss it until their meeting on 11 August.
  - \AP MSD to consult our Minister's office on changing the deadline.
- The WFF paper will likely be recirculated before it goes to Ministers for the Governance Group to review the recommendations.

#### Feedback will be incorporated into the WFF paper.

#### Item 3: Discuss and provide feedback on the draft engagement paper

- Members of the group suggested making the questions more specific and structured, but broadly the questions were thought to be fine. The group generally agreed on an open-ended approach for questions to the public, so as not to guide their answers to a certain response.
- In light of further direction from Ministers on the AS review, we will need to revisit the AS questions.
- The Treasury wondered if we could go to experts with packages if we land these in the next report.
- There was discussion on how we could ensure the broader views of the public would be captured. MSD noted that work on a comms plan is underway to ensure

we capture the voices of WFF recipients. It was noted that MSD and IR could use existing channels and relationships to push engagement.

Feedback will be incorporated into the engagement paper which is due by the end of the week.

#### Item 1: Confirm the minutes from the 20 July meeting

No comments on the minutes.

# Item 2: Discuss and provide feedback on the joint Working for Families paper

- Members agreed the paper was looking good.
- DPMC noted that the *Objective 1* options are helpful and speak to what we can and can't do with redistribution. DPMC suggested editing the executive summary to let the numbers speak for themselves.
- Members discussed the more conceptual nature of the *Objective 2* write-ups due to a lack of costings. It was noted that paragraph 45 makes a strong statement in the absence of costings.
  - MSD noted that modelling and resources are limited. Members suggested that this be stated in the paper.
- Treasury noted that it is important to be specific in the recommendations and that these could be shorter and blunter.
  - AP TSY to provide specific feedback on recommendations via email.
- The group generally had concerns about what will be used for the Income Support Ministers' meeting (Wednesday 11 August) to navigate the content. Treasury had pulled together a high-level table with the objectives and the levers Ministers have to pull to focus their discussion.


- AP TSY to email the table to the group for review.
- Treasury also suggested more clearly stating that indexation will happen anyway in 2022 as the CPI likely to reach 5 percent.
- Inland Revenue was happy that the feedback from the last meeting had been incorporated and had no further comments.
- Members thought it was important to point out s 9(2)(f)(iv)
   and that a \$14 per week increase in the Family
   Tax Credit does not fully reach child poverty targets.
  - Treasury noted that further modelling is being done as economic forecasts are improving, and therefore, there may be fewer children in poverty.

Feedback will be incorporated into the Working for Families paper due on Thursday 5 August.

# Item 3: Discuss and provide feedback on the Accommodation Supplement paper

- The group had some questions about the work on the Accommodation Supplement (AS):
  - Which groups would benefit from the different options as Ministers may not want to make those trade-offs?
  - Some options require significant funding.
  - Options 4 and 5 give the impression that there are ready savings when there are unlikely to be.
- Is there a way to remind Ministers of the proportion of recipients receiving main benefits who are on the pathway to homeownership?
- The group suggested using data/modelling to illustrate the impact of increasing housing supply on rents and the magnitude of potential AS savings, after the current modelling request is completed. An example of responsiveness to housing supply could be the Christchurch housing data. The group agreed that the paper should be clear on when we will have more cost/data modelling.
- The group thought the paper should focus more on the questions Ministers had from the last Income Support Minsters' meeting (Thursday 29 June).
- Members discussed including greater detail on the housing supply timeframes and reordering the paper with housing supply content first.
- The group broadly had questions about after-housing-cost incomes and how rents are changing relative to incomes.
  - Auckland rents are growing slowly, while the rest of the North Island's rents are surging.
  - There is a large group of low-income people with high rents, particularly evident for single people.
    - We have data that brings this information together for MSD's clients but not beyond.

#### Item 1: Confirm the minutes from the 3 August meeting

MSD

No comments on the minutes.

#### Item 2: Update on next steps (given current circumstances)

- Ministers are currently very busy with COVID-related work. The group agreed to
  proceed with the WFF advice assuming that feedback from Ministers on the advice
  provided before lockdown will continue to be delayed.
- Treasury noted that work has been commissioned on the COVID-19 response for vulnerable people and that this work should include a reference to Working for Families (WFF) decisions.
- The Ministry of Housing and Urban Development (HUD) gave an update of advice they are working on. Advice on the affordable housing fund, looking at how to increase supply for people on low to moderate incomes, will likely be provided to the Minister of Housing in September. This paper has quite a bit of overlap with the advice Ministers were seeking for the Accommodation Supplement (AS). HUD suggested pushing the AS advice out to October until feedback has come back on the affordable housing fund paper.
- HUD also noted that they have done previous work on capitalising AS which showed that it doesn't work. The group noted that the report will need to step Ministers through this.

- Members of the group indicated that the Minister of Housing's Office will need to manage timeframes with the Prime Minister's Office.
- The working group envisions subsequent WFF advice to be on two tracks: short-term modest cost-redistribution options for Budget 2022, and longer-term advice on potentially fundamental changes to the structure and design of WFF.

#### **Timeframes**

- Inland Revenue (IR) have advised to meet implementation timeframes they need
  Cabinet agreement to a second abatement threshold by the end of September.
  This is due to the system changes required and IR's annual calculation of WFF
  entitlements. This means that advice would need to go in one and a half weeks to
  meet these timeframes.
- The condensed timeframe raised the question of whether this would rule out abatement changes as an option. Testing with Ministers whether they want this advice was suggested, keeping in mind timeframes may be too tight for this.
- Members questioned the nature of the agreement sought and whether this
  necessarily had to be Cabinet agreement or could it go through the Social
  Wellbeing Committee (SWC) or Income Support Ministers. It was noted that this
  approach is not unprecedented.
  - IR clarified that agreement is needed to introduce a second abatement threshold, not the actual threshold value.

  - IR indicated that system staff capacity constraints were also playing into the deadlines.
  - AP Kerryn (IR) to email the Governance Group in the next few days outlining the below information:
    - Justification for the deadlines and whether we need Cabinet agreement on this or if SWC or Income Support Ministers will suffice.
    - Implications of getting agreement after the September deadline.
- The group noted that the working group is already progressing advice for Ministers if the end of September date is confirmed. Indicative costings for this will hopefully be completed in the next few days.

Item 1: Confirm the minutes from the 3 August meeting

• The Accommodation Supplement (AS) discussion at the bottom of page 1 should say that advice will look at how to make capitalisation options work and include concrete options for implementation.

# Item 2: Provide feedback on the draft advice on options for Budget 2022 for implementation on 1 April 2022

- The group broadly agreed the paper looks good.
- Treasury noted the paper seeks a lot of indication from Ministers and there is a question of how much we want to guide Ministers' decisions. Decision ordering in the paper is also important.
- The group noted two important points in the paper that should be highlighted. First, the report implies that we can achieve what Ministers are looking for with a single abatement threshold. Second, there are fewer losers if the thresholds are adjusted by the Consumer Price Index (CPI).
- The group discussed whether Ministers had requested an option that looks at the existing system but redistributes the scheduled CPI indexation amount (roughly \$190m) to lower income households.
  - s 9(2)(g)(i)
  - Members suggested that looking at Table 1, the fundamental modelling for this option may not be very different to what we have in the current option.

- The group noted the report needs to clearly indicate a shift in the consultation timeframes to mitigate public expectation for consultation.
- Inland Revenue (IR) indicated that if Ministers want to delay indexation, this will require legislation which needs to be done before December.
- IR also suggested strengthening a point on the two-tiered abatement option. That
  is, to address work incentives a phase two is necessary and we will need to spend
  quite a lot of money.
- Treasury questioned if there is a strong case for two-tiered abatement. Treasury
  noted they will be speaking to the Minister of Finance about the paper on Monday
  21 September.
- The group broadly agreed the paper should be clearer on what can be achieved with the existing abatement settings.

Feedback will be incorporated into the report due on Friday 17 September.

# Item 3: Note draft Working for Families work programme – will be substantively discussed at a future meeting

- The group noted the new work programme arose out of Ministers' decision to introduce a two-track approach.
- Treasury, the Ministry of Social Development and IR expressed resourcing concerns.
  - Specifically, IR noted they are managing from a policy perspective but may start to struggle if further work is added. IR have already indicated operational concerns.
  - The Department of the Prime Minister and Cabinet (DPMC) also noted that the *Debt* work may call on similar resources.

#### Item 1: Confirm the minutes from the 15 September meeting

#### Item 2: De-brief on Income Support Ministers' meeting on 22/09

- PMO read out from the Ministers' meeting.
- Confirmed Best Start was not discussed at the Ministers' meeting.
- Officials have gone back to Offices on timeframes for the next report, as decisions are not needed as urgently – have asked for another week.

#### Item 3: Next advice on B22 options - high-level plan

- \ The group talked through a summary table of options, tabled at the meeting.
- DPMC asked how the options in the table were selected. It was clarified that these were the options that met Ministers objectives (cost, child poverty impacts, minimise losers) and agreed this would be noted in the paper, including why other options weren't included.
- The group liked the table for presenting the options to Ministers.
- The group had a discussion on whether the option to increase the abatement threshold to \$45,200 should be included:
  - Treasury asked if we had put this up before, and it was clarified it was in the previous report
  - s 9(2)(g)(i)

- The group generally agreed the option may have been recommended in other contexts, but given the parameters for this advice it doesn't fit
- Group agreed to not include it.
- Brief discussion on EMTRs, and it was agreed to pull this out more in the next advice, perhaps through example families.
- The group noted the timeframes for decisions by late October, and that an announcement date for any FTC changes should be added in.



 The group discussed passing on any FTC increase to OB/UCB/FCA and agreed it should be in the paper. They noted there are mixed arguments for and against, and these should be put to Ministers.

#### Item 4: Next steps on phase two: Plan for development

- DPMC thinks the plan looks good and likes the integrated work plan across agencies. It would be good to communicate a summary of this to Ministers at a high level. IR and MSD agreed.
- The group discussed the administrative options IR are exploring to improve client experience and would like to see a short summary of what these are in the form of an outline with a timeline at a GG (not urgent). IR will provide this.
- DPMC noted the plan needs to be updated due to Tim moving into Director role.

#### Item 5: How we work together

- The Chair raised an additional item, not on the agenda, on how agencies work together.
- The Chair noted at least one agency briefed their Minister differently to the joint advice and that it would be good to share this advice with others. Generally, we want to try get agency views to feed into the main paper, rather than Ministers having different advice and as a matter of practice it would be good to share advice with other agencies.

- DMPC agreed agencies can brief Ministers, but if it is counter to the joint advice it should put in front on the group to work through and that Ministers should have visibility of different views.
- There was discussion of penholders getting late feedback, and the pressure this
  was placing on them. It was noted that sometimes late comments are unavoidable,
  but wherever possible feedback needs to come earlier and focus on substantive
  issues.
- Treasury raised they were unhappy with the recs last time, and focused feedback on these to improve the flow. It was generally noted that the recs had been circulated earlier and early feedback should be prioritized to avoid placing the penholder under pressure.
- Agencies agreed to share briefings they provide to their Minister, with the working group and governance group, while noting the Treasury has Budget obligations meaning this is not always possible.
- IR will direct their briefings to be shared in future and will share the most recent advice provided to their Minister ahead of the meeting on 22 September.

#### **Item 1: Engagement**

#### **Timing**

- Timing is April/May 2022.
- Ministers previously for submissions to be open for 8 weeks. Realistically, MSD can get this live on 20 April for 6 weeks, with email submissions/survey closing at the end of May. Group is happy with this.

- Group acknowledged the risk that the survey may not get us all the information we want, but it is worth trying anyway.

#### Targeted engagement

- Noted some cross-over with stakeholders engaging on WFF as well as other initiatives - the New Zealand Income Insurance Scheme engagement has only 6 days of cross-over.
- Targeted engagement can deliberately ensure stakeholders involved in a crossover period are not approached during that time.
- Group noted the importance of managing expectations, particularly in the current inflation environment – recognise the need to ensure our engagement is done with integrity and being upfront about limitations.

#### Item 1: First 1000 days

Nicholas Fitzpatrick

Ministers have asked us to look at adding a first 1000 days' objective to the Working for Families (WFF) Review. A memo was provided to the Governance Group to discuss.

- There seems to be general alignment between agencies on the approach,
- If we added an objective, we would need to go back to them to get a steer from Ministers relatively soon on trade-offs. The group is not sure we are in a position to determine the steer from Ministers until later.
- IRD are also concerned about scope creep.
- WFF investments over recent years have contributed to the first 1000 days of a child's life. The group agreed that WFF is inherently contributing to the 'first 1000 days' and are not sure we need to change the objectives. Instead, officials could apply a 'first 1000 days' lens to options analysis, ie provide advice throughout options development/modelling specifically around the first 1000 days of a child's life.
- The group briefly discussed whether reducing child poverty is a current objective of the WFF Review. This has been discussed in previous Governance Group meetings, the issue being that this is an objective of the WFF Policy, but not in the focus areas for the review. The group agreed that this is effectively the same thing and that the 'first 1000 days' is encompassed in the 'child poverty' objective.

Going forward, the group **agreed to recommend to Ministers that a 'first 1000 days' objective does not need to be included**, but to have explicit analysis around the early years with a 'first 1000 days' lens applied. This is a lens we expect to bring in the work we are doing given the objectives. As part of the further modelling work, we will work to indicate to Ministers the trade-offs of these options.

Members noted the time that the working group needed to commit to resolving this issue via the Governance Group and were concerned that it might have been a distraction, given how much other work is needed on the review. The group discussed this further below.

#### Other business:

Update on the current work and timing:

- Report 0 and report 1 are to be discussed at the Income Support Ministers' meeting, currently scheduled for 12 April. These reports are planned to be sent 3 weeks apart. Officials considered combining these two reports, however the Minister for Social Development and Employment's office have confirmed that they would like report 0 earlier. The benefit of report 0 is that it has a table with timing of advice so that Ministers know what to expect.
- Officials are currently working on report 1 this report includes problems as understood by officials and seeks to confirm the three workstreams with an indication of types of options (suggested that we could talk about first 1000 days options here if preferred but the group agreed Report 0 was appropriate). Following this, we will be looking at what options we want to model in May. s 9(2)(f)(iv)

The group agreed to provide comments on Report 0 and confirm minutes of previous meetings via email.

Shared problem definition across agencies:

To what extent do agencies have a consistent view of the problems with WFF or is it shaping to be a contest of ideas?

Agencies have a relatively shared understanding of the tension points/issues with WFF, but we have different ideas about what the most important ones to focus on are (and the solutions that we should implement).

#### Item 2: Update on progress of public and targeted engagement

#### Public engagement:

- Public engagement went live 20 April. So far, we have had 450 survey responses and 15 email submissions.
- Reponses generally noted that Working for Families (WFF) doesn't pay enough but it is a consideration when making decisions around work (particularly the In-work Tax Credit) and people like the Best Start Tax Credit. There have also been varied responses on debt.

#### Targeted engagement:

- 40 stakeholders have been contacted. Five sessions have been booked so far.
- There will be up to 20 sessions with a mixture of group and individual sessions, including 10 Māori engagement sessions, which will be in the second half of May. Policy experts and note takers from Inland Revenue (IRD) and the Ministry of Social Development (MSD), as well as facilitators will attend each session. The bulk of the engagement will be done in May, with two weeks in June as backup.

#### Item 4: Upcoming report - key messages and options

#### Modelling and timing:

- Modelling capacity across agencies is constrained so the working group will draw on previous modelling. The remaining modelling required is complex and unable to be provided until the end of May at the earliest. Therefore, the timing of the upcoming report has been pushed to June (likely late-June).
- The working group's focus next week is the prioritisation of modelling, generally thinking that more complex/new options will be prioritised.
- The group noted that we could recommend that the next Income Support Ministers' meeting be in July so that Childcare advice and engagement results are likely to be in.
- MSD is also working to improve project management internally, to flow on to more timely presentation of reports, and will provide updates as needed.

Options and report contents:

- The group acknowledged the current list of options is extensive and further prioritisation is expected, so it is too early to indicate agency preferences.
- The report will include options that we have been asked to explore and indicate other options to Ministers based on what direction Ministers want to go.
- Major themes and feedback from targeted engagement can be incorporated generally into the reports as we go. The engagement findings report may be ready in time for Income Support Ministers meeting, depending on when that is scheduled for.
- The report will have a problem and evidence section that will cover whether WFF is fit for purpose and how well the WFF system meets its objectives.
