On 30 May 2022, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- Under the Official Information Act 1982 I request all information held by the Ministry in relation to policy analysis and advice in regard to policy issues relating to and leading up to the introduction of the Oversight of the Oranga Tamariki System and Children and Young People's Commission Bill that has not already been publicly released.
- As part of your response could you identify for me (and provide links to) all material relevant to the request that has been publicly released.

On 14 June 2022, you agreed to limit the timeframe of your request to 1 January 2018 onwards.

On 29 June 2022, the Ministry emailed you to advise that more time was required to respond to your request as your request is for a large quantity of information, and it would take longer than the 20 working day time limit to collate the material requested and assess whether any interest might be prejudiced by its release.

Please find attached the following documents as **batch four** in response to your request:

# Meeting with the Children's Commissioner

Meeting details	22 May 2019, Minister's Office
Expected attendees	Judge Andrew Becroft, Children's Commissioner
Purpose of meeting	To meet with the Children's Commissioner to hear any questions or concerns he may have relating to the progress of the establishment of independent oversight of the Oranga Tamariki system and children's issues.

Background Since Cabinet policy decisions were made on 25 March 2019 MSD has met with the Commissioner and his staff on a number of occasions and a draft relationship agreement is also being prepared.

> Engagements to date have been constructive as we get into the detail regarding what Government is intending to achieve, how this might work in practice and what the implications might be for the Children's Commissioner and the Office of the Children's Commissioner (OCC).

MSD will provide you with a report in late June 2019 summarising the conversations we are having with the OCC, Office of the Ombudsman and Māori and our advice on next steps. Providing a paper to you in late June 2019 is necessary to meet the introduction of the oversight Bill in October this year, particularly if advice needs to be submitted to the Social Wellbeing Committee (SWC).

# **Progress** update

# **Engagement with the Office of the Children's Commissioner**

As a part of the work around strengthening independent oversight, MSD is currently holding a number of discussions with key agencies and stakeholders including the OCC and the Office of the

Ombudsman.

The primary aim of these discussions is to exchange information, discuss specific policy issues relating to oversight and to listen to and understand any concerns which are raised.

MSD's discussions with the OCC are focused primarily on issues relevant to the Commissioner, in particular:

- Clarifying the intent behind strengthening independent monitoring to ensure Ministers are aware of non-compliance with the Oranga Tamariki Act and associated regulations, quality of practice issues and a good understanding of how existing policy settings are impacting on the wellbeing of children and young people in care.
- Discussing how the advocacy and monitoring functions will work together and the implications for the Commissioner's independence.
- Implications for the Commissioner's existing monitoring and complaints functions.
- Seeking their input into building the assessment framework and operating model.

# **Engagement with Māori**

MSD is currently preparing a mixed model for Māori engagement. MSD has engaged the services of Donna Matahaere-Atariki and Hera Douglas as the independent facilitator and writer respectively to advise and assist MSD on the engagement and collaboration process with Māori and Iwi.

Their role is to ensure that the engagement and collaboration process is effective and robust, and leads to a well-designed, respected and culturally appropriate oversight system. We anticipate that engagement will begin in late May 2019.

# Discussion Points

Possible responses to questions and concerns the Commissioner may raise:

# Why are Māori not represented at the current discussions with the OCC?

- The Commissioner raised the concern that Māori should be present at the current discussions and that it would be better to delay this work rather than not include adequate Māori representation.
- We have considered this and expect there will be a number of issues on which joint engagement will be beneficial. However, given the nature of conversations at present, we believe there are advantages to continuing one-on-one engagements. These more personalised engagements provide a useful means of understanding specific views and progressing detailed discussions that might not otherwise progress as smoothly in a large group where stakeholders may have different priorities.
- In the interim we are taking steps to ensure our Māori engagement team are a party to future meetings with the

Commissioner.

# Why is the independent monitor being set up the way it is?

- The Commissioner has questioned the policy intent to separate the monitoring and advocacy functions. MSD is working through what this means and how we might find a solution.
- In the event that an agreement cannot be reached in line with Cabinet decisions, then we will bring the question to joint Ministers which will reflect the OCC's concerns

# What is being done in the area of Māori engagement?

- The proposed structure for the engagement process is to have an oversight group (the Kahui Group) to support the process and a mixed model engagement approach where participants represent a range and level of interest and expertise in varying aspects of the Oranga Tamariki system.
- The first phase of engagement will focus on high level issues for the oversight system and will involve a range of individuals and groups. This phase will involve holding early conversations around the oversight system rather than presenting a completed oversight model.
- MSD envisages subsequent phases will enlist small focus groups with particular expertise and skills to work on particular parts of the work programme including the legislative framework, the operating model and the assessment framework. Although these small focus groups will provide more detailed input into the work programme, a wider opportunity will still exist for providing feedback.

# The Kahui Group

- The Kahui Group will play an important role in supporting MSD to achieve its engagement and collaboration goals by providing oversight, advice and on-going support. More importantly they lend mana and endorsement to the process and help to allay any concerns that the process is not genuine or being undertaken in good faith.
- The Kahui Group is in the process of being established and will have up to four members. Sir Mark Solomon and Druis Barrett have already confirmed their availability and MSD welcomes the depth and range of expertise and mana they bring to this process. It is expected that the first meeting of the group will be on 30 May 2019.

# **Governance arrangements**

• The State Services Commission (SSC) is the lead expert on this matter and we are working closely with SSC.

 Discussions with the SSC and the Commissioner are scheduled over the next two weeks.

# Investigation powers and powers to direct

- The Commissioner raised a question around his current investigation powers and powers to direct under the Children's Commissioner Act 2003.
- MSD is currently exploring this question with the OCC and the Ombudsman's Office.

# **Un-redacted Cabinet Paper for the OCC**

- The OCC have requested an un-redacted copy of the Cabinet paper.
- MSD is currently working through what is required to honour this request and will provide advice to your office.



# Engagement has continued positively throughout the month including: • DCE level meetings with Oranga Tamariki, the Children's Commissioner and with Oranga Tamariki / the Ombudsman's Office · multiple meetings with key stakeholders led by the Policy / Legislation workstream to discuss a range of policy matters to inform drafting of the new **Engagement:** The ICM met with OCC to discuss progress and the current status of the work to. plan for building the assessment framework and operating model for the ICM. A draft engagement strategy on the approach to engagement with the wider sector and interest groups was considered by the Programme Sponsoring Group during August with feedback to be incorporated in the next draft. Māori engagement has continued to be successfully conducted in line with the approved Māori engagement plan. Twenty two hui have been completed with individuals and national organisations across the country. The team are now writing up the notes from the hui held to provide a summary of main themes arising. Māori **Engagement:** Two Kāhui Group meetings were held during August (9 & 20 August) with a focus on review and input on: · The model for future governance arrangements for the OCC · Treaty duties and commitments · The ICM monitoring framework. Weekly internal and external update emails have continued during the month. · The initial communications strategy was approved and implementation is underway with a focus on ICM brand and website creation. The Kāhui Group have advised that there is not currently enough certainty around the function and form of the ICM to further the process for obtaining a Māori name at this time. Communications: · We are developing an interim ICM brand and website - focussed on a professional and neutral look and feel to reflect the independent role of the ICM. The ICM website is targeted for release December 2019 and will leverage the all of government common web platform which will provide for independence from MSDs web presence and for ease of transfer of the web site to another agency in

# Policy/Legislation

- Work is progressing under tight timeframes to see introduction of a new bill now targeted for February 2020.
- Timeframe risks which reflect the overall AMBER status include the need to consult extensively with multiple stakeholders with differing views on some matters, extensive engagement with Maori, a dependency on SSC advice with respect to future governance models for the OCC and taking into account the parliamentary calendar and holiday period.
- A report providing an update on progress and seeking direction to assist with drafting of the Bill was sent to you in August.
- The team continue working through a range of key policy issues in workshops with Oranga Tamariki, OCC and the Ombudsman, while progressing the development of the Cabinet paper and cover note to support the drafting of the new Bill which you will receive in September.
- SSC continues to develop and consult on the proposed governance options for the OCC.
- An aide-memoire was developed to support your meeting with Judge Becroft and Minister Martin on 27 August.

# Phase 1 Independent Children's Monitor Monitoring/Operations

Phase 1 (from 1 July 2019) is underway with the initial assessment framework and MoUs in place with the 4 organisations being monitored (Oranga Tamariki, Open Home Foundation, Bamardos and the Dingwall Trust).

- The ICM has received the first set of information from the four agencies who have children in their custody and who we are monitoring under Regulation 69 and 85.
- Analysis of the information is underway and further information requests have been sent to the four agencies. The report for the Minister for Children is on track for completion in December.



# Programme summary

- 4 All key streams are tracking to plan, with overall status of AMBER reflecting the remaining schedule risks within the Legislation stream; and until the integrated programme plan is baselined by the Programme Sponsoring Group (targeted for October).
- 5 Several roles have been appointed within the Independent Children's Monitor (ICM) establishment team; and current recruitment to support the ICM Operations will

conclude early October with people coming on board throughout October and early November.

# Engagement and Communications

- Engagement with key agencies and Māori is progressing well with engagement hui for this phase of the programme now complete and a positive meeting held with the Chief Social Worker (Oranga Tamariki) to discuss the feedback.
- 7 Engagement in October will focus on the four agencies being monitored and some key NGOs in the sector, such as VOYCE Whakarongo Mai.
- The ICM website (and branding) is targeted for release December 2019 and will be independent from MSD's web presence and designed for ease of transfer of the web site to another agency in the future. A Statement of Work has been approved for an external party to develop the website on the Government Common Web Platform during October and November.
- An article on ICM for the Ministry's Kotahitanga newsletter was drafted and due to be sent to the Ministry's service providers and stakeholders on 1 October.

# Policy workstream

- Meetings were held and feedback on the draft Cabinet paper was incorporated during September with agency and Ministerial consultation planned to take place during October.
- 11 Key milestones have been reforecast to align with the paper for the Social Wellbeing Committee now planned for November, which includes a move of the target date for bill introduction from February 2020 to March 2020.





# Summary and key points of interest in report

# Programme summary

4 All key streams are tracking to plan, with overall status of AMBER reflecting the continued schedule risks within the Legislation stream and until the integrated

- programme plan is baselined by the Programme Sponsoring Group (now targeted for December).
- Several roles have been appointed within the Independent Children's Monitor; including two Principal Advisors and a Senior Advisor in addition to confirmation of key roles within the establishment team.

# Engagement and Communications

- 6 Engagement with key agencies is progressing well, with regular DCE level meetings with key partners and a meeting of the Kāhui group occurring during the month along with relationship meetings with the MSD Regional Commissioner and his team and the Oranga Tamariki Operational DCE's in Auckland.
- The Executive Director and Head of Assessment met with the CE's of Dingwall Trust and Barnardos to discuss their information return and future work, including opportunities for contributing to the development of the Monitor's Assessment Framework. They also met with the CE of VOYCE Whakarongo Mai to discuss the ICM's planned approach and expectations about how the ICM could partner with VOYCE moving forward.
- The design concepts for the interim ICM brand were approved this month and draft content for the ICM website was completed with the website and branding remaining on track for release December 2019.

# Policy workstream

- The draft Cabinet paper was sent for departmental consultation. Feedback was received from the majority of departments and has been positive overall. A summary of the draft paper was also provided to the Office of the Children's Commissioner, the Office of the Ombudsman and the Kahui Group for comment by 5 November.
- 10 We will send an updated Cabinet Paper to you on 7 November seeking your approval to commence consultation with Ministers.

Independent Children's Monitor monitoring and establishment workstreams

Current monitoring report – due December 2019

Work continued throughout the month on drafting the Monitor's first report. Tailored versions of the draft content are being developed to send to each agency early November for review and fact checking content specific to their organisation. The report remains on schedule for delivery to the Minister for Children in early December.

Work on mapping current outcomes frameworks to support development of the Monitor's assessment framework

- 12 Following the direction set by the Government regarding the purpose of the Monitor, to reflect a broad spectrum of monitoring from compliance and practice quality through to monitoring outcomes being achieved for tamariki and whānau, the Monitor has been mapping relevant child and whānau focused outcomes frameworks that already exist to guide its work. These are:
  - · the Government's Child and Youth Wellbeing Strategy,
  - Te Puni Kokiri's Whānau Ora outcomes framework, and
  - the Oranga Tamariki outcomes framework and end goals.
- All of these frameworks have been widely consulted on previously with the sector, Māori and the general public. To inform the Monitor's outcomes approach the National Care Standards (NCS) Regulations have then been mapped against the outcomes and indicators each framework measures. During October this has been tested with key agencies and is now being refined based on feedback received. The framework will enable future reporting by the Monitor to be focused on identifying if outcomes are being achieved as well as the required performance measures for accountability. It will also enable a focus on outcomes for tamariki Māori, with

- emphasis on the role of whānau in child wellbeing. A summary of the current high level draft of this work is attached at Appendix One.
- 14 Each of the key agencies has been involved in reviewing the outcomes work and support the outcomes focused approach. The outcomes work provides the platform for the Monitor's assessment approach and framework which is currently under development and drives the questions and considerations the Monitor will use when validating the information provided by agencies.
- 15 The Monitor's assessment framework is in the early stages of development and the Monitor intends to engage with the sector early in 2020 to seek feedback that will inform the further development of this approach.
- The aim is to test the Monitor's assessment framework for this work against sections of the NCS Regulations to inform both the June and December 2020 Monitor reports. This will allow the impacted agencies and the Monitor to review the process and make the required amendments to ensure the validity of the monitoring arrangements moving forward. As the Monitor will be monitoring and reporting on all the NCS Regulations from December 2020, it will be important for the agencies to have a thorough understanding of the approach, the impact on their day to day operations and the information the Monitor will be seeking.
- 17 The outcomes framework and the assessment framework will also inform the Monitor's operating model which is also currently under development. The operating model will reflect our 7 core design principles pillars:
  - Child-centred the Monitor will put the outcomes of children and young people in the Oranga Tamariki System at the heart of its services and decision making. It acknowledges that this must occur in the context of their whānau and the importance of being whānau-led.
  - Te ao Māori the Monitor will embed Te Ao Māori across the organisation and develop our tikanga approach within the principles of the Treaty.
  - Insight-driven the Monitor will leverage technology and analytics to turn information into insight to drive the organisation.
  - Influencer the Monitor will be a trusted and credible influencer in the system, a catalyst for meaningful change and action.
  - Fair, objective and unbiased the Monitor will be transparent and operate fairly, objectively and without bias. It will be independent and seen to be independent.
  - Systems outlook the Monitor will understand the Oranga Tamariki System and its complexities, to enable insightful reporting across the system and its players.
  - Partnering for impact the Monitor will partner and collaborate effectively to strengthen oversight.
- 18 It will also reflect the work that needs to be done, the structures and processes the Monitor will need to fulfil its functions. The high-level view of the Monitor's proposed operating model will also be a focus of the sector engagement early in the new year.





#### Programme summary:

  Programme Sponsoring Group (now targeted for December).
- Good progress has been made on development of the Independent Children's Monitor assessment framework and operating model with design principles and a draft outcomes framework produced.

#### **Programme Management:**

- Several appointments have been confirmed within the Independent Children's Monitor in addition to confirmation for key roles within the establishment team. Recruitment for a Principal Advisor Strategic Workforce Planning and Senior Advisor Communications is planned for November.
- A budget bid has been submitted within the Cost Pressures track for Budget 20 which seeks operational funding for the ICM for FY21/22, FY22/23 and outyears.

# **Engagement, Communications and Change:**

# Engagement: Engagement: Rel tea

- The Engagement Manager commenced on 21 October and work is underway on the detailed Engagement Plan (which follows on from the approved high level strategic plan), including drafting tactics and channels and initial drafting of regional hui, with a draft plan targeted for the end of November.
- Engagement has continued positively throughout the month with DCE level meetings held with Oranga Tamariki, The Children's Commissioner and with Oranga Tamariki / The Ombudsman's Office.
- Relationship meetings were held with the MSD Regional Commissioner and his team and the Oranga Tamariki Operational DCE's in Auckland:
- The Executive Director and Head of Assessment met with the CE's of Dingwall
  Trust and Bamardos to discuss their information return and future work,
  including opportunities for contributing to the development of the Monitor's
  Assessment Framework. They also met with the CE of VOYCE Whakarongo Mai to
  discuss the ICM's planned approach and expectations about how the ICM could
  partner with VOYCE moving forward.

# Māori Engagement:

- Māori engagement has continued to be successfully conducted in line with the approved Māori engagement plan.
- The Kāhui Group met on 18 October to consider the work programme for Phase 2 and to discuss the draft design principles for the assessment framework and operating model. The Group was provided with an update on progress with the Cabinet paper and the anticipated timeline for the legislative process.
- A meeting was held with the Ministry of Justice to discuss the Kāhui Group model and our approach and experience of working with the Kāhui.

# Communications:

- Weekly internal and fortnightly external update emails have continued during the month.
- The design concepts for the interim ICM brand were approved this month and draft content for the ICM website was completed. The ICM prototype website development is underway and is targeted for completion early November.
- A photo shoot has been commissioned and details have been finalised to provide imagery to support the ICM brand.

# Workstream summary:

# Policy/Legislation

- Work continues to progress under tight timeframes to see introduction of the new bill in mid-March 2020.
- Timeframe risks include the move to target SWC in December (a change from the previous November date) which decreases the time available for drafting of aspects of the bill.
- The draft Cabinet paper was sent out for departmental consultation from 23 October to 31 October. Feedback has been received from the majority of departments and has been positive overall.
- There was coordination throughout the month with the Parliamentary Counsel Office in preparation for drafting of the Bill and we are planning the approach for key remaining areas to be finalised in preparation for drafting legislation, including the approach to developing regulations.
- There was further development on the proposed governance structure of the OCC. The draft Cabinet paper recommends the key governance decisions. Detail around the makeup of a Board is being developed with input from our Māori Advisors (including the Kahui group), Crown Entity team and SSC.

# Phase 1 Independent Children's Monitor Monitoring/Operations

- Phase 1 is underway with the initial framework and MoUs in place with the 4 organisations being monitored (Oranga Tamariki, Open Home Foundation, Bamardos and the Dingwall Trust). Meetings with the 4 organisations being monitored were held in October to discuss their information returns and future work, including opportunities for contribution to the development of the assessment framework.
- Work continued throughout the month on drafting the monitor's first report for the Minister for Children. Tailored versions of the draft content are being developed to send to each agency in early November for review and fact checking content specific to their organisation.
- The report remains on schedule for delivery to the Minister for Children in early December.
- The Programme Sponsoring Group received an update on the review of the Memoranda of Understanding and the Initial Assessment Framework with the four agencies being monitored. Both documents will be further reviewed following any feedback or changes proposed by the agencies and an updated Initial Assessment Framework will then be reissued ahead of the second reporting cycle starting in January 2020.

# Phase 2/3 Independent Children's Monitor Assessment Framework and Operating Model



- A workshop was held with key people involved in the establishment of the ICM to consider how the Monitor will effect change. From this, a set of design principles has been developed, which will guide the Monitor's assessment framework and operating model.
- Work on the draft operating model has considered the potential key functions that will be required and the respective enablers and workflows between these functions in relation to the operating model pillars, which are based on the agreed design principles.
- Following completion of the exercise to map the National Care Standards Regulations against the outcome frameworks, we tested this approach with key stakeholders across OCC, TPK, DPMC, Oranga Tamariki and internally within MSD.

# **Policy**

- The Oversight of the Oranga Tamariki System and Children's Commission Legislation Bill will implement policy changes arising from the Cabinet commissioned *review to strengthen independent oversight of the Oranga Tamariki system and of children's issues* (the Review).
- The Review found significant gaps in the existing independent oversight arrangements, particularly for independent monitoring to assure New Zealand's statutory care system, and for a clear and resourced role for oversight of complaints and incidents in the statutory care system (and oversight of complaints processes for children and their whānau generally).
- The substantive policy proposals for this Bill were confirmed by Cabinet in March 2019, and subsequent clarification of policy proposals are due to be confirmed by Ministers in

- December 2019. A category 4 priority is proposed to ensure the Bill can be referred to Select Committee in 2020, to ensure that the Bill can be passed in early 2021.
- There is likely to be significant interest from the sector in this Bill as it is anticipated to include proposals to enhance the independent review of complaints in relation to Oranga Tamariki, as well as the independent monitoring role, and potential changes to the functions and governance arrangements for the Office of the Children's Commissioner (OCC).

# **Need for legislation**

- On 25 March 2019, Cabinet agreed to strengthen independent oversight of the Oranga Tamariki system and children's issues in three core areas: system-level advocacy for all New Zealand children and young people; oversight and investigation of complaints of matters related to application of the Oranga Tamariki Act 1989 and/or children in the care or custody of the State; and independent monitoring and assurance of the operations and obligation delivered under the Oranga Tamariki Act 1989 and associated regulations [CAB-19-MIN-0113 refers].
- Cabinet agreed to new primary legislation, in the form of an omnibus bill, to bring together in one place, the respective roles, responsibilities and powers of the oversight bodies [CAB-19-MIN-0113 refers]. The Bill will repeal the Children's Commissioner Act 2003, amend the Oranga Tamariki Act 1989 and associated regulations, and make minor amendments to the Ombudsmen Act 1975 to enable the Ombudsman to carry out the complaints and investigation oversight for Oranga Tamariki.
- The independent monitor is hosted by MSD and was appointed from 1 July 2019 which is when the Oranga Tamariki (National Care Standards and Related Matters) Regulations 2018 came into force. Although the independent monitor can monitor compliance under those regulations, permanent arrangements for the independent monitor under the Bill must be made. The Bill will also widen the jurisdiction of the Ombudsmen to include entities that provide services for children on behalf of Oranga Tamariki and/or pursuant to the Oranga Tamariki Act. Therefore, it is important to have the Bill enacted in early 2021.
- This Bill was on the Legislative Programme in 2018 but did not proceed due to the complexity of the policy work and time taken to progress policy proposals through Cabinet. The legislation did not proceed in 2019 as Ministers required extensive consultation following the initial policy approvals in March 2019, which led to further policy approvals being needed. The Bill will proceed this year as we will not be seeking further clarification of policy approvals from Cabinet.
- Initial drafting instructions have been provided to PCO based on the March 2019 Cabinet approvals. A skeleton Bill has been drafted. Further drafting instructions will be provided for the subsequent policy approvals, decisions due 4 December 2019. Permission is being sought from the Attorney General for PCO to begin drafting ahead of policy approvals, due to the tight timeframes.

<sup>&</sup>lt;sup>1</sup> The Ombudsman will use its powers contained in the Ombudsmen Act 1975, while giving regard to any additional powers or constraints (for example, duties relating to the Treaty of Waitangi, general principles, information access and sharing provisions, including the Codes for engaging with children and young people) as applicable in the new Act, to perform its specific function as oversight body for complaints and investigations within the Oranga Tamariki system.

# **Compliance**

- 11 It is anticipated that the Bill will comply with each of the following:
  - 11.1 the principles of the Treaty of Waitangi;
  - the rights and freedoms contained in the New Zealand Bill of Rights Act 1990 and the Human Rights Act 1993;
  - 11.3 the principles and guidelines set out in the Privacy Act 1993;
  - 11.4 the relevant international standards and obligations; and
  - the <u>Legislation Guidelines (2018 edition)</u>, which are maintained by the Legislation Design and Advisory Committee.

# **Binding on the Crown**

12 The Act will be binding on the Crown.

#### Consultation

- A consultation document Strengthening Independent Oversight of the Oranga Tamariki System and of Children's Issues in New Zealand was consulted on between May and July 2018. This resulted in the Beatie Report Consultation has been ongoing since then with government agencies (the Education Review Office, The Ministry of Health, Oranga Tamariki, Department of Prime Minister and Cabinet, Office of the Ombudsman) and Ministers. Since the March 2019 Cabinet decisions there has been further consultation during the policy development process, including with the OCC, the Office of the Ombudsman, Oranga Tamariki, the Kāhui group (a group key Māori leaders with experience in the areas of health and social services for Māori was established in May 2019 to assist MSD with the independent oversight work), and with Māori organisations and individuals that represent a range of interests and expertise across the Oranga Tamariki system, such as strategic Treaty/Iwi partners, medical professionals, providers, care experienced individuals, caregivers and other relevant stakeholders.
- Ministerial consultation has been undertaken by Minister for Social Development with the Minister for Children, the Prime Minister, in her capacity as the Minister for Child Poverty Reduction, the Minister for Whānau Ora, the Minister for Māori Development and the Minister of State Services.
- 15 Timing on future consultation will be determined by Ministers.
- The proposed Bill has been referred to the Legislation Design and Advisory Committee for advice.

# **Associated regulations**

17 Amendments to regulations will be required.
