### Tēnā koe

On 13 September 2022, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

I am after the number of people that have been funded by, or otherwise supported by MSD through obtaining their graduated drivers licence (Class 1) in the Taupo District in the last 3 years. In particular:

- The number and age of people supported in obtaining their learners licence, whether successful or not.
- The number and age of people supported in obtaining their restricted licence, whether successful or not.
- The number and age of people supported in obtaining their full licence, whether successful or not.
- The total cost (per year) paid to external organisations to support these people towards obtaining their licences.

On 3 October 2022, the Ministry emailed you as your request was broad in scope. The Ministry advised that we are only able to provide you with the total amount of driver licence hardship grants for the last 3 years in Taupo District and cannot be broken down by license type. However, as you did not respond to this email, the Ministry will be answering your original request as above.

On 11 October 2022, the Ministry emailed you to advise that we needed more time to prepare a response for you and a decision will be with you no later than 11 November 2022.

On 10 November 2022, the Ministry emailed to advise that we had decided to grant your request in part, namely the information which relates to the overall amount of hardship granted for driver licenses and total amount paid to external organisations to support clients obtain their licenses. However,

we required some additional time to prepare this information for release, and advised you it would be with you no later than 30 November 2022.

The Ministry will now answer each part of your request in turn for clarity.

- The number and age of people supported in obtaining their learners licence, whether successful or not.
- The number and age of people supported in obtaining their restricted licence, whether successful or not.
- The number and age of people supported in obtaining their full licence, whether successful or not.

I am unable to provide you with this information as it is held in notes on individual case files. In order to provide you with this information, Ministry staff would have to manually review a substantial number of files. As such, I refuse your request under section 18(f) of the Act. The greater public interest is in the effective and efficient administration of the public service.

I have considered whether the Ministry would be able to respond to your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Ministry's ability to undertake its work would still be prejudiced.

However, in the spirit of being helpful, please see **Table One** in the below **Appendix** which outlines the number of hardship grants for Drivers Licence – New for the Taupo District by age group and year for the period January 2019 to 31 October 2022.

 The total cost (per year) paid to external organisations to support these people towards obtaining their licences.

Please see **Table Two and Three** in the below **Appendix** which outlines the total amount paid to external providers to help clients obtain their licences in the Taupo District for period financial year ending 2020 to financial year ending 2022.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any

attached documents available to the wider public. The Ministry will do this by publishing this letter and attachments on the Ministry's website. Your personal details will be deleted, and the Ministry will not publish any information that would identify you as the person who requested the information.

- 2022 is a partial year and is from 1 January 2022 to 31 October 2022.

• The table includes the hardship reason Drivers Licence - New only. It does not include the hardship reason Drivers Licence - Renewal which is granted as a separate hardship.
