On 13 January 2023, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 the following information:

- could you please supply any information for what was the Age Benefit and what Acts was it included in.
- I have attached a screenshot referring to Age Benefit in the Social Security Act 1964 so could you please supply the Social Security Act or any other legislation previous to 1964 that dealt with the age pension.

On 1 April 1939, the Age Benefit came into force through the Social Security Act 1938, replacing the previous Old Age Pension that had been in place since 1898.

The eligibility age was set at 60 years, with a residency requirement of 20 years. There were also requirements relating to marital status, support of any children and being of good moral character and sober habits.

The payment level of the Age Benefit was 30 shillings per week, or £78 per year. The benefit was means-tested, and reduced by £1 for each £1 in excess of £52 per year. The benefit was also assets-tested and was reduced by £1 for every complete £10 of the net capital value of accumulated property.

The policy settings for the Age Benefit were adjusted over time, such as income exemptions, assets tests and residential qualification.

In 1977, the universal National Superannuation was introduced, replacing the Age Benefit.
