On 9 January 2023, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- 1/ As of December 31, 2022 please provide the ages of children dependent on benefits broken into one-year age bands
- 2/ Please provide the same data by benefit type
- 3/ Please provide the same data by ethnicity
- 4/ Please provide equivalent data at December 31, 2018

We have defined children as dependent children aged 18 years or younger. Where a dependent child is 18 years of age and is attending school or a tertiary establishment (including by correspondence), the child can continue to be regarded as a dependent child up until the end of the school year in which the child turns 18 years old.

In regards to your request, each of your questions will be responded to in turn:

- 1/ As of December 31, 2022 please provide the ages of children dependent on benefits broken into one-year age bands
- 2/ Please provide the same data by benefit type

3/ Please provide the same data by ethnicity

Please note that the Ministry does not record the ethnicity of people between 0-17 years of age. As such, this part of your request has been refused under section 18(g)(i) of the Act, as the information requested is not held by the Ministry and I have no grounds to believe that the information is held by another department or interdepartmental Venture or Minister of the Crown or organisation, or by a local authority.

However, we have provided you with a breakdown of the ethnicities of adult clients currently receiving a working age benefit that have children. Please see the **Appendix**, **Table Four**.

4/ Please provide equivalent data at December 31, 2018

Please see the **Appendix**, **Table One** and **Table Three**.

Finally, please note the following caveats regarding all information provided in the **Appendix**:

- Where referring to adults, these tables include working age people only (18 to 64 years).
- Main Benefits exclude NZ Superannuation, Veteran's Pension, Non-Beneficiary assistance, Orphan's Benefit and Unsupported Child's Benefit.
- To protect confidentiality the Ministry of Social Development uses processes to make it difficult to identify an individual person or entity from published data.
- These data tables have had random rounding to base three applied to all cell counts in the table.
- Random rounding does not round down to zero, a value of one or two will be rounded to three.
- The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals.
- The published counts will never differ by more than two counts.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public. The Ministry will do this by publishing this letter on the Ministry's website. Your personal details will be deleted, and the Ministry will not publish any information that would identify you as the person who requested the information.
