Official Information Act request

Thank you for your email of 31 October 2024, requesting the following information:

Correspondence between MSD and Heart of the City, Auckland centre city's business association, during the period 1 January 2022 and 30 September 2024.

Please include all email communication (including any attachments), meeting invites and minutes.

I have considered your request under the Official Information Act 1982 (the Act). Please find my decision on your request set out below.

I have identified 8 emails in scope of your request, and I have collated these emails in one document. Please see this document enclosed with this letter as **Appendix**.

As the Ministry has not received a response from you, in our email to you on 1 November 2024, in regard to staff names and contact details, I have deemed this information as out of scope.

Regarding the email, subject "RE: Update Please", sent 21 October 2024 at 12:41pm, by the Ministry's Regional Commissioner Advisor, I draw your attention to the following sentence regarding the Auckland Council: "*They are also working with their call centre team to understand the ability for these staff to have all the referral links for our agencies that are on AWHI so that when people call them, they can support with the social referrals as well.*"

The Council has explained that this statement is not correct. It was never intended that the Council's call centre team would be given access to the Ministry list that is used by AWHI (a Police application). The Council is continuing to work on a solution.

Your request for meeting minutes is refused under section 18(e) of the Act as this document does not exist or, despite reasonable efforts to locate it, cannot be found.

In regard to your request for meeting invites, I am providing you with a summary of the scheduled meeting dates and the subject of the meetings, as per section 16(1)(e), where the information would otherwise be withheld under section 18(h) as being considered trivial due to the administrative information contained within the invites themselves (such a phone and virtual meeting details).

Thanks for coming back to me. As per your text, I have popped in a time for us to connect on Wednesday morning, if the time doesn't suit, feel free to adjust it.

Re the 105 number idea – the police are already going through a review of the 111/105 call outs, which also means that they are currently trailing a new approach to how the respond to calls receive through both 111 and 105 as they are setting up a new response framework.

There isn't a lot of information on this, beyond what is already available publicly, but the goal is for Police to be able to better respond quicker to calls where immediate risk is present.

In saying that, the goal of having the 105 number, which would ideally have helped there to be a clearer process that people can follow to get help – is still the goal, just in a different way.

This would ideally be there being more information held with any option of support a person turns too, so for instance:

If there is immediate need for help and support – ie someone feels their immediate safety is at risk, then they should always call 111 If there is a non-urgent crime to report, then this would be 105

This stuff needs to stay with police and the goal is to have the messaging really clear on this.

Beyond that, if someone is wanting to get support for a noncriminal issue,

that isn't a risk to their safety, then that is where the network would come into play, and there are some ideas to make this as easy as possible. Firstly, the Council are looking to have their website updated with as many of the supports available for help as suitable.

They are also working with their call centre team to understand the ability for these staff to have all the referral links for our agencies that are on AWHI so that when people call them, they can support with the social referrals as well.

Secondly, to make this even easier – the Council are currently exploring having a QR code developed which will enable this to be on posters and anywhere and everywhere around the city. There is the understanding of cost and viability being worked out at the moment – before it can be shared much wider. They mentioned it at the last Subgroup meeting, and the plan is, all goes well, to advise the wider group that meets with the Minister in November.

But what this means, is that if anyone needs any help, they can just scan or click on the QR code from any phone camera – this will then open to tell them where to get the help they need where they can just click on the link they need, and it will connect them directly.

But lets have a chat on Wednesday where we can run through in more detail.

I asked for an update on the work to establish a simple way (ideally 3 digit) for people to raise issues at the last cross-agency meeting but unfortunately there wasn't one, other than the Council phone/website, which does not address the key issue. I've copied some comments below from concerned resident, who is dealing with some significant ongoing issues:

"I think we need more clarity on who to call and when. I'm struggling to make sense of the plethora of agencies and organisations involved that are outlined in the booklet from the launch of the Community Safety Plan the other day. I have Police numbers (111 and 105) — I've got that firmly imprinted on my mind (is it happening now or did it just happen?)..... In the heat of confrontation this is somewhat confusing to mentally select from 4 possible numbers (that aren't necessarily that memorable beyond 111 — although the HoTC one is easier to recall now but I still have to think whether it's better to call HoTC or AC Compliance). As a native English speaker I can begin to come to grips with these choices but I know many in my building would struggle to go for numbers beyond 111 because of the decision making nuances involved and having English as a second language. It would be very confusing for many. The reality is if it's not hugely urgent then the other numbers are more likely to succeed over 111 but it's just that process of deciding which."
