Official Information Act request

Thank you for your email of 9 May 2024, requesting information about Kōrero Mahi - Let's Talk Work seminars from the Ministry of Social Development (the Ministry).

I have considered your request under the Official Information Act 1982 (the Act). Please find my decision on each part of your request set out separately below.

I note you have asked for information that is considered as outside the scope of your request to still be included. In order for the Act to apply, the official information requested needs to be specified with due particularity. In my view, it would impair efficient administration to include other matters that might be contained within a report on a different topic in response to your request.

As such, where there are other matters contained within reports that do not relate to Kōrero Mahi – Let's Talk Work seminars, I have not considered or assessed it as part of this request.

If there are other matters you are interested in, you are welcome to submit further requests for information, noting each needs to specify clearly what information you are seeking.

all advice on the name and branding of the seminars. I'm particularly interested in why a te reo name was chosen, given the government's announced "English-first" policy

I am refusing your request under section 18(e) of the Act as this document does not exist or, despite reasonable efforts to locate it, cannot be found.

all advice on the expected cost of the seminars, both in dollar terms and in staff time

I am refusing your request for this information under section 18(e) of the Act as the document which would contain this information does not exist.

These seminars are managed within existing resource focussing on the employment service and incorporated into the employment offerings.

all advice on the expected benefit of the seminars, both to the government and to attendees

Please refer to the attached appendices in scope of this part of your request, as outlined below:

Appendix A- Körero Mahi – Let's Talk Work Brochure

Appendix B- Kōrero Mahi – Let's Talk Work PowerPoint slides

Please note, we have also identified a report REP/24/2/223-Delivering on your priorities and two draft Cabinet papers in scope of your request. All three documents contain information largely out of scope of your request and as such, have not been provided. Information relating specifically to Kōrero Mahi in these papers has been assessed.

I have included an excerpt of the relevant paragraphs from REP/24/2/223 in accordance with section 16(1)(e) as **Appendix C**, attached with this letter.

The first draft Cabinet paper was revised and substantially changed and has since been published online. I have withheld the relevant section of the draft paper relating to Kōrero Mahi under section 9(2)(g)(i), of the Act to protect the effective conduct of public affairs through the free and frank expression of opinions.

If you would like to read the published version of the Cabinet paper, you can do so at the following link: welfare-into-work.html. However, it should be noted that the published Cabinet paper ultimately did not include information on Korero Mahi.

Information on Kōrero Mahi in the second draft Cabinet paper has also been withheld under section 9(2)(g)(i), of the Act to protect the effective conduct of public affairs through the free and frank expression of opinions. Please note, the title of the Cabinet paper is withheld under section 9(2)(f)(iv) of the Act to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials. The release of this information is likely to prejudice the ability of government to consider advice and the wider public interest of effective government would not be served.

any advice on how the impact of the seminars will be evaluated

I am refusing your request for this information under section 18(e) of the Act as the document which would contain this information does not exist.

Kōrero Mahi – Let's Talk Work is just one of many tools that the Ministry uses to actively engage with job seekers and provide them opportunities to shift into work. It is a combination of activities, interventions, referrals to jobs, providers and services, as well as engagements with employers which lead to jobseekers shifting into work.

I will be publishing this decision letter, with your personal details deleted, on the Ministry's website in due course.

15 While many of these changes will require legislative amendment (such as legislation for the overall Traffic Light System framework), there are steps we can take now, for example the job check-ins starting in June 2024 that you announced in February 2024, the national roll-out of Kōrero Mahi – Let's Talk Work and operational changes to the employment service.

16 Taken together, these changes will deliver on your commitments and unlock capacity to directly engage with more clients and direct our available resources towards higher-value interactions. Delivering the right support at the right time for clients, combined with changes to other obligation and sanctions settings, will provide the best opportunity for the Traffic Light System to be successful.

17 Each of the options presented here is intended to support your overall priorities and your Jobseeker Reduction target, but there are choices about specific interventions.
