# Purpose

1. This briefing provides information about reporting requirements relevant to your portfolio and seeks decisions required to progress reporting due in the first half of next year.

# **Executive Summary**

- 2. The Children's Act 2014 (the Children's Act) requires you to report annually on progress in relation to the outcomes under the Child and Youth Wellbeing Strategy (the Strategy).
- The Strategy Annual Report (the Annual Report) for 2022/23 is required to be completed by 31 March 2024. We propose an approach that includes data on each of the indicators under the Strategy, with a short accompanying narrative for each outcome area explaining progress and trends.
- 4. The Children's Act requires the Annual Report to include analysis of 'identified populations', including Māori children and any other groups you identify. We recommend including analysis for those groups for whom analysis has been provided in previous Annual Reports, to maintain consistency.
- 5. You may also wish to share a draft of the Annual Report with key stakeholders prior to publication, for their information and to seek high-level feedback.
- 6. Out of Scope
- 7. The Child Poverty Reduction (CPR) Act 2018 requires you to report annually on progress against the Child Poverty Related Indicators (CPRIs). The CPRI Report for 2022/23 is required to be completed by 30 June 2024. We propose an approach similar to previous reports, providing data on each indicator and deeper analysis on the impacts of poverty on New Zealand children.

- 9. As the Minister for Child Poverty Reduction and the Minister responsible for Strategy, you, and other Ministers, have statutory requirements to report on progress in relation to both child poverty and child wellbeing<sup>1</sup>. A summary of the reporting requirements relevant to your portfolio is provided in the table in Attachment A.
- 10. Two of these reports are prepared by the Child Wellbeing and Poverty Reduction Group (CWPRG) on your behalf. These are the subject of this briefing. You are legally required to:
  - finalise the Annual Report on progress on the outcomes of the Strategy by 31 March 2024, and
  - publish a report on the CPRIs by 30 June 2024.
- 11. Both reports cover the period 1 July 2022 to 30 June 2023. Over time we have evolved the approach to these reports, including what data breakdowns are provided and the inclusion of a wider range of perspectives alongside the indicator data.
- 12. The previous Cabinet also directed officials to monitor the implementation of the Strategy and provide a separate implementation monitoring report annually to the Social Wellbeing Committee [SWC-19-MIN-0085 and SWC-21-MIN-047 refer].
- 13. This briefing:
  - sets out some immediate decisions on the approach to the 2022/23 Annual Report that we'd like to discuss with you in order to be able to meet the statutory timeframes
  - canvasses some longer-term issues that we'd like your direction on, including the Strategy implementation monitoring report, and
  - seeks agreement to the approach for the 2022/23 CPRI report.

# There are some immediate decisions required to progress the Annual Report

14. The Annual Report must be prepared by 31 March 2024<sup>2</sup>. You are required to present the report to Parliament as soon as practicable after this. The Child Wellbeing and Poverty Reduction Group (CWPRG) prepares the Annual Report on your behalf. We're seeking your agreement to the high-level approach and other decisions needed now to finalise the report.

#### We seek your agreement to the approach to reporting for 2022/23

- 15. Legally, the Annual Report must report on the progress towards achieving the outcomes of the Strategy during the year. In previous years the Annual Report has also been used to spotlight key government initiatives relating to each outcome area.
- 16. Our proposed approach to the 2022/23 report is to provide information on the progress towards the Strategy's outcomes, including data tables of the measures of progress with short text that explains the data for the reader. Acknowledging that the reporting covers a period that occurred under the previous Government, there is likely to be less text about the initiatives implemented to achieve the outcomes than in previous years. The table below provides an outline of the report for your consideration.

# We are also seeking your direction on which population groups you wish to include separate analysis on in the 2022/23 Annual Report

- 17. Section 7C of the Children's Act requires that the Annual Report include reporting of outcomes for "identified populations". The Children's Act requires that Māori children and young people are included as an identified population. In addition, as Minister, you may identify one or more other populations to report on, subject to data availability.
- 18. There are limitations to how the Strategy measures can be broken down by different population groups. The measures in the current indicator framework are largely derived from survey and administrative data, which are able to be broken down by ethnicity and in some cases by other demographic characteristics, such as disability.
- 19. The previous Minister nominated the following groups to be reported on where data was available: Pacific children and young people, children and young people from other ethnic communities, including Asian children and MELAA<sup>3</sup> children, disabled children and young people, and rainbow children and young people. There is quantitative evidence that these groups of children and young people have additional or different needs, and are more likely to experience unmet needs, compared to other groups of children and young people.
- 20. We recommend reporting on the same identified groups of children and young people for the 2022/23 report, for consistency.

## There is an opportunity to share a draft of the Annual Report with key stakeholders


21. Section 7B(2) of the Children's Act requires that Children's Ministers<sup>4</sup> must be consulted on a draft of the report before it is finalised. We will ensure that this happens as part of the production process.

- 22. The 2022 review of the Strategy included a recommendation that our reporting should involve iwi/Māori, children and young people and community organisations to help interpret the evidence. As a small first step towards this, the process for the 2021/22 Annual Report involved providing a draft of the report to key external stakeholder groups two weeks prior to publication.
- 23. The aim of this engagement was to build and maintain stakeholder buy-in to the Strategy and seek high-level comment on the content of the Annual Report. It also provides an opportunity to understand stakeholder perspectives and prepare for public commentary following the publication of the report.
- 24. You may wish to follow the same process for the 2022/23 report. If so, we will work with your office to confirm the group of stakeholders and the timeframe.



# We want to confirm the approach to the 2022/23 reporting on the CPRIs

29. The CPRI Report provides the latest data on a set of CPRIs, defined under the CPR Act as causes, consequences or correlates of child poverty. There are currently five CPRIs set out in table 2.

- 30. The CPR Act requires that the CPRI Report includes data on every indicator identified for the financial year.<sup>6</sup> The CPRI Report has evolved to provide deeper analysis on the impacts of poverty on New Zealand children, although there is no statutory requirement for the report to do this.
- 31. The next CPRI report is due to be published by 30 June 2024 and will include data on each of the indicators identified in the table above.
- 32. We propose following a broadly similar approach to reporting the 2022/23 CPRIs as was followed in previous years. We are seeking your agreement to the approach now so we can begin work on the report.

# Treaty of Waitangi considerations and te ao Māori perspectives

- 34. The Strategy recognises the status of iwi, hapū and whānau Māori as tangata whenua and the Crown's responsibilities to give effect to the Treaty of Waitangi | Te Tiriti o Waitangi. The Children's Act recognises this status through the requirement to report specifically on outcomes for Māori children and young people. The 2022/23 Annual Report will report on outcomes for Māori children and young people specifically and in the context of outcomes for non-Māori children and young people, in order to meet these obligations.
- 35. While the CPR Act does not explicitly require reporting on Māori children and young people, previous CPRI Reports have included this analysis. We anticipate following this for the 2022/23 CPRI Report.
- 36. Previous reporting on the Strategy and CPRIs demonstrates that Māori children and young people have significant unmet needs and experience greater levels of socio-economic disadvantage and hardship than other groups of children and young people. Specific reporting makes sure that the existing socio-economic and material hardship disparities experienced by whānau Māori and Māori children and young people and the specific needs of Māori children and young people are visible so these needs can be met.

Thank you for the opportunity to provide feedback on the fifth draft Annual Report of the Child and Youth Wellbeing Strategy on the child poverty reduction indicators.

### We would like to provide the following comments on the following sections of the paper: 1. Overall

The Ministry for Pacific Peoples (the Ministry) continues to support annual reporting on the child poverty reduction indicators (CPRIs), the Child Youth and Wellbeing Strategy, and the six wellbeing outcomes for all children and young people.

### 2. Background / Context section

- It would be useful to note any relevant policies that have been introduced within the reporting period and over time, reporting on whether they contribute to reducing child poverty.
- 3. Reporting on the wellbeing of Pacific children and young people
  - We note the recent shift in reporting within the draft 2022-23 Annual Report on the CPRIs, that reporting on measures for Pacific children and young peoples has stopped.

We suggest this shift be reconsidered in light of the significant disparities this cohort faces, including (<u>from Treasury's Pacific Wellbeing analytical paper</u>):

- one in four Pacific children live in poverty;
- Pacific children are more likely to live in a household experiencing material hardship, food insecurity, or housing issues;
- Pacific children are 50 times more likely to be hospitalised from developing acute rheumatic fever compared to non-Pacific, non-Māori children; and
- the high proportion of Pacific children and young people who do not attend school regularly. Ministry of Education officials raised concerns that children were not returning to school regularly post-pandemic because they have instead (likely) chosen to continue to support their families through employment and other activities.
- We understand that data was collected on Pacific children and young people for the draft 2022-23 Annual Report and will be provided when it is available. We look forward to this as it will be a valuable resource. We are available to discuss whether there is anything we can do to support the continued collection of data on Pacific children and young people.
- 4. Other future reporting considerations
  - Intersectional reporting (Māori disabled children and young people, and Pacific disabled children and young people, and Māori Pacific children and young people) We recommend that there be monitoring of progress for each of the subsets due to the additional challenges they face, including:
    - the general scarcity of <u>data on Pacific intellectually disabled children</u>, and that 44% of Pacific disabled children live in high deprivation; and
    - that rangatahi of both Māori and Pacific heritage are at higher risk of substance abuse (see Te Hiringa Hauora report, attached).

The Ministry also welcomes the opportunity to be involved in future reviews of the annual report.

As discussed at our last Strategy GMs meeting, please find attached the draft 2022/23 Annual Report on the Child and Youth Wellbeing Strategy and Child Poverty Related Indicators, for your review.

As directed by our Minister, this year's draft annual report combines the reporting on the Strategy and CPRIs into one, and provides more streamlined narrative compared to previous reporting. The analysis focuses on the changes in the Strategy indicators and the CPRIs over the period from 2019/20 (the first annual reports) to 2022/23.

Please note that we are still waiting for the data from the 2022/23 Stats NZ Household Economic Survey, which is being released this Thursday 22 February, as well as the serious injury data for Outcome 1. You will see that there are placeholders (highlighted in the attached document) for commentary on these.

We're asking for your review by **12pm Friday 1 March**, so we can meet our statutory reporting deadlines. We are also providing the report to your data teams simultaneously for their QA of the data. We particularly welcome feedback on the narrative in the annual report, including if you feel we have misrepresented any trends, or if there are other trends or insights you'd expect to see reflected.

As noted in the GMs meeting, the data in the report is disaggregated for Māori children and young people, and disabled children and young people. We'll provide the agencies who look after populations who have been featured in previous reporting with updated data tables with disaggregated data for internal use, when all the data, including the HES data, has been received.
