Official Information Act request

Thank you for your email of 21 May 2024, requesting information about the Rebel Business School.

I have considered your request under the Official Information Act 1982 (the Act). Please find my decision on each part of your request set out separately below.

• The reasoning behind your organisation beginning these deals.

In association with local councils and Economic Development Agencies (EDAs), the Rebel Business School delivers free-to-attend business training courses across New Zealand that teach participants the fundamentals of starting a small business. These workshops are open to the public, and the programme content is aimed at people who are starting a small business without capital funds or prior experience.

The Rebel Business School team travels to regions around New Zealand, offering this programme to people who might not otherwise have the opportunity to procure necessary skills to start their own business. Their core programme is a 10-day intensive business skills workshop. Since 2017, the Rebel Business School has assisted over 1250 people to graduate their programme with new skills and confidence about starting their own business.

The Ministry has been a minority funding partner, as the majority of costs are covered by local councils and EDAs. There is an overlap in the target audience of the Rebel Business School's programme and the Ministry's client population.

On rare occasions, the Ministry has funded programmes to be run in areas with high unemployment levels where there is no labour market such as Te Kaha, Kawerau and Murupara. The Ministry has also contracted the Rebel Business School to deliver Self-Employment support programmes delivered on a one-to-one basis with eligible clients, previously known as Awhi.

In the financial year ending 30 June 2023, the Rebel Business School was selected through a competitive tender process to deliver a programme supporting the Ministry's Flexi-wage for self-employment product. Please see **Table One** in the below **Appendix** for a breakdown of courses that the Ministry has provided funding for and the number of Ministry clients who have attended courses with the Rebel Business School.

Skills for Industry (SFI) contracts provide short-term job-focused training to prepare clients who require up-skilling for specific requirements identified by industry, or in the case of our contracts with Rebel, for Self-Employment. Training can be offered as pre-employment or in-work training, and programmes can be delivered by providers or employers. Funding is attached to an individual person and their outcome. Whereas a Fee for Service (FFS) contract enables us to purchase services that are not a set price per employment outcome – like, in the case of Rebel Business School, a contribution to a workshop in recognition of it being made available to clients.

The Ministry does not require the Rebel Business School to report on attendance or completion for their public workshops, as the participants may not be Ministry clients. This aspect of your request is refused under section 18(g) of the Act as the information is not held by the Ministry and I have no reason to believe this information is held by or more closely connected to the functions over another department, Minister of the Crown, or organisation.

Have issues been raised on the attendance.

Such as not attending the whole course but still getting a certificate.

No such issues have been raised with the Ministry.

I will be publishing this decision letter, with your personal details deleted, on the Ministry's website in due course.
