Official Information Act request

On 22 May 2024, the Department of the Prime Minister and Cabinet transferred your request in part to the Ministry of Social Development (the Ministry). Your request related to the advice provided by to the Ministry to Cabinet on the proposed reductions in funding.

I have considered your request under the Official Information Act 1982 (the Act).

On 28 May 2024, we emailed you seeking some clarification about the information you were requesting. As we have not received a response from you, I have interpreted your request solely on your initial letter to the Department of the Prime Minister and Cabinet.

If you were seeking Cabinet papers, your request was likely to be refused as it is Ministers of the Crown who submit papers to Cabinet or Cabinet committees on issues concerning their portfolios. The Ministry considered whether transferring your request to the responsible Minister would have been appropriate, however, we have not done so in this instance, as without refinement is considered too broad in this instance.

I am therefore, refusing your request under section 18(e) of the Act as the information you have requested does not exist or, despite reasonable efforts to locate it, cannot be found. However, I am providing you with links to existing information that may be of interest to you.

The Ministry publishes the titles of reports provided to the Minister for Social Development and Employment each month. I recommend looking through the list as it may assist you in identifying specific topics you may be seeking information on.
