### **Official Information Act request**

Thank you for your email of 23 January 2024, requesting information about the Ministry of Social Development's (the Ministry) ICT roles and job titles.

I have considered your request under the Official Information Act 1982 (the Act). Please find my decision on your request set out below.

For clarity, the Ministry's ICT function sits within the Improvement Systems and Technology (IST) group.

The Ministry does not have established and non-established roles. However, in relation to contractors, they only exist as either contingent or non-contingent workers.

Most Ministry contractors are contingent workers as such, they do not technically have positions in the system, they have no position title, and their job codes indicate something generic like contractor or vendor.

Non-contingent contractors do have positions in the system and therefore, do have position titles. A non-contingent contractor is filling a position that is on the system which could potentially otherwise be filled by a fixed term or permanent employee.

Please refer to the table attached below in Appendix 1 which answers the parts X-M of your request and shows the number of FTE staff and number of staff by headcount for the Ministry and for the staff in the Ministry's IST roles.

The information provided to you is at 31 January 2024 unless specified. This is in line with the Ministry's reporting.

The Ministry has responded separately to part I and L of your request based on the clarification you provided to the Ministry on 28 February 2024. You can find the response to these parts of your request immediately below.

#### I. Total number of information and data subject matter experts

You advised the Ministry you are seeking information on positions held by the staff with the following position titles 'Information and/or Data Analysts or Records Management Data'. Please note, these position titles do not exist within the IST roles, however, do exist across the wider Ministry for example, the Ministry's Strategy and Insights group and the Information group. If you would like information related to these groups, please contact the Ministry.

# L. Total number of staff involved with strategy development and implementation, transformation, portfolio management, monitoring, and reporting (exclude staff in management roles from this count)

You advised the Ministry that for this part of the request you are seeking information on roles that focus on the strategy team and aren't necessarily architects.

The Ministry has interpreted this part of your request to be for the number of staff who are accountable for our technology strategy. There are 7 FTE staff within this team who report to the Group General Manager of IST. Other staff members may contribute to this role and are not limited to architects, products owners, managers and others across the wider Ministry.

# In addition, please state who the end users of the ICT services at your organisation are, example internal staff or public or both? If the end users are a subset of the public then please estimate the number of such users.

ICT services provided by the Ministry's IST group are used by internal staff, partner organisations (other government agencies, suppliers, employers, housing providers), clients of the Ministry (students, working age people and super annuitants) and the general public.

The Ministry has interpreted this part of your request to be for data on traffic to the external websites hosted by the Ministry, such as but not limited to: <a href="http://www.msd.govt.nz">www.msd.govt.nz</a>, <a href="http://www.workandincome.govt.nz">www.msd.govt.nz</a>, <a href="http://www.workandincome.govt.nz">www.workandincome.govt.nz</a>, and <a href="http://www.workandincome.govt.nz">www.workandincome.govt.nz</a>.

There were approximately 6.5m visits on these external facing websites in a period of 6 months.

In the spirit of providing you with the most helpful information, I am also providing you with the total number of users for the Ministry's two main client facing platforms, that is MyMSD and MyStudyLink. These client facing platforms are used by Ministry clients for accessing services related to Work and Income and StudyLink.

As at 7 March 2024 there were a total of 1,594,990 registered users for MyMSD. In the last 12 months 4.7m registered users have logged in and accessed MyMSD.

Noting the same period as above, there were a total of 349,708 registered MyStudyLink users. In the last 12 months 3,316,857 registered users have logged in and accessed MyStudyLink.

It should be noted that a user may have accessed these platforms multiple times over the last 12 months.
