Official Information Act request

Thank you for your email of 5 April 2024, requesting information about Emergency Housing Special Needs Grant (EN SNGs), Public Housing Register and duration of applicants on the Housing Register.

I have considered your request under the Official Information Act 1982 (the Act). Please find my decision on each part of your request set out separately below.

I refer you to the **Appendix** enclosed with this letter which outlines the data we are providing to you, in table format, in the specified spreadsheets provided as appendices 1-3, in response to your request.

Please note, the Ministry does not record the longest duration of an applicant on the Housing Register. However, in the interests of providing you with the most useful information, I am providing you with the number of clients housed and the time to house from the Public Housing Register.

The length of time an application remains on the Register can be dependent on a number of reasons. For example, an applicant may remain on the Register for a longer period of time where they have specific preferences or requirements about where they need to be housed, have a change in circumstances while they are on the Register, or seek housing in areas which have high demand.

In regard to your request for the age of children in Emergency Housing and on the Public Housing Register, as well as information on the number of moves/accommodation provider changes and non-consecutive EH SNG grants for the same household, I am unable to provide you with this information as it is held in notes on individual case files. In order to provide you with this information, Ministry staff would have to manually review a substantial number of files. As such, I refuse your request under section 18(f) of the Act. The greater public interest is in the effective and efficient administration of the public service.

I have considered whether the Ministry would be able to respond to your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Ministry's ability to undertake its work would still be prejudiced. Please also note, in order to protect client privacy, some values in the attached data tables are suppressed and are represented by 'S'. The Ministry is unable to provide you with the exact number as releasing this information is likely to risk identifying the individuals concerned. As such, this information is withheld under section 9(2)(a) of the Act. The need to protect the privacy of these individuals outweighs and public interest in the information.

I have also included, as **Appendix Two**, a copy of your original request for information.

I will be publishing this decision letter, with your personal details deleted, on the Ministry's website in due course.
