Official Information Act request

Thank you for your email of 9 May 2024, requesting information about the number of clients receiving Accommodation Supplement in Rotorua.

I have considered your request under the Official Information Act 1982 (the Act).

I will first address your request for data before providing general information about the Accommodation Supplement. Please see the below table in response to your request.

Table One: The number of clients receiving Accommodation Supplement in the Rotorua District Territorial Local Authority as end of April 2019 to end of April 2024, broken down by year and type of accommodation.

Table Notes:

- Territorial Local Authorities (TLAs) are the second tier of local government in New Zealand, below regional councils.
- TLAs are estimated based on the client's address recorded by the Ministry at the time period, though the client may not necessarily reside in the same address at that time.
- To protect confidentiality, the Ministry uses processes to make it difficult to identify an individual person or entity from published data.
- These data tables have had random rounding to base three applied to all cell counts in the table.

- The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals.
- The published counts will never differ by more than two counts.

General information about Accommodation Supplement

The Accommodation Supplement (AS) is a non-taxable supplementary payment which provides financial assistance towards accommodation costs. It is available to eligible people who rent, board, or own their own home. A person does not have to be receiving a benefit to be eligible.

The amount of AS an eligible person or household receives is calculated using a formula that accounts for differences in regional rents, the type of main benefit received, family size, accommodation costs, income, cash assets, and accommodation type. The general formula the Ministry applies to calculate AS entitlement are outlined here: www.workandincome.govt.nz/map/income-support/extra-help/accommodation-supplement/calculating-rate-general-formula-01.html.

The statistical area units used to identify the AS areas are defined by Stats NZ. They are not equivalent to postal address suburbs, towns, or cities, despite occasionally sharing similar names. I note that New Zealand is divided into four areas, with a different maximum rate of AS payable within each area, for the purpose of calculating AS entitlement.

Homeowners are eligible to receive the AS for home ownership costs; however, the maximum weekly payments for the four AS areas are currently set based on 2016 rental data.

Any person currently in receipt of AS who believes the amount of AS they receives needs to be reviewed can initiate a review by completing this form and submitting it to their nearest Work and Income service centre for processing: www.workandincome.govt.nz/documents/forms/change-of-address-accommodation-costs.pdf.

At present, some people who need additional support to help meet essential living costs not subsidised by their AS may qualify for Temporary Additional Support (TAS). You do not have to be on a benefit to qualify for this payment.
