Official Information Act request

Thank you for your email of 4 November 2025 requesting information about the Ministry of Social Development (the Ministry's) Hearing Aid Funding / Subsidy Scheme.

I have considered your request under the Official Information Act 1982 (the Act). Please find my decision on each part of your request set out separately below.

1. **Hearing Aid Funding Scheme** *Average National Cost of Funded Aids for the period July to Sept 2025 with the average cost for the previous four quarterly periods split into Adults Funded Aids, Children's Funded Aids*
2. **Hearing Aid Subsidy Scheme** *Average National Cost of Subsidised Aids for the period July to Sept 2025 with the average cost for the previous four quarterly periods*

I can advise the average national cost of funded hearing aids for the period July 2024 to June 2025 was adults \$1,427, and children \$1,507. The Ministry does not have these figures available for the period July to September 2025.

The part of the request for this cost broken down by quarterly periods is refused under section 18(f) of the Act as substantial manual collation would be required to produce the data. The information for this part of your request is held by a third-party provider, who has advised the Ministry that to answer this request, they would need to develop and create a new report to provide this information. The greater public interest is in the effective and efficient administration of the public service.

I have considered whether the Ministry would be able to respond to your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Ministry's ability to undertake its work would still be prejudiced.

3. **Information on approvals and invoiced for DSS hearing aid services**
Please provide the below information updated with current numbers for these reported periods and add the three months from Jul25 to Sept 25


