I have considered your request under the Official Information Act 1982 (the Act). Please find my decision on your request set out below.

I can confirm that these suppliers listed in your request do not need to own property in order to receive any accommodation hardship grants. However, suppliers must confirm the owner's consent to use the property to register with MSD. If the operator is not the owner, a lease or contract is generally sufficient. Additionally, suppliers must be registered with the Ministry.
