## **Official Information Act request**

Thank you for your email of 27 January 2025, requesting information about Ministry staff attendance on Boma courses in the last three years, and any evaluations of these courses.

I have considered your request under the Official Information Act 1982 (the Act).

The Boma programmes were selected through ongoing one-on-one developmental conversations between Ministry staff and their manager to meet specific career or capability needs that were agreed through regular coaching. Over the last three years, thirteen Ministry staff attended Boma programmes.

Ministry participants were typically in specialist roles or functions, for example principal or senior advisors, where this development opportunity supported their unique growth and development needs.

The majority of participants attended locally delivered programmes which meant there were no additional costs, apart from two instances where travel was required. This resulted in \$1,112.00 air travel costs, and \$366.69 accommodation as well as daily personal expenses of \$75 for meals.

There is no formal evaluation of the value of attending these programmes, outside of regular coaching conversations between managers who authorise attendance to these programmes and the participants, which can include conversations about how learning is applied effectively back in the workplace or how it supports career aspirations.

The following table sets out the dates and course costs for the thirteen Ministry staff who attended Boma programmes over the last three years.
