Emergency Housing SNGs | Apr 2024 |

Emergency housing is short-term accommodation (usually in motels) for individuals who have an urgent need because they are unable to remain in their usual place of residence. It is funded through Special Needs Grants that clients apply for when they cannot access accommodation and we have explored all the other options available to them. Grants can cover between one and 21 nights of accommodation at a time





Commentary

The number of households in emergency housing has continued to decrease for the nineth consecutive month to 2,535 at the end of April 2024, down by 90 compared to last month. The number of households in emergency housing in April has returned to pre-pandemic levels.


Most regions saw a decrease in the number of households, in particular the East Coast (down by 36).


The number of Emergency Housing Special Needs Grants (EH-SNGs) has decreased by 378 (5.6 percent) to 6,429 with \$1.38 million fewer granted during April 2024 compared to March 2024. The monthly decrease in the number of grants in April is a seasonal trend that has occurred since 2020.

Note: Households living in Contracted Emergency Housing (CEH) in Rotorua are not included in this reporting. The new model is being piloted in Rotorua. Reporting of the number of households in CEH is currently unavailable. Random rounding has been applied to these figures. Figures in tables may not add up to the total due to random rounding.













Public Housing Register | 30 Apr 2024 |

The Public Housing Register is a non-time bound list of all applicants eligible to be placed in public housing. Applicants complete a public housing assessment which determines eligibility and priority for public housing against an agreed set of criteria, which is then used to assist the public housing provider in matching to the most appropriate property.








Public Housing Register numbers









Percentage of applications by bedrooms required 11 - as at end of the month

Commentary

The number of Public Housing Register applications has decreased by 1,164 (3.8 percent) to 29,514 at the end of April 2024.

This decrease is potentially due to fewer new applications onto the register and more applicants being housed in public housing in April compared to March 2024. All regions saw an decrease in the number of Public Housing Register applications.

Of the 921 applicants who were housed, 438 (47.6 percent) were households with children, 33 more than March 2024.
